

Engineering services required to prepare permitting and contract documents to bid and construct the new bridge. Once plans are developed and permits acquired, the project will be competitively bid, awarded, and constructed.

c. What direct services will be provided to citizens by the appropriation project?

The replacement of the bridge will Improve daily life for the residents of Freedom Road as well as other citizens and the traveling public that utilize Freedom Road. In addition to the convenience of opening the road, access for emergency vehicles will also be improved. Freedom Road is a significant short cut from downtown Century to the nearest local hospital in Jay.

d. Who is the target population served by this project? How many individuals are expected to be served?

All residents of the Town of Century and the associated traveling public. The population of the Town of Century is approximately 1,713, however, this bridge will serve the traveling public which includes non-residents.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

The construction of a new bridge along Freedom Road will improve the quality of life for the residents of the Town of Century. Additionally, emergency vehicles will have improved access to residents on Freedom Road as well as a shorter more direct route to the nearest hospital from downtown Century. These benefits will be measured by happier residents who have been requesting the bridge replacement since its closure in 2020. Additionally a decrease in emergency response time to incidents on Freedom Road as well as shortened travel time to the nearest hospital is expected.
