#### 4. Project/Program Description

The requested state funds will be used to renovate a donated commercial property located at 302 College Drive, Orange Park, FL 32065 into a free medical and dental clinic serving uninsured, low-income residents of Clay County, that will also serve as the headquarters of a county-wide medical care coordination system that will navigate low-income individuals to appropriate care and prevent unnecessary hospital utilization. The main objective of the goal is to dramatically increase the number of residents served, doubling volume within three years of operation, and navigating thousands of others to appropriate, affordable care. The project has received public support from The Clay County Board of Commissioners (2022) and Clay County Health Department, along with the three Clay hospitals and all outpatient medical providers serving the poor (2020), as well as both the Clay SafetyNet Alliance and Impact Clay (2020).

#### 14. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

The requested state funds will be used to renovate a donated commercial property located at 302 College Drive, Orange Park, FL 32065 into a free medical and dental clinic serving uninsured, low-income residents of Clay County, and the headquarters of a county-wide medical care coordination system that will navigate low-income individuals to appropriate care and prevent unnecessary hospital utilization. The main objective of the goal is to dramatically increase the number of residents served, doubling those served annually to 2,500 within three years of operation, and navigate and coordinate care for an additional 3,000 annually through the inpatient and outpatient healthcare system.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

The new clinic facility will provide free medical and dental care to Clay residents including primary, obstetrical, prenatal, diabetes, cardiovascular, respiratory, and dental care and hygiene services, as well as care coordination, navigation, and inpatient hospital aftercare services.

#### c. What direct services will be provided to citizens by the appropriation project?

All medical and dental services described above are direct, free services provided to the citizens of Clay County. (Free medical and dental care to Clay residents including primary, obstetrical, prenatal, diabetes, cardiovascular, respiratory, and dental care and hygiene services, as well as care coordination, navigation, and inpatient hospital aftercare services.)

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The target population served by this project are uninsured and under insured, low-income residents of Clay County, including the following specific categorical characteristics: elderly persons, persons with poor mental health, persons with poor physical health, jobless persons, economically disadvantaged persons, at-risk youth, homeless, developmentally disabled, physically disabled, drug users (in health services), preschool students, grade school students, high school students, university/college students, currently or formerly incarcerated persons, drug offenders (in criminal Justice), victims of crime, and pregnant women and their newborn children. An additional 1,250 residents are expected to be served annually with the first three years of operation and the other 3,000 assisted with navigation and care coordination services.

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

Improved physical health: Individual patients will improve measurable health indicators for their respective diseases and conditions (e.g. lowering of A1C blood levels for diabetes patients; healthy birth outcome for maternity cases with high APGAR scores for newborns). The clinic will also provfacility access to all appropriate care options for thousands throughout the county, improving health outcomes for all. Patient medical outcomes are tracked in the clinic's electronic health record system and reviewed by licensed medical personnel. Navigation and care coordination data will be collected and analyzed using a proprietary care navigation system, producing improved health treatment outcomes for thousands.

Improved mental health: Patients receiving ancillary behavioral health counseling will score improvements on screening tools (e.g. Depression Scale PHQ-9). Patient screening outcomes are tracked in the clinic's electronic health record system and reviewed by licensed medical sta

# f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Deliverables will consist of completion of defined milestones in the construction project leading up to completion and occupation. Penalty for ultimately failing to meet the deliverable of the completion of construction and occupation (not withstanding time delays due to construction and supply chain issues) should be prorated forfeiture of funding for portions of the project not completed.
