### 4. Project/Program Description

In order to increase overall nursing student enrollment and graduates that can enter the nursing workforce in Florida and nationwide, Florida Atlantic University's College of Nursing is proposing to initiate a number of new initiatives and enhancements to strengthen Florida's nursing workforce at all levels, including doubling the number of slots available for students to be admitted to the Accelerated BSN program (from 40 students to 80 students per year). FAU will also create a post-baccalaureate program with up to 60 students, focusing on the significant mental health needs of the state. Additionally, FAU will offer increased fellowship and scholarship opportunities, particularly in the areas of Caring Data Science (using a humanistic approach to data science), and will provide opportunities for existing nursing faculty to strengthen their leadership and specialty areas through trainings and educational opportunities.

### 14. Program Performance

### a. What specific purpose or goal will be achieved by the funds requested?

FAU will increase nursing graduates in the state by doubling the number of slots available for students in the Accelerated BSN program from 40 to 80 students per year. We will create a post-bacc program for Psychiatric Mental Health Nurse Practitioners to address the mental health needs in Florida (60 students). We will increase our fellowships and scholarships offerings, conduct annual leadership fellowship and trainings for nursing faculty, and hire 16 nursing and data science faculty.

### b. What activities and services will be provided to meet the intended purpose of these funds?

FAU will increase its nursing enrollment and graduation numbers. We will provide leadership development opportunities for up to 4 nursing faculty per year; will enroll at least 20 students in caring data science courses, will hire faculty, and will provide more fellowship opportunities.

### c. What direct services will be provided to citizens by the appropriation project?

FAU will graduate an additional 200 nurses annually & 1,000 over the course of the next five years, with over 90% entering the workforce in Florida and serving its residents.

### d. Who is the target population served by this project? How many individuals are expected to be served?

More than 3.2 million residents currently live in Broward, Palm Beach, and Martin counties, and these individuals are all within the target population that will be served by this project, in addition to individuals living in Indian River and St. Lucie counties.

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

Expected benefits include increased numbers of highly qualified nurses entering the workforce in Florida and positive contributions to the state's economy and workforce. The primary educational outcomes of the proposed programs include student enrollment and graduation numbers. The primary workforce outcomes include the number and percentage of students who successfully pass the NCLEX-RN exam and enter the nursing workforce; particularly in the state of Florida.

If Florida Atlantic University does not execute the plan as proposed, the state of Florida may relinquish all funds associated with this request.
