The County proposed to partner with either the City of Niceville or the City of Crestview to design and construct a special needs ball field and park. We estimate that approximately 100 individuals may be served by the special needs ball field through the establishment of a Miracle League or similar program. The park will be open to users of all abilities and may serve thousands of Okaloosa County residents and visitors.

The expected benefit is to provide a public facility that can be used by Okaloosa County residents and visitors. Outcomes that may be measured included: use of the special needs ball field (practices, games, play) and annual count of visitors to the special needs ball field and park.
