4. Project/Program Description

Pinebrook Park is the only large, active recreational facility within a radius of several miles and this project will provide safer accessibility for thousands of county residents. The primary purpose of the proposed improvements is to make street layout changes that will eliminate right of way parking and improve safe access to recreational opportunities for several communities surrounding the Pinebrook neighborhood. The improvements create safe traffic flow, improvements to increase pedestrian safety, and additional parking spaces that will eliminate right of way parking. The proposed project includes removing existing fencing, tennis courts, and concrete walks in order to improve street layout design and increase parking lot spaces; installation of new curbs, fencing, tennis courts, pedestrian gate, landscaping, and a stop sign that will provide pedestrians, bicyclists, and persons using assisted mobility equipment safer access to Pinebrook Park and its amenities.

14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The specific purpose/goal of the proposed improvements is to make street outlay changes that will eliminate right of way parking thereby improving public safety by reducing pedestrian/bicycle conflicts and improving accessibility to Pinebrook Park's recreational amenities for all users.

b. What activities and services will be provided to meet the intended purpose of these funds?

Project activities will include removing existing fencing, tennis courts, and concrete walks in order to prepare the site for street outlay changes. Additional parking spaces will be added. New curbs, tennis courts, fencing and pedestrian gate, and landscaping will be installed. A stop sign will be installed to provide pedestrians, bicyclists, and persons using assisted mobility equipment safer access to and from the park.

c. What direct services will be provided to citizens by the appropriation project?

The proposed project will provide park users from several Pinellas County communities safer access to Pinebrook Park and its amenities by reducing pedestrian/bicycle conflicts.

d. Who is the target population served by this project? How many individuals are expected to be served?

The general population of the greater Pinebrook community, Largo, and unincorporated areas of Pinellas County will be served by this project. City and State roadways throughout the area are traversed by nearly 50,000 residents, workers, students, and commuters. There are nearly 6,000 housing units within a two-mile radius of Pinebrook Park.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Pedestrians, bicyclists, and persons with mobility assistance equipment will be the primary benefactors of this project. The Pinebrook Community Safety Project aligns with Forward Pinellas' Safe Streets Pinellas Action Plan (2021) by being a proactive, preventive approach to preventing pedestrian/bicycle conflicts.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Agencies that contract with the City are required to purchase surety bonds at 100% of the cost of the project. Payments may be held pending the satisfactory achievement of performance measures or deliverables.
