Phase 1 of a new central sewer collection system in the Charlotte Park area to replace the aging septic systems and improve water quality.

c. What direct services will be provided to citizens by the appropriation project?

The sewer system would allow the City of Punta Gorda to provide wastewater collection and treatment services to Charlotte Park and increase water quality in Charlotte Harbor.

d. Who is the target population served by this project? How many individuals are expected to be served?

Residents of Charlotte Park. Over 400 homes, with approximately 904 people will be connected to the city's utility system in phase I. Impacts will serve the entire estuary and watershed area.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Reduce nitrogen, phosphorus and chlorophyll flows into Charlotte Harbor and surrounding waterways. Water quality testing will be ongoing.

Reallocate funding.
