#### SUMMARY ANALYSIS

The civil service system for the Lee County Sheriff's Office was established by the Florida Legislature in 1974 pursuant to ch. 74-522, L.O.F. This special act was subsequently amended in 1987, 1995, 2007, and 2008. Section 9 of the act governs the qualifications for employment. It prohibits employment of applicants convicted of a misdemeanor for which the penalty is greater than \$300 and/or 90 days confinement. It also requires applicants with military service to have no less than an honorable discharge.

The bill increases the misdemeanor threshold to \$5000 and authorizes applicants who have been discharged for medical or other reasons by only excluding applicants who have been discharged under dishonorable conditions or reasons.

This bill is effective upon becoming law.

## FULL ANALYSIS

#### I. SUBSTANTIVE ANALYSIS

#### A. EFFECT OF PROPOSED CHANGES:

#### **Current Situation**

The civil service system for the Lee County Sheriff's Office was established by the Florida Legislature in 1974 pursuant to ch. 74-522, L.O.F. This special act was subsequently amended in 1987<sup>1</sup>, 1995<sup>2</sup>, 2007<sup>3</sup>, and 2008<sup>4</sup>. Section 9 of the act governs the qualifications for employment. It prohibits employment of applicants convicted of a misdemeanor for which the penalty is greater than \$300 and/or 90 days confinement.<sup>5</sup>

This section also requires applicants with military service to have no less than an honorable discharge. The Sheriff's Office has encountered some difficulty in applying this language to individuals who have received discharges for medical or for reasons other than dishonorable.

## Effect of Proposed Changes

The bill increases the monetary threshold for disqualifying misdemeanors from \$300 to \$5000. This amount is consistent with the current amount for a third degree felony.<sup>6</sup> The bill also clarifies the military discharge language to only prohibit those applicants discharged under dishonorable conditions or reasons.
