The appointment of an executive director by the governing board is subject to approval by the Governor and must be initially confirmed by the Florida Senate. applications under part II or part IV or petitions for variances or waivers of permitting requirements under part II or part IV, except for denials of such actions as provided in s. 373.083(5).
