- Section 1. Subsection (10) of section 121.052, Florida Statutes, is amended to read:
 - 121.052 Membership class of elected officers.-
- member of the Elected Officers' Class who is a Supreme Court justice, district court of appeal judge, circuit judge, or county court judge shall receive judicial retirement credit of 3 1/3 percent of average final compensation, and all other members shall receive elected officer retirement credit of 3 percent of average final compensation, for each year of creditable service in such class. Effective July 1, 2011, all members of such class shall receive a retirement credit of 2 percent of average compensation.
- Section 2. Subsection (4) of section 121.72, Florida Statutes, is amended to read:
- 121.72 Allocations to optional retirement program participant accounts; percentage amounts.—
- (4) Effective July 1, 2002, Allocations from the Florida Retirement System Contributions Clearing Trust Fund to optional retirement program participant accounts shall be as follows:
