29 "Barber" means a person who is licensed to engage in (1) 30 the practice of barbering in this state under the authority of 31 this chapter. "Barbering" means any of the following practices when 32 (2) 33 done for remuneration and for the public, but not when done for the treatment of disease or physical or mental ailments: 34 35 shaving, cutting, trimming, coloring, shampooing, arranging, 36 dressing, curling, or waving the hair or beard or applying oils, 37 creams, lotions, or other preparations to the face, scalp, or 38 neck, either by hand or by mechanical appliances. (3) "Barbering intern" means a student enrolled in a 39 1,200-hour barbering program who participates in an optional 40 work-experience internship under the direct supervision of a 41 42 licensed barber in a licensed barbershop. (4) (3) "Barbershop" means any place of business wherein 43 44 the practice of barbering is carried on. (5) (4) "Board" means the Barbers' Board. 45 (6) (5) "Department" means the Department of Business and 46 47 Professional Regulation. "Internship sponsor" means a licensed barber 48 (7) 49 registered with the board for the purpose of supervising a 50 barbering intern and ensuring compliance by the intern with the 51 laws and rules of this state and the internship requirements 52 established by the board and administered through a school of 53 barbering or a barbering program. 60	is eligible to become a barbering intern and whether an
61	internship sponsor meets the requirements for its educational
62	objectives. The school or program, on behalf of the student,
63	shall provide written notice to the board that an internship
64	sponsor has been selected and name the barbering intern to be
65	supervised. The school or program shall determine the length and
66	schedule of an individual barbering internship, but such
67	internship may not exceed 12 months. Internships may not
68	substitute or take the place of educational or licensure
69	requirements.
70	(2) Each internship sponsor shall obtain approval from a
71	school of barbering or barbering program and shall register with
72	the board before accepting placement of each barbering intern.
73	The application for registration must include the name and
74	contact person of the school or program placing the intern, the
75	name and address of the internship sponsor, and other
76	information that the board requires.
77	(3) The internship sponsor must have an active license and
78	shall actively supervise the barbering intern in the practice of
79	barbering pursuant to rules established by the board. A
80	barbering intern may practice only within the field of barbering

and the board. (4) All services provided by the barbering intern shall be expressly approved by the internship sponsor and contracted for by the internship sponsor. The internship sponsor shall ensure that the public is clearly informed that the barbering intern is not a licensed barber. (5) Pursuant to rules established by the board, the barbershop in which a barbering intern is engaged in the practice of barbering shall post notice in a conspicuous manner within the barbershop indicating that a student intern is providing services on the premises. (6) A barbering intern shall possess written documentation of his or her authorization to engage in the practice of barbering from the student's school of barbering or barbering program and shall furnish such documentation to the department before engaging in the practice of barbering and upon request by department personnel.
