A bill to be entitled to physical education

An act relating to physical education instruction in public schools; amending s. 1003.455, F.S.; requiring that physical education instruction for students in kindergarten through grade 5 be delivered by a certified physical education teacher; requiring that each school district implement such requirement during a 5-year period; requiring that each district school board provide 150 minutes of physical education instruction by a certified physical education teacher each week for students in grade 6 who are enrolled in a school that contains one or more elementary grades so that on any day during which physical education instruction is conducted there are at least 30 consecutive minutes per day; providing that a student may have the physical education requirement waived for a period of one semester each year under certain circumstances; providing an effective date.

WHEREAS, every year an estimated 300,000 people in the United States die because they are overweight or obese, and WHEREAS, since 1970, the number of overweight children in Florida has increased by 300 percent, and

WHEREAS, overweight or obese children experience the same risk factors associated with heart disease in adults such as high blood pressure, high cholesterol levels, and Type 2 diabetes, once known as adult-onset diabetes, and

WHEREAS, studies have shown that up to 80 percent of overweight adolescents become overweight adults, and

WHEREAS, the annual economic impact in the United States from obesity on our health care system is estimated by the Centers for Disease Control and Prevention at \$147 billion, and

WHEREAS, a recent study by a major insurance carrier stated that 50 percent of all Americans will develop diabetes by 2020, which will cost the health care system approximately \$3.35 trillion if current trends in obesity are not abated, and

WHEREAS, early education on proper physical fitness and nutrition will provide a foundation for a child's future as does learning to read, which prepares a child for success in his or her life and academic achievement, NOW, THEREFORE,

Each district school board shall provide 150 minutes of physical education each week for students in kindergarten through grade 5 and for students in grade 6 who are enrolled in a school that contains one or more elementary grades so that on any day during which physical education instruction is conducted there are at least 30 consecutive minutes per day. In order to ensure that physical education instruction is delivered by a highly qualified teacher commensurate with all subject areas, the instruction must be provided by a certified physical education teacher. This requirement shall be implemented by each school district during a 5-year period, beginning with the 2012-

2013 school year and through the 2016-2017 school year.

(4) Each district school board shall provide 150 minutes of physical education instruction by a certified physical education teacher each week for students in grade 6 who are enrolled in a school that contains one or more elementary grades so that on any day during which physical education instruction is conducted there are at least 30 consecutive minutes per day.

- (5) Beginning with the 2009-2010 school year, the equivalent of one class period per day of physical education for one semester of each year is required for students enrolled in grades 6 through 8. Students enrolled in such instruction shall be reported through the periodic student membership surveys, and records of such enrollment shall be audited pursuant to s. 1010.305. Such instruction shall may be provided by a certified physical education teacher to ensure that instruction is delivered by a highly qualified teacher commensurate with all subject areas any instructional personnel as defined in s. 1012.01(2), regardless of certification, who are designated by the school principal. This requirement shall be implemented by each school district during a 5-year period, beginning with the 2012-2013 school year and through the 2016-2017 school year.
- $\underline{(6)}$ (4) The requirement in subsection $\underline{(5)}$ (3) shall be waived for a student for a period of one semester each year who meets one of the following criteria:
- (a) The student is enrolled or required to enroll in a remedial course.
- (b) The student's parent indicates in writing to the school that \div
