An act relating to ownership of state lands; transferring certain state property lying within the City of West Park, Broward County, to be used by the city for the purposes of open space and public recreation needs; declaring such use a public purpose; providing for reversion of the property to the state if used for any other purpose; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. The State of Florida transfers ownership interest of the state's portion of the approximately 19.2 acres of the following described property, commonly known as "McTyre Park," to the City of West Park in Broward County. The property shall be used by the City of West Park for the purposes of open space and public recreation needs. The boundaries of the property transferred by this act are as follows:

A portion of the Northwest one-quarter (NW 1/4) and a portion of the Southwest one-quarter (SW 1/4), all in Section 30, Township 51 South, Range 42 East, Broward County, Florida, described as follows:

BEGINNING at the West one-quarter (W 1/4) corner of said Section 30, said point also being located on an Easterly municipal boundary of the City of West Park as established by Chapter 2004-454, Laws of Florida
