SUMMARY ANALYSIS

The bill requires the courts to assess individuals convicted of a crime a \$100 fee for any crime lab services when those services are provided by a local county-operated crime laboratory. All fines collected will continue to be deposited into the Florida Department of Law Enforcement's Operating Trust Fund and used to reimburse local county-operated crime laboratories. Currently such assessment is permissive and limited to certain drug related crimes.

The bill will have a positive fiscal impact on certain local governments because the bill requires the court to assess the \$100 fee when crime lab services are provided by a local county-operated crime laboratory.

The bill has an effective date of October 1, 2012.

I. SUBSTANTIVE INFORMATION

A. EFFECT OF CHANGES:

Background

Section 938.25, F.S., allows the courts to assess a \$100 fee to any defendant who pleads guilty or nolo contendere to, or who is convicted of, a drug offense specified in s. 893.13, F.S., relating to the sale, manufacture, or possession with intent to sell certain controlled substances, if the investigation included services provided by any of the state or county-operated criminal analysis laboratories that operate throughout the state. The proceeds from the assessment are deposited into the Operating Trust Fund within Florida Department of Law Enforcement (FDLE) and used by FDLE to recover their state-operated labs or to reimburse the local county-operated crime lab that provided the service.

Effects of the Bill

The bill requires the courts to assess individuals convicted of an offense in chapters 775 – 893, F.S., a \$100 fee for any crime lab services when those services are provided by a local county-operated crime laboratory. All fines collected will continue to be deposited into FDLE's Operating Trust Fund and used to reimburse local county-operated crime laboratories. The effective date of this bill is October 1, 2012.

Current law allows the court to assess the \$100 fee for crime lab services for only certain drug related offences. This bill expands the assessment of the fee to any defendant who pleads guilty or nolo contendere to, or who is convicted of an offence specified in the following chapters:

The bill will have a positive fiscal impact on local government operated crime labs enumerated in s. 943.35 (1), F.S., because the bill requires the court to assess the \$100 fee when crime lab services are provided by those local county-operated crime laboratory. The crime labs affected by this bill are:

- The Broward County Sheriff's Crime Laboratory;
- The Miami-Dade Police Department Crime Laboratory;
- The Indian River Crime Laboratory;
- The Palm Beach County Crime Laboratory; and
- The Pinellas County Forensic Laboratory.

While The Florida Department of Law Enforcement was not able to determine the exact number of cases involving crime laboratory services, FDLE's Statistical Analysis Center reports that 88,623 individuals within the jurisdictions served by county-operated forensic laboratories were found guilty or pled guilty/nolo contendere to offenses in Chapters 755-896, F.S. If all convictions or guilty pleas involved the use of county-operated crime laboratory services, this will generate \$8.86 million for distribution to the five local county-operated crime laboratories.

C. DIRECT ECONOMIC IMPACT ON PRIVATE SECTOR:

More offenders will be required to pay the \$100 crime lab fee.
