SUMMARY ANALYSIS

CS/HB 7039 passed the House on February 23, 2012, was amended by the Senate on February 29, 2011, and subsequently passed the House on March 6, 2012. The bill includes elements of other House bills as companion measures. Please see LEAGIS or myfloridahouse.gov for a list of these bills. The bill makes designations and directs the Department of Transportation (DOT) to erect suitable markers for those designations in each of the following counties.

The bill also corrects errors in the Miss Lillie Williams Boulevard and Father Jean-Juste Street designations that passed in 2010.

The bill has an estimated negative fiscal impact of \$55,000, which is the cost for DOT to erect the markers.

The bill was approved by the Governor on April 6, 2012, ch. 2012-228, Laws of Florida. The effective date of the bill is July 1, 2012.

I. SUBSTANTIVE INFORMATION

A. EFFECT OF CHANGES:

Present Situation

Section 334.071, F.S., provides legislative designations of transportation facilities for honorary or memorial purposes, or to distinguish a particular facility. The legislative designations do not officially change the current names of the facilities, nor does the statute require local governments and private entities to change street signs, mailing addresses, or 911 emergency telephone-number system listings.

The statute provides that a city or county must pass a resolution in support of a particular designation before road markers are erected. Additionally, if the designated road segment extends through multiple cities or counties, a resolution must be passed by each affected local government. Upon approval, the Department of Transportation (DOT) is required to place a marker at each termini or intersection of an identified road or bridge, and to erect other markers it deems appropriate for the transportation facility.
