An act relating to the Village of Estero, Lee County; amending chapter 2014-249, Laws of Florida; providing continuing effect of certain developments of regional impact; delaying compliance with state-shared revenue requirements; authorizing millage levied by the Estero Fire Rescue District to be used for certain purposes; revising the corporate and council district boundaries; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Paragraph (c) of subsection (7) and subsection (8) of section 12 of chapter 2014-249, Laws of Florida, are amended to read:

Section 12. Referendum election; transition.-
(7) TRANSITIONAL LAND DEVELOPMENT REGULATIONS.-To
implement the transitional comprehensive land use plan when adopted, the village shall, in accordance with the procedures required by the laws of the state, adopt ordinances providing for land use development regulations within the corporate limits. Until the village adopts the ordinances:
(c) Subsequent to the adoption of a local comprehensive land use plan and Subject to general law, the council is fully empowered to amend, supersede, enforce, or repeal the transitional land use development regulations, or any portion

thereof, by ordinance. All approved developments of regional impact (DRIs) located within the jurisdictional boundaries of and existing on the date of incorporation of the village are not required to submit a notice of proposed change application to adopt a new DRI development order as required by s . $380.06(15)(h)$, Florida Statutes. Effective December 31, 2014, any existing DRI development orders are deemed subject to the jurisdiction of the village without the need to amend the existing DRI development order. Jurisdiction over existing DRI development orders by the village is subject to, without limitation, all rights, entitlements, covenants, and commitments adopted in DRI development orders and zoning adopted in conjunction with or pursuant to the DRI development order before December 31, 2014, including, without limitation, all rights and entitlements included in any local development orders or plats adopted pursuant to the DRI development order and related zoning. The village shall recognize the property rights and interests held by property owners under such DRI development orders and all other vested property rights held by such property owners as such rights and entitlements existed on or before December 31, 2014.
(8) STATE-SHARED REVENUES.-The village shall be entitled to participate in all revenue sharing programs of the state effective April 1, 2015. The provisions of s. 218.23(1), Florida Statutes, shall be waived for the purpose of conducting audits and financial reporting through the end of fiscal year 2016-2017

2014-2015. For purposes of complying with s. 218.23(1), Florida Statutes, relating to ad valorem taxation, the millage levied by special districts, including, but not limited to, the Estero Fire Rescue District, may be used for an indefinite period of time. Initial revised population estimates for calculating eligibility for shared revenues shall be determined by the University of Florida Bureau of Economic and Business Research. Should the bureau be unable to provide an appropriate population estimate, the Lee County Department of Community Development shall provide the estimate.
