> An act relating to the Village of Estero, Lee County; amending chapter $2014-249$, Laws of Florida; revising district boundaries; revising boundaries of district 1; providing continued effect of certain developments of regional impact; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Section 3 of chapter 2014-249, Laws of Florida, is amended to read:
