> An act relating to specialty license plates; amending ss. 320.08056 and 320.08058 , F.S.; directing the Department of Highway Safety and Motor Vehicles to develop certain specialty license plates; establishing annual use fees for the plates; providing for distribution and use of fees collected from the sale of the plates; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Paragraphs (ffff) through (mmmm) are added to subsection (4) of section 320.08056 , Florida Statutes, to read: 320.08056 Specialty license plates.-
(4) The following license plate annual use fees shall be collected for the appropriate specialty license plates:
(ffff) Alpha Phi Alpha Fraternity license plate, \$25. (gggg) Omega Psi Phi Fraternity license plate, $\$ 25$. (hhhh) Kappa Alpha Psi Fraternity license plate, \$25. (iiii) Phi Beta Sigma Fraternity license plate, \$25. (jjjj) Zeta Phi Beta Sorority license plate, \$25. (kkkk) Delta Sigma Theta Sorority license plate, $\$ 25$. (llll) Alpha Kappa Alpha Sorority license plate, \$25. (mmmm) Sigma Gamma Rho Sorority license plate, \$25.

Section 2. Subsections (84) through (91) are added to section 320.08058 , Florida Statutes, to read:

(84) ALPHA PHI ALPHA FRATERNITY LICENSE PLATES.-
(a) The department shall develop an Alpha Phi Alpha

Fraternity license plate as provided in this section and s. 320.08053. The plates must bear the colors and design approved by the department. The word "Florida" must appear at the top of the plate, and the name of the fraternity must appear at the bottom of the plate.
(b) The annual use fees from the sale of the plate shall be distributed as follows:

1. Ten percent shall be distributed to the Florida Federation of Alpha Chapters and used solely for marketing of the Alpha Phi Alpha Fraternity license plate.
2. Eighty-five percent shall be distributed to the Florida Federation of Alpha Chapters and used to promote community awareness and action through educational, economic, and cultural service activities.
3. Five percent shall be distributed to the United Negro College Fund to be used for college scholarships for Florida residents attending historically black colleges and universities.
(85) OMEGA PSI PHI FRATERNITY LICENSE PLATES.-
(a) The department shall develop an Omega Psi Phi Fraternity license plate as provided in this section and s. 320.08053. The plates must bear the colors and design approved by the department. The word "Florida" must appear at the top of

the plate, and the name of the fraternity must appear at the bottom of the plate.
(b) The annual use fees from the sale of the plate shall be distributed as follows:

1. Ten percent shall be distributed to the State of Florida Omega Friendship Foundation, Inc., and used solely for marketing of the Omega Psi Phi Fraternity license plate.
2. Eighty-five percent shall be distributed to the State of Florida Omega Friendship Foundation, Inc., and used to promote community awareness and action through educational, economic, and cultural service activities.
3. Five percent shall be distributed to the United Negro College Fund to be used for college scholarships for Florida residents attending historically black colleges and universities.
(86) KAPPA ALPHA PSI FRATERNITY LICENSE PLATES.-
(a) The department shall develop a Kappa Alpha Psi Fraternity license plate as provided in this section and s. 320.08053. The plates must bear the colors and design approved by the department. The word "Florida" must appear at the top of the plate, and the name of the fraternity must appear at the bottom of the plate.
(b) The annual use fees from the sale of the plate shall be distributed as follows:

3. Five percent shall be distributed to the United Negro College Fund to be used for college scholarships for Florida residents attending historically black colleges and universities.
(87) PHI BETA SIGMA FRATERNITY LICENSE PLATES.-
(a) The department shall develop a Phi Beta Sigma

Fraternity license plate as provided in this section and s. 320.08053. The plates must bear the colors and design approved by the department. The word "Florida" must appear at the top of the plate, and the name of the fraternity must appear at the bottom of the plate.
(b) The annual use fees from the sale of the plate shall be distributed as follows:

1. Ten percent shall be distributed to TMB Charitable Foundation, Inc., and used solely for marketing of the Phi Beta Sigma Fraternity license plate.
2. Eighty-five percent shall be distributed to TMB Charitable Foundation, Inc., and used to promote community awareness and action through educational, economic, and cultural service activities.
3. Five percent shall be distributed to the United Negro

College Fund to be used for college scholarships for Florida residents attending historically black colleges and universities.
(88) ZETA PHI BETA SORORITY LICENSE PLATES.-
(a) The department shall develop a Zeta Phi Beta Sorority license plate as provided in this section and s. 320.08053. The plates must bear the colors and design approved by the department. The word "Florida" must appear at the top of the plate, and the name of the sorority must appear at the bottom of the plate.
(b) The annual use fees from the sale of the plate shall be distributed as follows:

1. Ten percent shall be distributed to Florida Pearls, Inc., and used solely for marketing of the Zeta Phi Beta Sorority license plate.
2. Eighty-five percent shall be distributed to Florida Pearls, Inc., and used to promote community awareness and action through educational, economic, and cultural service activities.
3. Five percent shall be distributed to the United Negro College Fund to be used for college scholarships for Florida residents attending historically black colleges and universities.
(89) DELTA SIGMA THETA SORORITY LICENSE PLATES.-
(a) The department shall develop a Delta Sigma Theta Sorority license plate as provided in this section and s. 320.08053. The plates must bear the colors and design approved
by the department. The word "Florida" must appear at the top of the plate, and the name of the sorority must appear at the bottom of the plate.
(b) The annual use fees from the sale of the plate shall be distributed as follows:
4. Ten percent shall be distributed to the Delta Research and Educational Foundation and used solely for marketing of the Delta Sigma Theta Sorority license plate.
5. Eighty-five percent shall be distributed to the Delta Research and Educational Foundation and used to promote community awareness and action through educational, economic, and cultural service activities.
6. Five percent shall be distributed to the United Negro College Fund to be used for college scholarships for Florida residents attending historically black colleges and universities.
(90) ALPHA KAPPA ALPHA SORORITY LICENSE PLATES.-
(a) The department shall develop an Alpha Kappa Alpha Sorority license plate as provided in this section and s. 320.08053. The plates must bear the colors and design approved by the department. The word "Florida" must appear at the top of the plate, and the name of the sorority must appear at the bottom of the plate.
(b) The annual use fees from the sale of the plate shall be distributed as follows:
7. Ten percent shall be distributed to the Alpha Kappa

Alpha Educational Advancement Foundation, Inc., and used solely for marketing of the Alpha Kappa Alpha Sorority license plate. 2. Eighty-five percent shall be distributed to the Alpha Kappa Alpha Educational Advancement Foundation, Inc., and used to promote community awareness and action through educational, economic, and cultural service activities.
3. Five percent shall be distributed to the United Negro College Fund to be used for college scholarships for Florida residents attending historically black colleges and universities.
(91) SIGMA GAMMA RHO SORORITY LICENSE PLATES.-
(a) The department shall develop a Sigma Gamma Rho Sorority license plate as provided in this section and s. 320.08053. The plates must bear the colors and design approved by the department. The word "Florida" must appear at the top of the plate, and the name of the sorority must appear at the bottom of the plate.
(b) The annual use fees from the sale of the plate shall be distributed as follows:

1. Ten percent shall be distributed to the Sigma Gamma Rho Sorority National Education Fund, Inc., and used solely for marketing of the Sigma Gamma Rho Sorority license plate.
2. Eighty-five percent shall be distributed to the Sigma Gamma Rho Sorority National Education Fund, Inc., and used to promote community awareness and action through educational, economic, and cultural service activities.
