CREATION OF PUBLIC SERVICE COMMISSION; TERM LIMITS FOR APPELLATE COURTS AND COMMISSION MEMBERS.—Proposing an amendment to the State Constitution that creates a Public Service Commission to regulate utilities and perform other duties assigned by general law and limits the terms of Supreme Court justices, judges of the district courts of appeal, and Public Service Commission members.
