51 for new or different regulation of auxiliary containers, 52 wrappings, or disposable plastic bags used by consumers to carry 53 products from retail establishments. The analysis shall include 54 input from state and local government agencies, stakeholders, 55 private businesses, and citizens, and shall evaluate the 56 efficacy and necessity of both statewide and local regulation of 57 these materials. To ensure consistent and effective 58 implementation, the department shall submit a report with 59 conclusions and recommendations to the Legislature no later than 60 February 1, 2010. Until such time that the Legislature adopts the recommendations of the department, no local government, 61 62 local governmental agency, or state government agency may enact 63 any rule, regulation, or ordinance regarding use, disposition, 64 sale, prohibition, restriction, or tax of such auxiliary 65 containers, wrappings, or disposable plastic bags.
