A bill to be entitled

An act relating to Fellsmere Drainage District, Indian River County; codifying the district's charter pursuant to s. 189.019, Florida Statutes; providing legislative intent; amending, codifying, reenacting, and repealing special acts relating to the district; repealing chs. 8877 (1921), 11555 (1925), 12023 (1927), 14719 (1931), 16998 (1935), 28418 (1953), 61-1414, and 69-1161, Laws of Florida, relating to the Fellsmere Drainage District; changing the name of the district to the Fellsmere Water Control District; removing the 99-year term limitation of the district originally provided by court decree; amending the boundaries of the district; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Pursuant to s. 189.019, Florida Statutes, this act constitutes the codification of all special acts and court decrees relating to the Fellsmere Drainage District. This act shall also serve to formally change the name of the district to the Fellsmere Water Control District pursuant to s. 298.001, Florida Statutes; remove the 99-year term limitation of the district originally provided by court decree in the case In re:

Fellsmere Drainage District issued on April 8, 1919, by the Circuit Court of the Fifteenth Judicial Circuit, in and for St. Lucie County, so that the Fellsmere Water Control District shall continue in existence and authority as provided in this act; and amend the boundaries of the district to reflect lands that are no longer located within the district. It is the intent of the Legislature in enacting this act to provide a single, comprehensive special act charter for the district, including all current legislative authority granted to the district by its several legislative enactments and any additional authority granted by this act. It is the further intent of the Legislature that this act preserve all district authority in addition to any authority contained in chapter 298, Florida Statutes. Section 2. Chapters 8877 (1921), 11555 (1925), 12023 (1927), 14719 (1931), 16998 (1935), 28418 (1953), 61-1414, and 69-1161, Laws of Florida, are amended, codified, reenacted, and repealed as herein provided. Section 3. The Fellsmere Water Control District, formerly known as the Fellsmere Drainage District, is re-created, and the charter for such district is re-created and reenacted to read: Section 1. Section 2. Minimum charter requirements.—In accordance with s. 189.031(3), Florida Statutes, the following are the minimum requirements for the charter of the Fellsmere Water Control District:

- (1) The district is organized and exists for all purposes set forth in this act and chapter 298, Florida Statutes, as may be amended from time to time.
- (2) The district's charter may be amended only by special act of the Legislature.
- (3) In accordance with chapter 189, Florida Statutes, this act, and ss. 298.11 and 298.12, Florida Statutes, as may be amended from time to time, the governing board of the district shall be designated the "Board of Supervisors of the Fellsmere Water Control District" and shall be composed of three persons, who shall be qualified to hold such office if they are landowners within the district, residents of the state, and citizens of the United States, elected on a 1-acre, one-vote basis by the landowners in the district; however, landowners owning less than 1 acre in the aggregate shall be entitled to one vote. Landowners with more than 1 acre shall be entitled to one additional vote for any fraction of an acre greater than 1/2 acre owned when a landowner's acreage has been aggregated for purposes of voting. The membership and organization of the governing board shall be as set forth in this charter and chapter 298, Florida Statutes, as may be amended from time to

time, provided this charter controls with respect to any inconsistency.

- (4) The compensation of the governing board members shall be governed by this act and chapter 298, Florida Statutes, as may be amended from time to time.
- (5) The administrative duties of the governing board shall be as set forth in this act and chapters 189 and 298, Florida

 Statutes, as may be amended from time to time.
- (6) Requirements for financial disclosure, meeting notices, reporting, public records maintenance, and per diem expenses for district officers and employees shall be as set forth in chapters 112, 189, 190, 286, and 298, Florida Statutes, and all other applicable general laws of the state, as may be amended from time to time.
- (7) The procedures and requirements governing the issuance of bonds, notes, and other evidence of indebtedness by the district shall be as set forth in chapters 189 and 298, Florida Statutes, and applicable general laws, as may be amended from time to time.
- (8) The procedures for conducting district elections or referenda and for qualification of electors shall be pursuant to chapters 189 and 298, Florida Statutes, as may be amended from time to time; however, a quorum for purposes of holding the annual meeting or any special meetings shall consist of those

landowners present in person or represented by proxy at said
meeting.

- (9) The district may be financed by any method established in this act, chapter 298, Florida Statutes, and other applicable general laws of the state, as may be amended from time to time.
- (10) The methods for collecting non-ad valorem
 assessments, fees, or service charges shall be as set forth in
 chapters 197 and 298, Florida Statutes, and other applicable
 general laws of the state, as may be amended from time to time.
- (11) The district's planning requirements shall be as set forth in chapters 189 and 298, Florida Statutes, as may be amended from time to time.
- (12) The district's geographic boundary shall be as set forth in this act.

Section 3. Provisions of chapter 298, Florida Statutes, made applicable.—The Fellsmere Water Control District is an independent water control district and a public corporation of this state. The provisions of state law applicable to water control districts or subdistricts which are embodied in chapter 298, Florida Statutes, as may be amended from time to time, so far as not inconsistent with this act, are declared to be applicable to the Fellsmere Water Control District. The Fellsmere Water Control District shall have all of the powers and authority conferred in this act and chapter 298, Florida Statutes, as may be amended from time to time.
