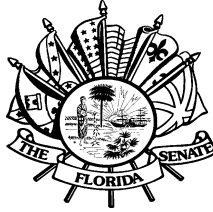

CS/CS/SB 586, 1st Eng. (3R) by the Committees on Judiciary, Environmental Preservation and Conservation and Senator Altman—

Brownfields; Revising legislative intent with regard to community revitalization in certain areas; revising procedures for designation of brownfield areas by local governments; providing procedures for adoption of a resolution; providing requirements for notice and public hearings; authorizing local governments to use a term other than “brownfield area” when naming such areas; providing an exemption from liability for property damage for entities that execute and implement certain brownfield site rehabilitation agreements; providing for applicability, etc. Effective Date: 07/01/2014

Read the second time and amended on April 11, 2014

CS/CS/SB 850, 1st Eng. (3R) by the Committees on Appropriations, Education and Senator Legg—

Education; Requiring a school that includes certain grades to include information, data, and instructional strategies in its school improvement plan; revising the kind of lab schools that receive a proportional share of the sparsity supplement; requiring a district school board, in consultation with the district school superintendent, to make CAPE Digital Tool certificates and CAPE industry certifications available to students, including students with disabilities, in prekindergarten through grade 12, to enable students to attain digital skills; authorizing district school boards to execute a contract with a state university or certain independent colleges and universities to establish the collegiate high school program, etc. Effective Date: 07/01/2014

SB 1108 (3R) by the Committee on Community Affairs (Simpson)—

OGSR/Children of Agency Officers and Employees/Identifying Information; Amending provisions relating to an exemption from public record requirements for personal identifying information of certain dependent children of current or former agency officers or employees; removing the scheduled repeal of the exemption, etc. Effective Date: 10/01/2014

CS/CS/SB 286, 1st Eng. (3R) by the Committees on Governmental Oversight and Accountability, Regulated Industries, Senator Richter and others—

Concrete Masonry Education; Creating the “Concrete Masonry Education Act”; creating the Florida Concrete Masonry Education Council, Inc.; requiring the council to operate under a written contract with the Department of Economic Opportunity; authorizing the council to accept grants, donations, contributions, and gifts under certain circumstances; providing for collection of a voluntary assessment on concrete masonry units; requiring manufacturers who elect to pay the assessment to commit to paying the assessment for a specified period, etc. Effective Date: 07/01/2014

CS/CS/SB 172, 1st Eng. (3R) by the Committees on Regulated Industries, Commerce and Tourism and Senator Soto—

Notaries Public; Requiring a notary public to record specified information in a notarial journal when performing certain notarial acts; requiring that a notary public retain a notarial journal for a specified period; requiring a notary public to notify the Notary Section of the Executive Office of the Governor if a notarial journal is lost, stolen, misplaced, destroyed, erased, compromised, rendered unusable, or becomes otherwise inaccessible during the retention period; exempting certain acts of specified law enforcement and correctional officers from the notarial journal requirements, etc. Effective Date: 01/01/2015

HB 559 (3R) by Representative Metz and others—

Military Veterans; Revises references from Korean Conflict & Vietnam Era to Korean War & Vietnam War, respectively, & from Korean Conflict Veteran to Korean War Veteran; authorizes issuance of Combat Medical Badge license plate; revises references; establishes method of proof of eligibility for certain specialty license plate. Effective Date: 07/01/2014

CS/HB 591 (3R) by the Committee on Health and Human Services Committee and Representative Harrell—

Newborn Health Screening; Authorizes State Public Health Laboratory to release results of newborn's hearing & metabolic tests or screenings to newborn's health care practitioner; requires audiologist to provide parent or guardian with contact information of certain service providers; requires audiologist or designee to electronically transmit consent form. Effective Date: 07/01/2014

CS/SB 726 (3R) by the Committee on Governmental Oversight and Accountability and Senator Detert—

Reemployment Assistance Appeals Commission; Revising membership requirements of the commission; removing a provision requiring payment of a daily stipend for certain commissioners, etc. Effective Date: 07/01/2014

HB 7009 (3R) by the Committee on Insurance and Banking Subcommittee, Representative Moraitis and others—

Security for Public Deposits; Revises collateral-pledging level for public deposits; repeals provisions relating to Qualified Public Depository Oversight Board; provides that notice of default or insolvency of qualified public depository is not required; requires information from nonqualified bank, savings bank, or savings association that acquires public depository by default or insolvency; revises notice requirements for public depositories; revises restrictions on loss protection provisions in certain circumstances in which public depositor fails to comply with notice requirements. Effective Date: 07/01/2014

CS/SB 762 (3R) by the Committee on Governmental Oversight and Accountability and Senator Detert—

Family Care Councils; Revising the membership of the family care council within each service area of the Agency for Persons with Disabilities; requiring consent of a grandchild's parent or legal guardian for appointment of a grandparent to a family care council; requiring the parent or legal guardian to provide notice of consent to the agency, etc. Effective Date: 07/01/2014

CS/CS/CS/SB 702 (3R) by the Committees on Appropriations, Judiciary, Regulated Industries, Senator Bean and others—

Pharmacy Audits; Enumerating the rights of pharmacies relating to audits of pharmaceutical services which are conducted by certain entities; providing a list of audits not subject to such rights; providing an exemption from the right to notice of an on-site audit under certain circumstances, etc. Effective Date: 10/01/2014

POW-MIA Chair of Honor Memorial; Establishes POW-MIA Chair of Honor Memorial; authorizes Florida chapters of Rolling Thunder, Inc., to fund memorial; requires DMS to designate an area of Capitol Complex for memorial; requires department to consult with DVA & Florida chapters of Rolling Thunder, Inc., regarding specific aspects of memorial. Effective Date: Upon becoming a law

CS/CS/SB 708, 1st Eng. (3R) by the Committees on Appropriations, Banking and Insurance and Senator Bean—

Insurance Claims; Providing that a claim for residential property insurance cannot be denied based on certain credit information; providing that a policy or contract may not be cancelled based on certain credit information; providing grounds for challenging an umpire's impartiality in estimating the amount of a property loss; establishing a Homeowner Claims Bill of Rights for residential property insurance policyholders, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect July 1, 2014

Read the second time and amended on April 23, 2014

CS/CS/SB 820, 1st Eng. (3R) by the Committees on Community Affairs, Transportation and Senator Bullard—

Transportation Facility Designations; Providing honorary designations of certain transportation facilities in specified counties; directing the Department of Transportation to erect suitable markers, etc. Effective Date: 07/01/2014

Read the second time and amended on April 23, 2014

CS/SB 862 (3R) by the Committees on Judiciary, and Health Policy (Bean)—

Prescription Drug Monitoring; Revising provisions relating to the comprehensive electronic database system and prescription drug monitoring program maintained by the Department of Health; requiring the department to adopt a user agreement by rule; authorizing the department to provide relevant information that does not contain personal identifying information to a law enforcement agency if the program manager determines that a specified pattern exists; repealing language creating a direct-support organization to fund the program, etc. Effective Date: 07/01/2014

Read the second time on April 23, 2014

CS/SB 1142 (3R) by the Committee on Commerce and Tourism, Senator Lee and others—

Ticket Sales; Providing that a person who counterfeits, forges, alters, clones, or possesses a ticket, card, wristband, or other medium that accesses or is associated with a specified ticket, token, or paper with the intent to defraud commits a misdemeanor of the first degree; providing enhanced criminal penalties for second and subsequent violations concerning fraudulent creation or possession of an admission ticket; prohibiting the sale, offer for sale, or transfer of certain multiuse tickets or a card, wristband, or other medium that accesses or is associated with such multiuse ticket, etc. Effective Date: 07/01/2014

Read the second time on April 23, 2014

HB 1049, 1st Eng. (3R) by Representative Raschein and others—

Divers; Requires all divers to prominently display divers-down flags or buoys in areas in which diving occurs; requires vessel operators encountering divers-down buoys to take specified actions; prohibits divers-down buoys from being used or displayed onboard vessels. Effective Date: 07/01/2014

Substituted for CS/SB 1176(SUB) (Abruzzo) and read the second time on April 23, 2014

CS/CS/SB 1308 (3R) by the Committees on Judiciary, Banking and Insurance and Senator Simmons—

Insurer Solvency; Providing additional definitions applicable to the Florida Insurance Code; clarifying that production of documents does not waive the attorney-client or work-product privileges; requiring an insurer's annual statement to include an actuarial opinion summary; revising the Standard Valuation Law and the Standard Nonforfeiture Law; providing for the groupwide supervision of international insurance groups, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect October 1, 2014, if SB 1300 or similar legislation is adopted in the same legislative session or an extension thereof and becomes a law

Read the second time on April 23, 2014

HB 7031 (3R) by the Committee on K-12 Subcommittee, Representative Adkins and others—

Education; Revises & repeals various provisions relating to education; revises course & assessment requirements for promotion to high school & for award of standard high school diploma; provides course & assessment requirements for graduation for certain cohorts of high school students transitioning to new graduation requirements; revises & conforms provisions relating to selection & purchase of instructional materials, statewide assessment program, education personnel, & educational facilities. Effective Date: Upon becoming a law

Substituted for CS/CS/SB 1226(SUB) (Montford), read the second time, and amended on April 23, 2014

CS/SB 1190 (3R) by the Committee on Children, Families, and Elder Affairs and Senator Lee—

Family Law; Creating the "Collaborative Law Act"; declaring that a collaborative law process commences when the parties enter into a collaborative law participation agreement; providing that a tribunal may not order a party to participate in a collaborative law process over the party's objection; providing for confidentiality of communications made during the collaborative law process, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect July 1, 2014

Read the second time on April 23, 2014

CS/CS/SB 132, 1st Eng. (3R) by the Committees on Transportation, Rules, Senator Latvala and others—

Specialty License Plates; Authorizing the collection of annual use fees for the Fallen Law Enforcement Officers license plate, the Florida Sheriffs Association license plate, the Keiser University license plate, and the Moffitt Cancer Center license plate; revising provisions relating to the distribution of annual use funds to the Astronauts Memorial Foundation, Inc., for the Challenger/Columbia specialty license plate; requiring the Department of Highway Safety and Motor Vehicles to discontinue the plates under certain circumstances; establishing an annual use fee for the plates; providing for the distribution of use fees received from the sale of such plates, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect October 1, 2014

CS/HB 7081, 1st Eng. (3R) by the Committees on Appropriations Committee, Finance and Tax Subcommittee and Representative Caldwell—

Tax Administration; Revises provisions relating to ad valorem taxes, the tax on sales, use, & other transactions, electronic remittance & distribution of funds collected by clerks of court, automated sales suppression devices, & unemployment compensation. Effective Date: Upon becoming a law

Substituted for CS/SB 1654(SUB) (Hukill) and read the second time on April 23, 2014

SB 392 (3R) by Senators Brandes and Clemens—

State Speed Zones; Raising the maximum allowable speed limit on certain highways; increasing the maximum allowable speed limit on roadways under the jurisdiction of the Department of Transportation, etc. Effective Date: 07/01/2014

Read the second time on April 23, 2014

SB 566 (3R) by Senator Lee—

Florida Bright Futures Scholarship Program; Requiring a student, as a prerequisite for the Florida Academic Scholars award, the Florida Medallion Scholars award, or the Florida Gold Seal Vocational Scholars award, to identify a social or civic issue or a professional area of interest and develop a plan for his or her personal involvement in addressing the issue or learning about the area; prohibiting the student from receiving remuneration or academic credit for the volunteer service work performed, etc. Effective Date: 07/01/2014

Read the second time on April 23, 2014

CS/CS/SB 764 (3R) by the Committees on Rules, Judiciary and Senator Detert—

Hearsay; Providing that certain statements are an exception to the hearsay rule and thus admissible, etc. Effective Date: Upon becoming a law

CS/CS/SB 782 (3R) by the Committees on Appropriations, Governmental Oversight and Accountability, Senator Brandes and others—

Government Data Practices; Requiring the Division of Library and Information Services of the Department of State to adopt rules providing procedures for an agency to establish schedules for the physical destruction or other disposal of records containing personal identification information; requiring an agency that collects and maintains personal identification information to post a privacy policy on the agency's website; requiring the Agency for Health Care Administration to provide specified data on assisted living facilities by a certain date, etc. Effective Date: 07/01/2014

Read the second time on April 23, 2014

CS/CS/SB 1150 (3R) by the Committees on Health Policy, Commerce and Tourism and Senator Bean—

Medical Tourism; Requiring Enterprise Florida, Inc., to collaborate with the Department of Economic Opportunity to market this state as a health care destination; requiring the Division of Tourism Marketing to include in its 4-year plan a discussion of the promotion of medical tourism; requiring the plan to promote national and international awareness of the qualifications, scope of services, and specialized expertise of health care providers in this state, to promote national and international awareness of certain business opportunities to attract practitioners to destinations in this state, and to include an initiative to showcase qualified health care providers, etc. Effective Date: 07/01/2014

Read the second time on April 23, 2014

HB 7029 (3R) by the Committee on K-12 Subcommittee, Representative Baxley and others—

Code of Student Conduct; Provides that simulating firearm or weapon while playing or wearing certain clothing or accessories is not grounds for disciplinary action or referral to criminal justice or juvenile justice system; provides criteria for determining whether certain student conduct warrants disciplinary action; provides criteria for determining appropriate consequences for conduct. Effective Date: Upon becoming a law

Substituted for SB 1060(SUB) (Evers) and read the second time on April 23, 2014

HB 7097 (3R) by the Committee on Rulemaking Oversight and Repeal Subcommittee and Representative Steube—

Ratification of Rules/Office of Insurance Regulation; Ratifies specified OFR rules requiring title insurance agencies & retail offices of certain title insurance underwriters to electronically submit certain statistical data, for sole & exclusive purpose of satisfying any condition on effectiveness pursuant to s. 120.541(3), F.S. Effective Date: Upon becoming a law

Substituted for SB 1698(SUB) (Simmons) and read the second time on April 23, 2014

CS/SB 1726 (3R) by the Committees on Appropriations, and Children, Families, and Elder Affairs (Sobel)—
