CS/CS/SB 638 (SO) by the Committees on Appropriations, Commerce and Tourism and Senator Brandes—

Charities; Excluding charitable organizations or sponsors disqualified by the Department of Agriculture and Consumer Services from receiving certain tax exemptions; revising the applicability of the Solicitation of Contributions Act; requiring that the financial statements of certain charitable organizations or sponsors be audited or reviewed; requiring each officer, director, trustee, or owner of a professional solicitor and any employee of a professional solicitor that conducts certain telephonic solicitations to obtain a solicitor license from the department, etc. Effective Date: 07/01/2014
