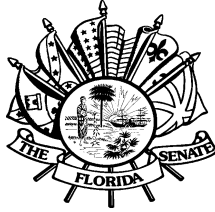

SB 2-B (SO) by Senator Galvano—

Establishing the Congressional Districts of the State; Redistricting the state's congressional districts in accordance with the United States Decennial Census of 2010 (plan H000C9065); deleting provisions providing for apportionment of districts for the United States House of Representatives which are superseded by the act; providing for the future repeal of provisions relating to the applicability of districts for the United States House of Representatives which are superseded by the act, etc. Effective Date: Except for sections 9 and 10 and this section, which shall take effect upon this act becoming a law, this act shall take effect upon the expiration of the terms of the representatives to the United States House of Representatives serving on the date that this act becomes a law
