SJR 2-C (SO) by Senator Galvano—

Apportionment; Apportioning the senatorial districts of the state in accordance with the United States Decennial Census of 2010; providing for the inclusion of omitted areas; providing contiguity for areas specified for inclusion in one senatorial district which are noncontiguous; specifying that the apportioned districts constitute the senatorial districts of the state; providing for severability of invalid portions, etc.
