## SPECIAL ORDER CALENDAR FOR WEDNESDAY, APRIL 12, 2017

### **CS/SB 10 (SO) by the Committee on Appropriations, Senator Bradley and others—**

**Water Resources;** Authorizing the South Florida Water Management District and the Board of Trustees of the Internal Improvement Trust Fund to negotiate the amendment and termination of leases on lands within the Everglades Agricultural Area for exchange or use for the reservoir project; requiring certain lease agreements for agricultural work programs to be terminated in accordance with the lease terms; requiring the district to request that the United States Army Corps of Engineers jointly develop a post-authorization change report for the Central Everglades Planning Project ;providing requirements for the C-51 reservoir project if state funds are appropriated for the project; prohibiting the use of inmates for correctional work programs in the agricultural industry in certain areas; providing appropriations, etc. Effective Date: Upon becoming a law

*Reported favorably by the Committee on Environmental Preservation and Conservation; recommended favorably as a committee substitute by Appropriations Subcommittee on the Environment and Natural Resources; and reported favorably as a committee substitute by the Committee on Appropriations*

### **SB 2500 (SO) by the Committee on Appropriations (Latvala)—**

**Appropriations;** Providing moneys for the annual period beginning July 1, 2017, and ending June 30, 2018, and supplemental appropriations for the period ending June 30, 2017, to pay salaries and other expenses, capital outlay - buildings, and other improvements, and for other specified purposes of the various agencies of state government, etc. Effective Date: Except as otherwise provided herein, this act shall take effect July 1, 2017, or upon becoming law, whichever occurs later; however, if this act becomes law after July 1, 2017, then it shall operate retroactively to July 1, 2017

---

### **SB 2502 (SO) by the Committee on Appropriations (Latvala)—**

**Implementing the 2017-2018 General Appropriations Act;** Incorporating by reference certain calculations of the Florida Education Finance Program; extending the date by which the Florida Polytechnic University must meet certain criteria established by the Board of Governors; providing an exception from cost per student station limitations for the Dixie County Middle/High School special facility project; requiring the Agency for Persons with Disabilities to contract for an independent consultant to study and make recommendations on certain aspects of the home and community-based services Medicaid waiver program, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2017; or, if this act fails to become a law until after that date, it shall take effect upon becoming a law and shall operate retroactively to July 1, 2017

---

### **SB 2504 (SO) by the Committee on Appropriations (Latvala)—**

**State Employees;** Providing for the resolution of collective bargaining issues at impasse between the state and certified bargaining units of state employees, etc. Effective Date: 07/01/2017

### **SB 7022 (SO) by the Committee on Governmental Oversight and Accountability (Baxley)—**

**State-administered Retirement Systems;** Revising required employer retirement contribution rates for each membership class and subclass of the Florida Retirement System, etc. Effective Date: 07/01/2017

*Reported favorably by the Committee on Appropriations*

---

### **SB 2506 (SO) by the Committee on Appropriations (Latvala)—**

**Clerks of the Court;** Requiring that certain filing fees for trial and appellate proceedings be deposited into clerks of the circuit court fine and forfeiture funds, rather than into the General Revenue Fund; authorizing the Florida Clerks of the Court Operations Corporation to recommend budgets that are in excess of the official estimate under certain circumstances; requiring the corporation to certify the revenue deficit and report the amount necessary to fund anticipated expenditures to the commission, etc. Effective Date: Upon becoming a law

---

### **SB 2508 (SO) by the Committee on Appropriations (Latvala)—**

**Division of State Group Insurance;** Removing a requirement that a contract for dependent eligibility verification services for the state group insurance program be contingency-based; requiring the division to notify subscribers of dependent eligibility rules by a certain date; requiring the division to hold a subscriber harmless for past claims of ineligible dependents for a specified timeframe, etc. Effective Date: 07/01/2017

---

### **SB 2510 (SO) by the Committee on Appropriations (Latvala)—**

**Public Records/Dependent Eligibility Verification Services;** Creating an exemption from public records requirements for records collected for dependent eligibility verification services for the state group insurance program and held by the Department of Management Services; providing for future legislative review and repeal; providing a statement of public necessity, etc. Effective Date: On the same date that SB 2508 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes law

---

### **SB 2512 (SO) by the Committee on Appropriations (Latvala)—**

**Capitol Complex Advisory Council;** Creating the advisory council within the legislative branch; authorizing the advisory council to consult with specified persons in furtherance of its duties; requiring the Department of Management Services to periodically brief the advisory council with respect to planned actions regarding the Capitol Complex, etc. Effective Date: 07/01/2017

**SB 2514 (SO) by the Committee on Appropriations (Latvala)—**

**Health Care;** Providing that a specified percentage of the cigarette tax, up to a specified amount, be paid annually to the Florida Consortium of National Cancer Institute Centers Program, rather than the Sanford-Burnham Medical Research Institute; creating the Substance Abuse and Mental Health (SAMH) Safety Net Network; requiring the Department of Children and Families and the Agency for Health Care Administration to determine the scope of services to be offered through providers contracted with the SAMH Safety Net Network, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon becoming a law, this act shall take effect July 1, 2017

---

**SB 2516 (SO) by the Committee on Appropriations (Latvala)—**

**Education Funding;** Requiring the Auditor General to conduct annual audits of the Florida School for the Deaf and the Blind; extending the date for future legislative review and repeal of provisions governing the Florida Endowment for Vocational Rehabilitation; requiring the 300 lowest-performing elementary schools to provide a specified summer school program; revising the schools that may be considered small, isolated schools to include elementary schools that meet certain requirements, for the purpose of determining the annual allocation to each district, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2017

---

**CS/CS/SB 374 (SO) by the Committees on Appropriations, Education, Senator Hukill and others—**

**Postsecondary Education;** Citing this act as the "College Competitiveness Act of 2017"; renaming the Florida College System as the Florida Community College System; creating the State Board of Community Colleges; prohibiting citizen members of the State Board of Community Colleges or Florida Community College System institution boards of trustees from having an employment or contractual relationship as specified lobbyists; revising the function and mission of the Florida K-20 education system; providing the primary mission of a career center operated by a district school board, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon becoming a law, this act shall take effect October 1, 2017

*Reported favorably as a committee substitute by the Committee on Education; and reported favorably as a committee substitute by the Committee on Appropriations*

---

**SB 376 (SO) by Senator Simmons—**

**Charter School Funding;** Authorizing school boards to levy specified amounts for charter schools; providing that charter school capital outlay funding consists of shared local capital outlay and state funding as provided in the General Appropriations Act; prohibiting a charter school from being eligible for a funding allocation under certain circumstances, etc. Effective Date: 07/01/2017

*Reported favorably by the Committee on Education; recommended favorably by Appropriations Subcommittee on Pre-K - 12 Education; and reported favorably by the Committee on Appropriations*

**CS/CS/SB 234 (SO) by the Committees on Appropriations, Environmental Preservation and Conservation, Senator Bradley and others—**

**Land Acquisition Trust Fund;** Requiring a specified appropriation for certain projects related to the St. Johns River and its tributaries or the Keystone Lake Region, etc. Effective Date: 07/01/2017

*Reported favorably as a committee substitute by the Committee on Environmental Preservation and Conservation; and reported favorably as a committee substitute by the Committee on Appropriations*

**CS/CS/SM 572 (SO) by the Committees on Rules, Commerce and Tourism, Senator Campbell and others—**

**Haitian Independence and Flag Day/Haitian, Haitian American, and Caribbean American Heritage Month;** Urging Congress to recognize January 1 as "Haitian Independence Day," the month of May as "Haitian Heritage Month" and "Haitian American Heritage Month," May 18 as "Haitian Flag Day," and the month of June as "Caribbean American Heritage Month," etc.

**CS/SB 532 (SO) by the Committee on Environmental Preservation and Conservation, Senator Galvano and others—**

**Public Notification of Pollution;** Creating the "Public Notice of Pollution Act"; specifying authority of the Department of Environmental Protection; specifying that the act does not alter or affect the emergency management responsibilities of certain other governmental entities; requiring an owner or operator of an installation at which a reportable pollution release occurred to provide certain information to the department within 24 hours after the discovery of a reportable pollution release, etc. Effective Date: 07/01/2017

*Reported favorably as a committee substitute by the Committee on Environmental Preservation and Conservation; Appropriations Subcommittee on the Environment and Natural Resources recommends the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably*

**CS/CS/SB 886 (SO) by the Committees on Governmental Oversight and Accountability, Children, Families, and Elder Affairs and Senator Powell—**

**Public Records/Substance Abuse Impaired Persons;** Providing an exemption from public records requirements for petitions for involuntary assessment and stabilization, court orders, related records, and personal identifying information regarding substance abuse impaired persons; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: 07/01/2017

*Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and the Committee on Rules reports the committee substitute favorably*

---

**CS/CS/SB 550 (SO) by the Committees on Judiciary, Criminal Justice, Senator Bracy and others—**

**Public Records/Murder Witness;** Providing that the personal identifying information of a witness to a murder remains confidential and exempt for a specified period; providing an exemption from public records requirements for criminal intelligence or criminal investigative information that reveals the personal identifying information of a witness to a murder for a specified period; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: 07/01/2017

*Reported favorably as a committee substitute by the Committee on Criminal Justice; reported favorably as a committee substitute by the Committee on Judiciary; the Committee on Governmental Oversight and Accountability reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably*

**SB 350 (SO) by Senator Clemens—**

**Criminal Justice Standards and Training Commission;** Requiring the Criminal Justice Standards and Training Commission to implement, administer, maintain, and revise a basic abilities examination by a specified date; requiring that examination fees be deposited in the Criminal Justice Standards and Training Trust Fund; reenacting provisions relating to examinations, administration, and materials not being public records, to incorporate the amendment made to provisions in a reference thereto, etc. Effective Date: 07/01/2017

*Reported favorably by the Committee on Criminal Justice; recommended favorably by Appropriations Subcommittee on Criminal and Civil Justice; and reported favorably by the Committee on Appropriations*

**SB 372 (SO) by Senator Stargel—**

**Reemployment Assistance Fraud;** Authorizing reproductions from certain files or digital records maintained by the Department of Highway Safety and Motor Vehicles to be made and issued to the Department of Economic Opportunity pursuant to an interagency agreement for specified purposes, etc. Effective Date: Upon becoming a law

*Reported favorably by the Committee on Commerce and Tourism; reported favorably by the Committee on Transportation; and reported favorably by the Committee on Rules*

---

**CS/CS/SB 172 (SO) by the Committees on Judiciary, Children, Families, and Elder Affairs, Senator Passidomo and others—**

**Guardianship;** Requiring each examining committee member, in a proceeding to determine a person's incapacity, to file his or her report with the clerk of the court within a specified timeframe after appointment; revising the timeframe within which specified parties must be served with all reports; increasing the timeframe within which a guardian has to file a required annual guardianship plan with the court if the court does not require filing on a calendar-year basis, etc. Effective Date: 07/01/2017

*Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; reported favorably as a committee substitute by the Committee on Judiciary; and the Committee on Rules reports the committee substitute favorably*

**CS/CS/SB 18 (SO) by the Committees on Appropriations, Judiciary and Senator Flores—**

**Relief of "Survivor" and the Estate of "Victim" by the Department of Children and Families;** Providing for the relief of "Survivor" and the Estate of "Victim"; providing appropriations to compensate Survivor and the Estate of Victim for injuries and damages sustained as a result of the negligence of the Department of Children and Families, formerly known as the Department of Children and Family Services, etc. Effective Date: Upon becoming a law

**CS/SB 852 (SO) by the Committee on Criminal Justice, Senator Garcia and others—**

**Human Trafficking;** Requiring the Department of Children and Families or a sheriff's office to conduct a multidisciplinary staffing on child victims of commercial sexual exploitation to determine the child's service and placement needs; defining the term "commercial sexual exploitation"; adding human trafficking to the list of crimes requiring pretrial detention of the defendant, etc. Effective Date: 10/01/2017

**Shark Fins;** Prohibiting persons from possessing separated shark fins except under certain conditions; providing penalties; prohibiting persons with suspended or revoked saltwater license privileges from engaging in certain activities, etc. Effective Date: 10/01/2017

### **CS/SB 148 (2R) by the Committee on Education and Senator Garcia—**

**Students Remaining on School Grounds During School Hours;** Requiring schools in certain districts to obtain written parental consent before permitting students to leave school grounds during the lunch period, etc. Effective Date: 07/01/2017

### **CS/CS/SB 264 (2R) by the Committees on Rules, Judiciary and Senator Artilles—**

**Self-storage;** Providing that a lien sale may be conducted on certain websites; providing that a self-storage facility owner is not required to have a license to post property for online sale; authorizing an owner to impose and collect a late fee from a tenant under certain circumstances; authorizing an owner to charge the tenant certain reasonable expenses incurred in rent collection or lien enforcement, etc. Effective Date: 07/01/2017

*Reported favorably as a committee substitute by the Committee on Judiciary; the Committee on Regulated Industries reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Rules*

### **CS/CS/SB 334 (2R) by the Committees on Rules, Judiciary and Senator Steube—**

**Prejudgment Interest;** Requiring a court to include interest on economic damages and costs in the final judgment of a negligence action as a result of a personal injury; specifying the date from which interest accrues, etc. Effective Date: 07/01/2017

*Reported favorably as a committee substitute by the Committee on Judiciary; and reported favorably as a committee substitute by the Committee on Rules*

### **CS/CS/SB 340 (2R) by the Committees on Judiciary, Banking and Insurance, Senator Brandes and others—**

**Transportation Network Companies;** Providing that a transportation network company (TNC) driver is not required to register certain vehicles as commercial motor vehicles or for-hire vehicles; providing requirements for a TNC's digital network; providing that specified automobile insurers have a right of contribution against other insurers that provide automobile insurance to the same TNC drivers in satisfaction of certain coverage requirements under certain circumstances, etc. Effective Date: 07/01/2017

*Reported favorably as a committee substitute by the Committee on Banking and Insurance; reported favorably as a committee substitute by the Committee on Judiciary; and the Committee on Rules reports the committee substitute favorably*

### **CS/SB 392 (2R) by the Committee on Education, Senator Hukill and others—**

**High School Graduation Requirements;** Revising the requirements for the Next Generation Sunshine State Standards to include financial literacy; revising the required credits for a standard high school diploma to include one-half credit of instruction in personal financial literacy and money management and seven and one-half, rather than eight, credits in electives, etc. Effective Date: 07/01/2017
