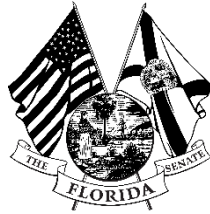

CS/SB 1670 (3R) by the Committee on Appropriations and Senator Latvala—

Juvenile Justice; Requiring the Department of Health to waive fees for a birth certificate issued to certain juvenile offenders; providing an additional circumstance under which the court may order continued detention; requiring the court to place a prolific juvenile offender in certain detention care under a special detention order until disposition; revising the circumstances under which an adjudication of delinquency for a felony disqualifies a person from possessing a firearm, etc. Effective Date: 10/01/2017

Read the second time on April 27, 2017

Similar to CS/CS/HB 7059(HC) in the Committee on Rules

CS/CS/CS/HB 785 (3R) by the Committees on Health and Human Services Committee, Health Care Appropriations Subcommittee, Health Quality Subcommittee, Representative Magar and others—

Stroke Centers; Directs AHCA to include hospitals meeting criteria for acute stroke ready centers on list of stroke centers; authorizes DOH to contract with private entity to establish & maintain registry, subject to appropriation; provides immunity from liability. Effective Date: 07/01/2017

Substituted for CS/CS/SB 1406(SUB) (Powell) and read the second time on April 28, 2017

CS/HB 493 (3R) by the Committee on Transportation and Infrastructure Subcommittee, Representative Toledo and others—

Enhanced Safety for School Crossings; Requires DOT to evaluate viability & cost of uniform system of high-visibility markings & signage for designation of safe school crossings, subject to certain requirements; authorizes DOT to consider implementation of new technology/innovations that enhance pedestrian & crosswalk visibility; requires report. Effective Date: 07/01/2017

Substituted for SB 1416(SUB) (Young) and read the second time on April 28, 2017

CS/CS/SB 1682 (3R) by the Committees on Rules, Regulated Industries, Senator Garcia and others—

Condominiums; Prohibiting an officer, director, or manager of a condominium association from soliciting, offering to accept, or accepting a kickback for which consideration has not been provided; prohibiting an association from hiring an attorney who represents the management company of the association; requiring the Division of Florida Condominiums, Timeshares, and Mobile Homes to maintain and provide copies of financial reports; authorizing, rather than requiring, the division to employ full-time attorneys to conduct certain arbitration hearings; prohibiting specified parties from purchasing a unit at a foreclosure sale resulting from the association's foreclosure of association lien for unpaid assessments or from taking a deed in lieu of foreclosures, etc. Effective Date: 07/01/2017

Read the second time on April 28, 2017

Similar to CS/CS/HB 1237, 1st Eng.(HC) in the Committees on Judiciary; Regulated Industries; and Rules

HJR 7105 (3R) by the Committee on Ways and Means Committee, Representatives La Rosa, Jaquet and others—

Increased Homestead Property Tax Exemption; Amends the State Constitution to increase the homestead exemption by exempting the assessed valuation of homestead property greater than \$75,000 and up to \$100,000 for all levies other than school district levies. The amendment shall take effect January 1, 2019.

Read the second time and amended on April 28, 2017

HB 7107 (3R) by the Committee on Ways and Means Committee and Representative La Rosa—

Homestead Exemption Implementation; Increases homestead exemption from all taxes other than school district taxes; specifies calculation of rolled-back rate for purposes of 2019 tax roll; requires Legislature to appropriate moneys to offset reductions in tax revenues in certain counties as result of specified constitutional amendment. Effective Date: On the effective date of the amendment to the State Constitution proposed by HJR 7105 or a similar joint resolution having substantially the same specific intent and purpose

SB 862 (3R) by Senator Lee and others—

Public Records/Voters and Voter Registration; Providing an exemption from public records requirements for information concerning preregistered voter registration applicants who are minors; providing for future legislative review and repeal; providing a statement of public necessity, etc. Effective Date: 07/01/2017

Read the second time on April 28, 2017

CS/CS/CS/HB 695 (3R) by the Committees on Government Accountability Committee, Transportation and Tourism Appropriations Subcommittee, Transportation and Infrastructure Subcommittee and Representative Santiago—

South Florida Regional Transportation Authority; Authorizes South Florida Regional Transportation Authority, in conjunction with operation of certain commuter rail service, to assume specified indemnification & insurance obligations, subject to certain requirements; authorizes DOT to agree to assume certain indemnification & insurance obligations under certain circumstances; prohibits authority from entering into certain contracts/agreements without DOT approval of expenditures; provides that certain funds provided to authority are state financial assistance; requires written agreement; authorizes advance of funds under certain circumstances. Effective Date: 07/01/2017

CS/HB 6545 (3R) by the Committee on Civil Justice and Claims Subcommittee and Representative Raburn—

Relief/Jerry Cunningham/Broward County; Provides appropriation from Broward County to compensate Jerry Cunningham for injuries sustained as result of negligence of Broward County; provides that appropriation settles all present & future claims; provides limitation on payment of compensation, fees, & costs. Effective Date: Upon becoming a law

Substituted for SB 314(SUB) (Farmer) and read the second time on April 28, 2017

CS/HB 6549, 1st Eng. (3R) by the Committee on Civil Justice and Claims Subcommittee and Representative Diaz, J.—

Relief/Altavious Carter/Palm Beach County School Board; Provides appropriation from PBCSB to compensate Altavious Carter for injuries sustained as result of negligence of school district employee; provides limitation on payment of fees & costs. Effective Date: Upon becoming a law

Substituted for CS/CS/SB 304(SUB) (Thurston), read the second time, and amended on April 28, 2017

CS/SB 1398 (3R) by the Committee on Appropriations, Senator Stewart and others—

Accessibility of Places of Public Accommodation; Authorizing qualified experts to advise and provide certain inspections for places of public accommodation relating to the Americans with Disabilities Act; authorizing an owner of a place of public accommodation to file a certification of conformity or remediation plan with the Department of Business and Professional Regulation, etc. Effective Date: 07/01/2017

Read the second time on April 28, 2017

Similar to CS/CS/CS/HB 727, 1st Eng.(HC) in the Committees on Regulated Industries; Appropriations Subcommittee on General Government; and Appropriations

HB 301 (3R) by Representative White and others—

Supreme Court Reporting Requirements; Requires Supreme Court to prepare annual report regarding certain cases; specifies data to be included in such report; provides for future legislative review & repeal. Effective Date: 07/01/2017

Substituted for CS/CS/SB 196(SUB) (Flores), read the second time, and amended on April 28, 2017

CS/SB 1238, 1st Eng. (3R) by the Committee on Rules and Senator Bean—

Utility Investments in Gas Reserves; Revising the jurisdiction of the Public Service Commission over public utilities to include the approval of cost recovery for certain gas reserve investments; requiring each public utility to file with the commission a comparison of all gas reserve projects entered into on behalf of the utility and any affiliate or subsidiary of the parent company as part of its risk management plan; requiring the use of a third-party auditor for audits of associated transactions for a gas reserve project, etc. Effective Date: 07/01/2017

Read the second time and amended on April 28, 2017

CS/CS/HB 465 (3R) by the Committees on Government Accountability Committee, Local, Federal and Veterans Affairs Subcommittee, Representative Raburn and others—

Firefighters; Provides for designation as Lifetime Firefighter; provides requirements for such designation; provides responsibilities of Division of State Fire Marshal within DFS; authorizes division to investigate convictions or disqualifying events concerning Lifetime Firefighters; authorizes division to adopt rules. Effective Date: 07/01/2017

Substituted for CS/SB 1084(SUB) (Stargel) and read the second time on April 28, 2017

CS/CS/HB 573, 1st Eng. (3R) by the Committees on Agriculture and Natural Resources Appropriations Subcommittee, Natural Resources and Public Lands Subcommittee, Representative Burton and others—

Water Protection and Sustainability; Creates "Heartland Headwaters Protection & Sustainability Act"; requires cooperative to prepare annual report concerning water resource projects & specifies requirements for such report. Effective Date: 07/01/2017

Substituted for CS/SB 928(SUB) (Stargel) and read the second time on April 28, 2017

CS/CS/HB 557 (3R) by the Committees on Health and Human Services Committee, Health Quality Subcommittee, Representatives Duran, Silvers and others—

Controlled Substance Prescribing; Defines "acute pain"; limits prescribing of opioids for acute pain in certain circumstances; revises requirements for reporting dispensing of controlled substances; limits exception to reporting requirements for certain facilities dispensing controlled substances; authorizes certain employees of U.S. Department of Veterans Affairs to access certain information in program's database; specifies when revised reporting requirement takes effect. Effective Date: 07/01/2017

Substituted for CS/CS/CS/SB 840(SUB) (Clemens), read the second time, and amended on April 28, 2017

CS/HB 879 (3R) by the Committee on Justice Appropriations Subcommittee, Representative Burgess and others—

Unlawful Acquisition of Utility Services; Revises elements that constitute theft of utilities; specifies circumstances that constitute prima facie evidence of violations; specifies types of damages that may be recovered for damaging property of utility or for theft of electricity services; specifies methods & bases used to determine & assess damages for damaging property of utility or for theft of electricity services. Effective Date: 10/01/2017

Substituted for CS/CS/SB 776(SUB) (Baxley) and read the second time on April 28, 2017

HB 379, 1st Eng. (3R) by Representative Leek and others—

Underground Facilities; Revises information to be submitted to Legislature by board of directors of Sunshine State One-Call of Florida, Inc.; requires excavators to call 911 under specified circumstances; requires member operators to file report with free-access notification system; provides reporting requirements; specifies distribution of civil penalties issued by state law enforcement officers. Effective Date: 07/01/2017

Substituted for CS/SB 446(SUB) (Passidomo) and read the second time on April 28, 2017

CS/CS/SB 1018, 1st Eng. (3R) by the Committees on Appropriations, Environmental Preservation and Conservation, Senator Grimsley and others—

Pollution; Citing this act as the "Public Notice of Pollution Act"; defining the term "reportable pollution release"; requiring an owner or operator of an installation at which a reportable pollution release occurred to provide certain information to the department within 24 hours after the discovery of the release; creating the State Watch Office within the Division of Emergency Management, etc. Effective Date: 07/01/2017

Read the second time and amended on April 28, 2017

HB 1239 (3R) by Representative Eagle and others—

School Bus Safety; Provides for mandatory noncriminal penalties, fine, driver license suspension, & driver license points for certain violations resulting in serious bodily injury to/death of another person. Effective Date: 07/01/2017

Substituted for SB 1622(SUB) (Passidomo) and read the second time on April 28, 2017

SB 892 (SO) by Senator Simmons—

Youthful Offenders; Revising the criteria allowing a court to sentence as a youthful offender a person who is found guilty of, or who pled nolo contendere or guilty to, committing a felony before the person turned 21 years of age, etc. Effective Date: 07/01/2017

Reported favorably by the Committee on Criminal Justice; recommended favorably by Appropriations Subcommittee on Criminal and Civil Justice; and reported favorably by the Committee on Appropriations

SB 7014 (SO) by the Committee on Agriculture (Perry)—

OGSR/Nonpublished Reports or Data/Department of Citrus; Amending provisions relating to an exemption from public records requirements for nonpublished reports or data related to certain studies or research related to citrus fruit, citrus fruit juices, and the products and byproducts thereof which is conducted, caused to be conducted, or funded by the Department of Citrus; abrogating the scheduled repeal of the exemption, etc. Effective Date: 10/01/2017

Reported favorably by the Committee on Governmental Oversight and Accountability; and reported favorably by the Committee on Rules

*Identical to **HB 7035(HC)** in the Committees on Agriculture; Governmental Oversight and Accountability; and Rules*

SB 1050 (SO) by Senator Simmons—

Memory Disorder Clinics; Establishing a memory disorder clinic at Florida Hospital in Orange County, etc. Effective Date: 07/01/2017

Reported favorably by the Committee on Health Policy; recommended favorably by Appropriations Subcommittee on Health and Human Services; and reported favorably by the Committee on Appropriations

*Similar to **HB 883(HC)** in the Committees on Health Policy; Appropriations Subcommittee on Health and Human Services; and Appropriations*

CS/SB 1156 (SO) by the Committee on Appropriations and Senator Stargel—

Corporate Income Tax; Adopting the 2017 version of the Internal Revenue Code; extending the extension to file a corporate return under certain circumstances; revising the filing date for estimated tax under certain circumstances, etc. Effective Date: Upon becoming a law

Recommended favorably by Appropriations Subcommittee on Finance and Tax; and reported favorably as a committee substitute by the Committee on Appropriations

*Similar to **HB 7099(HC)** in the Committee on Appropriations*

CS/SB 48 (SO) by the Committee on Judiciary and Senator Braynon—

Relief of Wendy Smith and Dennis Darling, Sr./Florida State University; Providing for the relief of Wendy Smith and Dennis Darling, Sr., parents of Devaughn Darling, deceased; providing an appropriation to compensate the parents for the loss of their son, Devaughn Darling, whose death occurred while he was engaged in football preseason training on the Florida State University campus, etc. Effective Date: Upon becoming a law

Recommended favorably by the Special Master on Claim Bills; reported favorably as a committee substitute by the Committee on Judiciary; Appropriations Subcommittee on Higher Education recommends the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably

CS/CS/CS/SB 190 (SO) by the Committees on Rules, Community Affairs, Regulated Industries and Senator Perry—

Alarm Systems; Providing an exclusion from the requirement for a verification call prior to alarm dispatch for specified premises under certain circumstances; redefining the term "low-voltage alarm system project" to include low-voltage electric fences; providing requirements for a low-voltage electric fence to be permitted as a low-voltage alarm system project, etc. Effective Date: 07/01/2017

Reported favorably as a committee substitute by the Committee on Regulated Industries; reported favorably as a committee substitute by the Committee on Community Affairs; and reported favorably as a committee substitute by the Committee on Rules

CS/CS/SB 264 (SO) by the Committees on Rules, Judiciary and Senator Perry—

Self-storage; Providing that a lien sale may be conducted on certain websites; providing that a self-storage facility owner is not required to have a license to post property for online sale; authorizing an owner to impose and collect a late fee from a tenant under certain circumstances; authorizing an owner to charge the tenant certain reasonable expenses incurred in rent collection or lien enforcement, etc. Effective Date: 07/01/2017

Reported favorably as a committee substitute by the Committee on Judiciary; the Committee on Regulated Industries reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Rules

*Similar to **CS/CS/HB 357(HC)** in the Committees on Judiciary; Regulated Industries; and Rules*

CS/SB 360 (SO) by the Committee on Appropriations, Senator Stargel and others—

Middle School Study; Requiring the Department of Education to solicit for a contract to conduct a comprehensive study of states with nationally recognized high-performing middle schools in reading and mathematics; specifying areas that must be reviewed in conducting the study, etc. Effective Date: 07/01/2017

Reported favorably by the Committee on Education; recommended favorably as a committee substitute by Appropriations Subcommittee on Pre-K - 12 Education; and reported favorably as a committee substitute by the Committee on Appropriations

*Compare to **CS/CS/HB 293(HC)** in the Committees on Education; and Appropriations*

CS/CS/SB 590 (SO) by the Committees on Appropriations, Judiciary, Senator Brandes and others—
