Juvenile Justice; Requiring the Department of Health to waive fees for a birth certificate issued to certain juvenile offenders; providing an additional circumstance under which the court may order continued detention; requiring the court to place a prolific juvenile offender in certain detention care under a special detention order until disposition; revising the circumstances under which an adjudication of delinquency for a felony disqualifies a person from possessing a firearm, etc. Effective Date: 10/01/2017

CS/SB 1238, 1st Eng. (3R) by the Committee on Rules and Senator Bean—

Utility Investments in Gas Reserves; Revising the jurisdiction of the Public Service Commission over public utilities to include the approval of cost recovery for certain gas reserve investments; requiring each public utility to file with the commission a comparison of all gas reserve projects entered into on behalf of the utility and any affiliate or subsidiary of the parent company as part of its risk management plan; requiring the use of a third-party auditor for audits of associated transactions for a gas reserve project, etc. Effective Date: 07/01/2017

SB 892 (3R) by Senator Simmons—

Youthful Offenders; Revising the criteria allowing a court to sentence as a youthful offender a person who is found guilty of, or who pled nolo contendere or guilty to, committing a felony before the person turned 21 years of age, etc. Effective Date: 07/01/2017

Memory Disorder Clinics; Establishes memory disorder clinic at Florida Hospital in Orange County. Effective Date: 07/01/2017

HB 7099 (3R) by the Committee on Ways and Means Committee and Representative Cortes, B.—

Corporate Income Tax; Adopts 2017 version of Internal Revenue Code; provides retroactive operation. Effective Date: Upon becoming a law

Substituted for CS/SB 1156(SUB) (Stargel), read the second time, and amended on May 1, 2017

CS/CS/HB 6515 (3R) by the Committees on Appropriations Committee, Civil Justice and Claims Subcommittee, Representative Jones and others—

Relief/Wendy Smith and Dennis Darling, Sr./State of Florida; Provides appropriation to compensate Wendy Smith & Dennis Darling, Sr., for death of son Devaughn Darling during preseason training on FSU campus; provides limitation on payment of fees & costs. Effective Date: Upon becoming a law

Low-voltage Electric Fences; Revises definition of term "low-voltage alarm system project"; provides definition for term "low-voltage electric fence"; provides requirements for low-voltage electric fence to be permitted as low-voltage alarm system project. Effective Date: 07/01/2017

CS/CS/HB 357 (3R) by the Committees on Civil Justice and Claims Subcommittee, Careers and Competition Subcommittee and Representative Moraitis—

Self-Service Storage Facilities; Provides that lien sale may be conducted on certain websites; provides that facility or unit owner is not required to hold license to post property for online sale; limits maximum value of certain property; provides options for disposition of motor vehicles or watercraft claimed to be subject to lien; authorizes facility or unit owner to charge tenant certain fees under certain conditions. Effective Date: 07/01/2017

SB 1024 (3R) by Senator Stewart—
