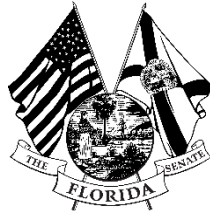

### BILLS ON THIRD READING

#### **CS/SB 1238, 1st Eng. (3R) by the Committee on Rules and Senator Bean—**

**Utility Investments in Gas Reserves;** Revising the jurisdiction of the Public Service Commission over public utilities to include the approval of cost recovery for certain gas reserve investments; requiring each public utility to file with the commission a comparison of all gas reserve projects entered into on behalf of the utility and any affiliate or subsidiary of the parent company as part of its risk management plan; requiring the use of a third-party auditor for audits of associated transactions for a gas reserve project, etc. Effective Date: 07/01/2017

*Read the second time and amended on April 28, 2017*

#### **CS/CS/HB 467 (3R) by the Committees on Commerce Committee, Agriculture and Property Rights Subcommittee, Representative Raburn and others—**

**Department of Agriculture and Consumer Services;** Revises & repeals provisions relating to agriculture education & promotion facilities, surveyors & mappers, pesticides & devices, private investigative agencies, health studios, telephone solicitation, taximeters & transportation measurement systems, livestock, marketing & inspection of agricultural commodities, Florida Building Code & Florida Forest Service facilities, & aquaculture & agriculture dealers & producers; revises requirements for obtaining & reducing fees for concealed weapon or firearm license. Effective Date: 07/01/2017

*Substituted for CS/CS/CS/SB 498(SUB) (Young) and read the second time on May 2, 2017*

#### **CS/CS/HB 169 (3R) by the Committees on Commerce Committee, Careers and Competition Subcommittee and Representative White—**

**Fictitious Name Registration;** Revises information required to register fictitious name; revises requirements for change in registration; revises provisions concerning expiration of registration; prohibits renewal of registration if registered fictitious name is prohibited by specified provisions; specifies additional forms of business organization that may not be required to register; revises provisions concerning penalties for violations; specifies additional terms that may not be included in fictitious name. Effective Date: 07/01/2017

*Substituted for CS/CS/CS/SB 346(SUB) (Stargel) and read the second time on May 2, 2017*

---

#### **CS/HB 6539 (3R) by the Committee on Civil Justice and Claims Subcommittee and Representative Byrd—**

**Relief/Eddie Weekley and Charlotte Williams/Agency for Persons with Disabilities;** Provides appropriation from APD to compensate Eddie Weekley & Charlotte Williams for disappearance & death of son Franklin Weekley due to negligence of DCF; provides limitation on payment of fees & costs. Effective Date: Upon becoming a law

*Substituted for CS/SB 50(SUB) (Gibson) and read the second time on May 2, 2017*

---

#### **CS/HB 6521 (3R) by the Committee on Civil Justice and Claims Subcommittee and Representative Jenne—**

**Relief/Mary Mifflin-Gee/City of Miami;** Provides appropriation from City of Miami to compensate Mary Mifflin-Gee for injuries & damages sustained as result of negligence of city employees; provides limitation on payment of compensation, fees, & costs. Effective Date: Upon becoming a law

*Substituted for CS/SB 46(SUB) (Montford) and read the second time on May 2, 2017*

**CS/HB 6507 (3R) by the Committee on Civil Justice and Claims Subcommittee and Representative Beshears—**

**Relief/Angela Sanford/Leon County;** Provides for appropriation to compensate Angela Sanford for injuries & damages sustained as result of negligence of Leon County employee; provides that certain payments & appropriation satisfy all present & future claims related to negligent act; provides limitation on payment of compensation, fees, & costs. Effective Date: Upon becoming a law

*Substituted for **CS/SB 42(SUB)** (Montford) and read the second time on May 2, 2017*

---

**HB 299 (3R) by Representative Goodson—**

**Central Florida Expressway Authority;** Increases membership of Central Florida Expressway Authority to include member appointed by chair of Brevard County Commission; authorizes Governor to appoint citizen member from Brevard County; adds area within geographical boundary of Brevard County to area to be served by authority; conforms provisions. Effective Date: 07/01/2017

*Substituted for **SB 720(SUB)** (Mayfield) and read the second time on May 2, 2017*

---

**CS/CS/HB 925, 1st Eng. (3R) by the Committees on Commerce Committee, Insurance and Banking Subcommittee, Representatives Miller, M., Plakon and others—**

**Department of Financial Services;** Replacing, within the Division of Treasury, the Treasury Investment Committee with the Treasury Investment Council; requiring certification of boiler inspectors; providing an exemption from the nonresident examination requirement for certain all-lines adjusters; authorizing certain insurer employees to adjust specified claim losses or damage; revising the residency requirement for certain directors of a bank or trust company; repealing provisions relating to the disposition of certain money paid into a court which is unclaimed, etc. Effective Date: 07/01/2017

*Substituted for **CS/CS/SB 986(SUB)** (Stargel), read the second time, and amended on May 2, 2017*

---

**HB 6021 (3R) by Representative Rommel—**

**Home Health Agency Licensure;** Repeals provision prohibiting AHCA from issuing initial license to applicant for home health agency license which is located within 10 miles of licensed home health agency that has common controlling interests. Effective Date: 07/01/2017

*Substituted for **SB 1056(SUB)** (Garcia) and read the second time on May 2, 2017*

---

**CS/HB 477 (3R) by the Committee on Criminal Justice Subcommittee, Representative Boyd and others—**

**Controlled Substances;** Provides that certain crime laboratory personnel may possess, store, & administer emergency opioid antagonists; provides that unlawful distribution of specified controlled substances & analogs or mixtures thereof which proximately cause death is murder; adds certain synthetic opioid substitute compounds to Schedule I; prohibits possession of more than 10 grams of specified substances; revises substances that constitute certain trafficking offenses; creates certain trafficking offenses; provides specified minimum terms of imprisonment & fines based on quantity involved in for certain offenses. Effective Date: 10/01/2017

*Substituted for **CS/CS/CS/SB 150(SUB)** (Steube), read the second time, and amended on May 2, 2017*

---

**CS/HB 181 (3R) by the Committee on Appropriations Committee and Representative Jacobs—**

**Natural Hazards;** Creates interagency workgroup to share information, coordinate efforts, & collaborate on initiatives relating to natural hazards; requires certain agencies to designate liaisons to the workgroup; requires the Division of Emergency Management to prepare annual report; requires report to be posted on agency websites & submitted to the Governor & Legislature; providing an appropriation. Effective Date: 07/01/2017

*Substituted for **SB 464(SUB)** (Clemens) and read the second time on May 2, 2017*

---

**CS/CS/HB 813, 1st Eng. (3R) by the Committees on Commerce Committee, Insurance and Banking Subcommittee and Representative Lee—**

**Flood Insurance;** Revises intervals at which specified standards & guidelines must be revised by Florida Commission on Hurricane Loss Projection Methodology; authorizes certain insurers to issue insurance policies, contracts, or endorsements providing excess coverage for peril of flood & to issue flood & excess flood insurance policies, contracts, or endorsements on flexible basis; specifies condition for surplus lines agent to be exempt from diligent-effort requirement under certain circumstances; requires agents to provide written notice under certain circumstances. Effective Date: 07/01/2017

*Substituted for **CS/CS/SB 420(SUB)** (Brandes), read the second time, and amended on May 2, 2017*

---

**HB 6027 (3R) by Representative Williamson—**

**Financial Reporting;** Deletes provision authorizing certain associations to prepare report of cash receipts & expenditures in lieu of specified financial statements; deletes provision prohibiting condominium & cooperative associations from waiving certain financial reporting requirements. Effective Date: 07/01/2017

*Substituted for **CS/SB 294(SUB)** (Bracy) and read the second time on May 2, 2017*

---

**CS/CS/HB 435, 1st Eng. (3R) by the Committees on Commerce Committee, Insurance and Banking Subcommittee, Representative Raulerson and others—**

**International Financial Institutions;** Revises requirements for confidential books & records of financial institutions that must be made available for inspection & examination; revises applicability of the financial institutions codes as to international banking corporations; revises requirements for carrying on financial institution business; provides requirements for carrying on international financial business; provides requirements relating to international trust company representative offices, including licensure, recordkeeping, representative offices, permissible activities, liability, claims, & fees; provides requirements relating to qualified limited service affiliates of international trust entities, including permissible activities, registration, recordkeeping, & examinations; provides responsibilities of OFR & FSC. Effective Date: 01/01/2018

*Substituted for **CS/CS/SB 736(SUB)** (Mayfield) and read the second time on May 2, 2017*

---

**CS/CS/HB 437 (3R) by the Committees on Commerce Committee, Insurance and Banking Subcommittee and Representative Raulerson—**

**Pub. Rec./International Financial Institutions;** Provides exemptions from public records requirements for certain information held by OFR relating to international trust company representative offices, qualified limited service affiliates, & affiliated international trust entities; authorizes disclosure of information by office to specified persons; provides criminal penalties; provides future legislative review & repeal of exemptions; provides that certain exemptions from public records requirements for information relating to investigations, reports of examinations, operations, or condition, including working papers, & certain materials supplied by governmental agencies are exempt; provides statement of public necessity. Effective Date: On the same date that CS/CS/HB 435 or similar legislation takes effect

**CS/CS/HB 837 (3R) by the Committees on Commerce Committee, Insurance and Banking Subcommittee and Representative Raburn—**

**Insurer Insolvency;** Revises Insurers Rehabilitation & Liquidation Act; revises notice requirements, court jurisdiction, filing requirements, procedures, & defenses of delinquency proceedings; authorizes receiver & DFS, as domiciliary receiver, to perform certain functions; provides delinquency procedures for specified large deductible claims under certain workers' compensation policies; provides certain persons of insolvent insurers are discharged & have no further authority over affairs or assets of insurer; revises priority of claims. Effective Date: 07/01/2017

*Substituted for **CS/CS/SB 730(SUB)** (Passidomo) and read the second time on May 2, 2017*

**CS/CS/HB 249, 1st Eng. (3R) by the Committees on Health and Human Services Committee, Health Quality Subcommittee, Representatives Rommel, Lee and others—**

**Drug Overdoses;** Permitting certain entities to report controlled substance overdoses to the Department of Health; providing immunity for persons who make reports in good faith; requiring a hospital with an emergency department to develop a best practices policy to promote the prevention of unintentional drug overdoses, etc. Effective Date: 10/01/2017

*Substituted for **CS/CS/CS/SB 588(SUB)** (Passidomo) and read the second time on May 2, 2017*

---

**HB 7091 (3R) by the Committee on Criminal Justice Subcommittee and Representative Altman—**

**Probation and Community Control;** Revises offenses that render offender ineligible for administrative probation; redesignates & deletes various terms; revises facilities at which incarceration may be served; authorizes, rather than requires, court to order offender to make good faith effort toward educational goals in certain circumstances; revises list of offenders required to pay DOC monthly sum; requires, rather than authorizes, DOC to electronically monitor offenders sentenced to community control. Effective Date: 07/01/2017

*Substituted for **CS/CS/SB 790(SUB)** (Brandes) and read the second time on May 2, 2017*

---

**CS/CS/SB 744, 1st Eng. (3R) by the Committees on Judiciary, Regulated Industries and Senator Passidomo—**

**Community Associations;** Requiring certain condominium or cooperative associations to post certain signs or symbols on buildings; prohibiting an officer, director, or manager from soliciting, offering to accept, or accepting a kickback for which consideration has not been provided; revising voting requirements relating to alterations and additions to certain common elements or association property; revising provisions relating to required condominium and cooperative association bylaws, etc. Effective Date: 07/01/2017

*Read the second time and amended on May 2, 2017*

*Similar to **CS/CS/CS/HB 653, 2nd Eng.(HC)** in the Committee on Rules*

---

**HB 1203 (3R) by Representative Gonzalez—**

**Pub. Rec./DOC/Health Information;** Provides that certain protected health information held by DOC is confidential & exempt from public records requirements; authorizes release of protected health information & other records of an inmate to certain entities, subject to specified conditions and; provides statement of public necessity. Effective Date: On the same date that HB 1201 or similar legislation takes effect

*Substituted for **CS/SB 1526(SUB)** (Bracy) and read the second time on May 2, 2017*

**CS/HB 1269 (3R) by the Committee on Health Quality Subcommittee and Representative Harrell—**

**Child Protection;** Revises entities responsible for screening, employing, & terminating child protection team medical directors; revises terms; revises subdivision of state from districts to circuits for purpose of child protection teams; revises required board certifications for certain entities; revises timeframe in which child protection team medical directors must obtain certification; requires Children's Medical Services to convene task force to develop protocol for forensic interviewing of children suspected of having been abused; revises provisions regarding expert testimony provided by certain entities. Effective Date: 07/01/2017

*Substituted for CS/SB's 1318 & 1454(SUB) (Broxson) and read the second time on May 2, 2017*

---

**CS/CS/HB 981 (3R) by the Committees on Health and Human Services Committee, Children, Families and Seniors Subcommittee and Representative Gonzalez—**

**Pub. Rec./Department of Elderly Affairs;** Provides exemption from public records requirements for certain identifying information of complainants & wards held by Department of Elderly Affairs; provides applicability; provides for future legislative review & repeal of exemption; provides statement of public necessity. Effective Date: 07/01/2017

*Substituted for SB 1408(SUB) (Broxson) and read the second time on May 2, 2017*

---

**HB 7093 (3R) by the Committee on Oversight, Transparency and Administration Subcommittee and Representative Daniels—**

**OGSR/Agency Personnel Information;** Revises exemptions from public record requirements for certain personal identifying & location information of specified agency personnel & spouses & children thereof; removes scheduled repeal of certain exemptions; provides for retroactive application; provides for future legislative review & repeal of certain exemptions; provides statements of public necessity. Effective Date: 10/01/2017

*Substituted for CS/SB 7018(SUB) (Baxley) and read the second time on May 2, 2017*

---

**HB 65 (3R) by Representatives Fischer, White and others—**

**Civil Remedies for Terrorism;** Creates cause of action relating to terrorism; specifies measure of damages; prohibits claims by specified individuals; provides for attorney fees & court costs; provides construction. Effective Date: 07/01/2017

*Substituted for SB 898(SUB) (Simmons) and read the second time on May 2, 2017*

---

**CS/CS/HB 747 (3R) by the Committees on Commerce Committee, Insurance and Banking Subcommittee and Representative Stark—**

**Mortgage Brokering;** Provides exemption from regulation under parts I & II of ch. 494, F.S., for certain securities dealers, investment advisors, & associated persons. Effective Date: 07/01/2017

*Substituted for CS/CS/SB 830(SUB) (Baxley), read the second time, and amended on May 2, 2017*

---

**CS/CS/HB 229, 1st Eng. (3R) by the Committees on Health and Human Services Committee, Health Quality Subcommittee, Representative Byrd and others—**

**Health Care Practitioner Licensure;** Revises provisions related to impaired practitioner programs; requires DOH to establish terms & conditions of program by contract; provides contract terms; requires DOH to refer practitioners to consultants; revises grounds for refusing to issue or renew license, certificate, or registration in health care profession. Effective Date: Upon becoming a law

*Substituted for CS/CS/SB 876(SUB) (Young) and read the second time on May 2, 2017*

---

**HB 7087 (3R) by the Committee on Oversight, Transparency and Administration Subcommittee, Representative Davis and others—**

**OGSR/Protective Injunctions for Certain Types of Violence;** Extends repeal dates for exemptions from public record requirements for personal identifying & location information of petitioner requesting notification of service of injunction for protection against domestic violence, repeat violence, sexual violence, & dating violence & other court actions related to injunction held by clerks & law enforcement agencies. Effective Date: 10/01/2017

*Substituted for SB 7028(SUB) (Steube) and read the second time on May 2, 2017*

---

**CS/CS/HB 421 (3R) by the Committees on Commerce Committee, Insurance and Banking Subcommittee and Representative Shaw—**

**Public Housing Authority Insurance;** Authorizes certain entities to join self-insurance funds participated in by public housing authorities for specified purpose; authorizes reinsurance companies to issue coverage directly to certain entities; requires contracts issued to such entities to receive same tax treatment as contracts issued to insurance companies. Effective Date: 07/01/2017

*Substituted for CS/SB 850(SUB) (Rouson) and read the second time on May 2, 2017*

---

**CS/HB 7047 (3R) by the Committees on Commerce Committee, Careers and Competition Subcommittee and Representative Beshears—**

**Deregulation of Professions and Occupations;** Removes regulations on specified DBPR professions, including labor organizations, hair braiders, hair wrappers & body wrappers, & boxing timekeepers & announcers; revises certain requirements for barbers, nail specialists, business organizations that provide architecture services and interior design, landscape architects, & geologists. Effective Date: 07/01/2017

*Substituted for **CS/CS/SB 802(SUB)** (Passidomo), read the second time, and amended on May 2, 2017*

**SPECIAL ORDER CALENDAR FOR

**CS/SB 1626 (SO) by the Committee on Criminal Justice and Senator Bradley—**

**Department of Legal Affairs;** Authorizing the Statewide Council on Human Trafficking to apply for and accept funds, grants, gifts, and services from various governmental entities or any other public or private source for a specified purpose; providing that the Attorney General has standing to assert the rights of certain qualified beneficiaries in judicial proceedings; revising the conditions under which a trustee may amend the governing instrument of a specified charitable trust to comply with specified provisions of ch. 736, F.S., etc. Effective Date: 07/01/2017

*Reported favorably as a committee substitute by the Committee on Criminal Justice; Appropriations Subcommittee on Criminal and Civil Justice recommends the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably*

*Similar to **CS/HB 1379(HC)** in the Committees on Criminal Justice; Appropriations Subcommittee on Criminal and Civil Justice; and Appropriations*

---

**CS/SB 7020 (SO) by the Committees on Rules, and Children, Families, and Elder Affairs (Garcia)—**

**Ratification of a Department of Elder Affairs Rule and a Department of Health Rule;** Ratifying a specific rule relating to the practice for professional guardians; ratifying a specific rule adopted by the Board of Medicine relating to the standard of care for office surgery for the sole and exclusive purpose of satisfying any condition on effectiveness pursuant to provisions which require ratification of any rule exceeding the specified thresholds for likely adverse impact or increase in regulatory costs, etc. Effective Date: Upon becoming law

*Reported favorably as a committee substitute by the Committee on Rules*

*Similar to **HB 7073(HC)** in the Committee on Rules*

---

**CS/SB 328 (SO) by the Committee on Health Policy, Senator Grimsley and others—**

**Regulation of Nursing;** Removing an obsolete qualification no longer sufficient to satisfy certain nursing certification requirements; authorizing the Board of Nursing to conduct certain on-site evaluations; removing a requirement that certain nursing program graduates complete a specific preparatory course; providing that a name change or the creation of a new educational institution does not reduce the waiting period for reapplication, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect July 1, 2017

*Reported favorably as a committee substitute by the Committee on Health Policy; the Committee on Education reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably*

*Compare to **CS/CS/HB 543, 1st Eng.(HC)** in the Committees on Health Policy; and Rules*

---

**CS/SB 714 (SO) by the Committee on Appropriations and Senator Garcia—**

**Comprehensive Transitional Education Programs;** Authorizing the Agency for Persons with Disabilities to petition a court for the appointment of a receiver for a comprehensive transitional education program under certain circumstances, etc. Effective Date: Upon becoming a law

*Reported favorably by the Committee on Children, Families, and Elder Affairs; recommended favorably as a committee substitute by Appropriations Subcommittee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Appropriations*
