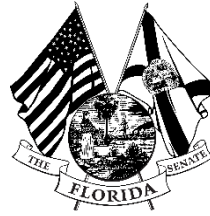

## BILLS ON THIRD READING

### **CS/HB 85, 1st Eng. (3R) by the Committee on Public Integrity and Ethics Committee, Representative Spano and others—**

**Voter Registration List Maintenance;** Authorizes DOS to become member of nongovernmental entity to verify voter registration information; establishes requirements for such memberships; requires DHSMV to provide specified information to DOS; establishes reporting requirements. Effective Date: 01/01/2019

*Substituted for **CS/SB 276(SUB)** (Hutson) and read the second time on February 8, 2018*

### **SB 800 (3R) by Senator Braynon and others—**

**Infectious Disease Elimination Pilot Programs;** Citing this act as the "Florida Infectious Disease Elimination Act (IDEA)"; authorizing the Department of Health to establish sterile needle and syringe exchange pilot programs upon request from eligible entities, rather than a single program established in Miami-Dade County, etc. Effective Date: 07/01/2018

### **HB 193 (3R) by Representative Stark—**

**Mortgage Brokering;** Provides exemption from regulation under parts I & II of ch. 494, F.S., for certain securities dealers, investment advisors, & associated persons; provides requirements for certain solicitations & referrals. Effective Date: 07/01/2018

*Substituted for **SB 314(SUB)** (Baxley) and read the second time on February 8, 2018*

### **CS/CS/SB 510 (3R) by the Committees on Rules, Health Policy, Senator Young and others—**

**Reporting of Adverse Incidents in Planned out-of-hospital Births;** Defining the term "adverse incident"; requiring licensed physicians, certified nurse midwives, and licensed midwives to report an adverse incident and a medical summary of events to the Department of Health within a specified timeframe; requiring the department to review adverse incident reports and determine if conduct occurred that is subject to disciplinary action, etc. Effective Date: Upon becoming a law

### **SB 162 (3R) by Senator Steube and others—**

**Payment of Health Care Claims;** Prohibiting a health insurer or a health maintenance organization from retroactively denying a claim under specified circumstances, etc. Effective Date: 07/01/2018

### **HB 405 (3R) by Representatives Williamson and Payne—**

**Linear Facilities;** Revises definition of "development" to exclude certain utility work on rights-of-way or corridors & creation or termination of distribution & transmission corridors; requires DEP to consider certain variance standard for certification of power plants & transmission corridors; specifies PSC authority to locate transmission lines underground. Effective Date: Upon becoming a law

*Substituted for **SB 494(SUB)** (Lee) and read the second time on February 8, 2018*

### **CS/SB 1048 (3R) by the Committee on Judiciary, Senator Baxley and others—**

**Firearms;** Authorizing a church, a synagogue, or other religious institution to allow a concealed weapons or concealed firearms licensee to carry a concealed handgun in certain established physical places of worship under certain circumstances, etc. Effective Date: Upon becoming a law

### **CS/HB 87 (3R) by the Committee on Public Integrity and Ethics Committee, Representative Spano and others—**

**Pub.Rec./Statewide Voter Registration System;** Provides exemption from public records requirements for certain information received by DOS from another state or District of Columbia which is confidential or exempt pursuant to laws of that jurisdiction; provides for release of such information to specified persons; provides for future legislative review & repeal of the exemption; provides statement of public necessity. Effective Date: On the same date that CS/HB 85 or similar legislation takes effect

### **SB 660, 1st Eng. (3R) by Senator Brandes—**

**Florida Insurance Code Exemption for Nonprofit Religious Organizations;** Revising criteria under which a nonprofit religious organization that facilitates the sharing of contributions among its participants for financial, physical, or medical needs is exempt from requirements of the code, etc. Effective Date: 07/01/2018

*Read the second time and amended on February 8, 2018*

**CS/HB 55 (3R) by the Committee on Oversight, Transparency and Administration Subcommittee, Representative White and others—**

**Sale of Firearms;** Requires FDLE procedures to allow payment or transmittal of processing fees for criminal history checks of potential firearms buyers by electronic means; provides that criminal history check requests may be made by electronic means. Effective Date: 10/01/2018

*Substituted for CS/SB 152(SUB) (Steube) and read the second time on February 8, 2018*

**CS/SB 52 (2R) by the Committee on Judiciary and Senator Mayfield—**

**Relief of Cathleen Smiley by Brevard County;** Providing for the relief of Cathleen Smiley by Brevard County; providing for an appropriation to compensate Cathleen Smiley for personal injuries and damages sustained in an automobile accident caused by a Brevard County employee, etc. Effective Date: Upon becoming a law

*Recommended favorably, with one amendment, by the Special Master on Claim Bills; reported favorably as a committee substitute by the Committee on Judiciary; the Committee on Governmental Oversight and Accountability reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably*

**SB 100 (2R) by Senator Steube—**

**Identification Card and Driver License Fees for Veterans;** Deleting fees for adding the word "Veteran" to an identification card or a driver license; revising acceptable forms of identification required to add the word "Veteran" to an identification card or a driver license; prohibiting tax collectors from charging certain driver license service fees to veterans who present specified forms of identification, etc. Effective Date: 07/01/2018

*Reported favorably by the Committee on Military and Veterans Affairs, Space, and Domestic Security; recommended favorably by Appropriations Subcommittee on Transportation, Tourism, and Economic Development; and reported favorably by the Committee on Appropriations*

**CS/SB 160 (2R) by the Committee on Appropriations and Senator Bean—**

**Specialty License Plates;** Deleting the annual use fee for the Donate Organs-Pass It On license plate; establishing an annual use fee for certain specialty license plates; requiring the Department of Highway Safety and Motor Vehicles to develop certain specialty license plates, etc. Effective Date: 10/01/2018

*Reported favorably by the Committee on Transportation; recommended favorably as a committee substitute by Appropriations Subcommittee on Transportation, Tourism, and Economic Development; and reported favorably as a committee substitute by the Committee on Appropriations*

**SB 168 (2R) by Senator Steube—**

**Nonnative Animals;** Requiring the Fish and Wildlife Conservation Commission to establish a pilot program for the eradication of priority invasive species; specifying procedures for the capture and disposal of animals that belong to priority invasive species; requiring animals that belong to certain nonnative species to be implanted with a passive integrated transponder tag before sale, resale, or being offered for sale by a pet dealer, etc. Effective Date: 07/01/2018

*Reported favorably by the Committee on Environmental Preservation and Conservation; recommended favorably by Appropriations Subcommittee on the Environment and Natural Resources; and reported favorably by the Committee on Appropriations*

**CS/SB 174 (2R) by the Committee on Appropriations, Senator Hukill and others—**

**Coastal Management;** Revising the criteria to be considered by the Department of Environmental Protection in determining and assigning annual funding priorities for beach management and erosion control projects; requiring that certain projects be considered separate and apart from other specified projects; revising requirements for the comprehensive long-term management plan, etc. Effective Date: Except as otherwise provided in this act, this act shall take effect July 1, 2018

*Reported favorably by the Committee on Environmental Preservation and Conservation; recommended favorably by Appropriations Subcommittee on the Environment and Natural Resources; and reported favorably as a committee substitute by the Committee on Appropriations*

**SCR 184 (2R) by Senator Thurston and others—**

**Joint Committee on the Library of Congress/Statue Replacement Approval;** Requesting the Joint Committee on the Library of Congress to approve the replacement of the statue of Confederate General Edmund Kirby Smith in the National Statuary Hall Collection with a statue of Mary McLeod Bethune, etc.

*Reported favorably by the Committee on Appropriations; and reported favorably by the Committee on Rules*

**CS/CS/CS/SB 268 (2R) by the Committees on Rules, Governmental Oversight and Accountability, Children, Families, and Elder Affairs and Senator Passidomo—**

**Public Records/Public Guardians/Employees with Fiduciary Responsibility;** Providing an exemption from public records requirements for certain identifying and location information of current or former public guardians, employees with fiduciary responsibility, and the spouses and children thereof; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: 07/01/2018

*Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and reported favorably as a committee substitute by the Committee on Rules*

**SB 286 (2R) by Senator Rouson and others—**

**Florida Slavery Memorial;** Establishing the Florida Slavery Memorial; providing for administration of the memorial by the Department of Management Services; directing the department to develop a specified plan for the design, placement, and cost of the memorial and submit the plan to the Governor and Legislature, etc. Effective Date: 07/01/2018

*Reported favorably by the Committee on Governmental Oversight and Accountability; recommended favorably by Appropriations Subcommittee on General Government; and reported favorably by the Committee on Appropriations*

**CS/SB 290 (2R) by the Committee on Appropriations, Senator Rouson and others—**

**Motor Vehicle Registration Applications;** Requiring the application form for motor vehicle registration to include language to indicate an applicant is deaf or hard of hearing; requiring such information to be included in certain databases, etc. Effective Date: 10/01/2018

*Reported favorably by the Committee on Transportation; recommended favorably as a committee substitute by Appropriations Subcommittee on Transportation, Tourism, and Economic Development; and reported favorably as a committee substitute by the Committee on Appropriations*

**CS/SB 298 (2R) by the Committee on Criminal Justice and Senator Bracy—**

**Criminal History Records;** Revising the elements that must be attested to by a petitioner in a statement submitted in support of the expunction of a criminal history record; revising the elements that must be attested to by a petitioner in a statement submitted in support of the sealing of a criminal history record; revising the circumstances under which the Department of Law Enforcement must issue a certificate of eligibility for sealing of a criminal history record, etc. Effective Date: 07/01/2018

*Reported favorably as a committee substitute by the Committee on Criminal Justice; the Committee on Judiciary reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably*

**CS/SB 330 (2R) by the Committee on Appropriations and Senator Gainer—**

**Transportation Facility Designations/Lieutenant Ewart T. Sconiers Highway;** Providing an honorary designation of a certain transportation facility in a specified county, etc. Effective Date: Upon becoming a law
