Infectious Disease Elimination Pilot Programs; Citing this act as the "Florida Infectious Disease Elimination Act (IDEA)"; authorizing the Department of Health to establish sterile needle and syringe exchange pilot programs upon request from eligible entities, rather than a single program established in Miami-Dade County, etc. Effective Date: 07/01/2018

SB 162 (3R) by Senator Steube and others—

Payment of Health Care Claims; Prohibiting a health insurer or a health maintenance organization from retroactively denying a claim under specified circumstances, etc. Effective Date: 07/01/2018

Read the second time on February 8, 2018

CS/SB 1048 (3R) by the Committee on Judiciary, Senator Baxley and others—

Firearms; Authorizing a church, a synagogue, or other religious institution to allow a concealed weapons or concealed firearms licensee to carry a concealed handgun in certain established physical places of worship under certain circumstances, etc. Effective Date: Upon becoming a law

Read the second time on February 8, 2018

CS/HB 55 (3R) by the Committee on Oversight, Transparency and Administration Subcommittee, Representative White and others—

Sale of Firearms; Requires FDLE procedures to allow payment or transmittal of processing fees for criminal history checks of potential firearms buyers by electronic means; provides that criminal history check requests may be made by electronic means. Effective Date: 10/01/2018

SB 1078 (3R) by Senator Perry—

Public Records/United States Census Bureau; Creating an exemption from public records requirements for specified United States Census Bureau address information held by an agency; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: Upon becoming a law

HB 75 (3R) by Representative Ponder and others—

Postsecondary Fee Waivers; Authorizes FCS institutions to waive portion of certain postsecondary fees for active duty members of U.S. Armed Forces using military tuition assistance; requires FCS institutions to report to SBE number & value of such fee waivers granted annually. Effective Date: 07/01/2018

Substituted for SB 460(SUB) (Gainer) and read the second time on February 27, 2018

SB 100 (3R) by Senator Steube—

Identification Card and Driver License Fees for Veterans; Deleting fees for adding the word "Veteran" to an identification card or a driver license; revising acceptable forms of identification required to add the word "Veteran" to an identification card or a driver license; prohibiting tax collectors from charging certain driver license service fees to veterans who present specified forms of identification, etc. Effective Date: 07/01/2018

Read the second time on February 27, 2018

SB 440, 1st Eng. (3R) by Senator Garcia and others—

Florida Veterans Care Program; Creating the program within the Department of Veterans' Affairs; authorizing the department, the Agency for Health Care Administration, and the Department of Children and Families to jointly negotiate with federal agencies in order to seek federal funding for the program; prohibiting the use of state funds to support the program; providing that the act does not affect a person's eligibility for the state Medicaid program, etc. Effective Date: 07/01/2018

Transportation Facility Designations/Lieutenant Ewart T. Sconiers Highway; Providing an honorary designation of a certain transportation facility in a specified county, etc. Effective Date: Upon becoming a law

SB 1370 (3R) by Senator Book and others—

Trust Funds/Land Acquisition Trust Fund/Department of Agriculture and Consumer Services; Re-creating the Land Acquisition Trust Fund within the Department of Agriculture and Consumer Services without modification, etc. Effective Date: 07/01/2018

CS/SB 174 (SO) by the Committee on Appropriations, Senator Hukill and others—

Coastal Management; Revising the criteria to be considered by the Department of Environmental Protection in determining and assigning annual funding priorities for beach management and erosion control projects; requiring that certain projects be considered separate and apart from other specified projects; revising requirements for the comprehensive long-term management plan, etc. Effective Date: Except as otherwise provided in this act, this act shall take effect July 1, 2018

Reported favorably by the Committee on Environmental Preservation and Conservation; recommended favorably by Appropriations Subcommittee on the Environment and Natural Resources; and reported favorably as a committee substitute by the Committee on Appropriations

CS/SB 416 (SO) by the Committee on Banking and Insurance and Senator Thurston—

Governance of Banks and Trust Companies; Revising requirements relating to the financial institution experience of certain proposed directors and officers of a proposed bank or trust company; revising the residency requirement for certain directors of a bank or trust company; revising instances during which a bank may not own certain stock, obligations, and other securities, etc. Effective Date: 07/01/2018

Reported favorably as a committee substitute by the Committee on Banking and Insurance; the Committee on Commerce and Tourism reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably

Similar to CS/CS/HB 455(HC) in the Committees on Banking and Insurance; Commerce and Tourism; and Rules

SB 780 (SO) by Senator Brandes and others—

Prohibition Against Contracting with Scrutinized Companies; Prohibiting a company that is on the Scrutinized Companies that Boycott Israel List or that is engaged in a boycott of Israel from bidding on, submitting a proposal for, or entering into or renewing a contract with an agency or local governmental entity for goods or services of any amount; requiring such contracts entered into or renewed on or after July 1, 2018, to include a provision authorizing termination of the contract under specified circumstances, etc. Effective Date: 07/01/2018

Reported favorably by the Committee on Governmental Oversight and Accountability; recommended favorably by Appropriations Subcommittee on General Government; and reported favorably by the Committee on Appropriations

Identical to HB 545(HC) in the Committees on Governmental Oversight and Accountability; Appropriations Subcommittee on General Government; and Appropriations

CS/SB 894 (SO) by the Committee on Rules and Senator Garcia—

Mortgage Regulation; Defining the term “business purpose loan”; defining the term “hold himself or herself out to the public as being in the mortgage lending business”; prohibiting the misrepresentation of a residential mortgage loan as a business purpose loan, etc. Effective Date: 07/01/2019

Reported favorably by the Committee on Banking and Insurance; reported favorably by the Committee on Commerce and Tourism; and reported favorably as a committee substitute by the Committee on Rules

SB 988 (SO) by Senator Perry—

Public Records/ First Responder Network Authority/Nationwide Public Safety Broadband Network; Providing an exemption from public records requirements for information obtained by persons or agencies from the First Responder Network Authority and information relating to the Nationwide Public Safety Broadband Network obtained by persons or agencies from entities operating pursuant to a contract with the First Responder Network Authority; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: 07/01/2018

CS/SB 1316 (SO) by the Committee on Rules and Senator Simmons—

Uniform Voidable Transactions Act; Removing conditions under which a partnership is insolvent; providing conditions under which attachments or other provisional remedies are available to creditors; revising the parties subject to judgments for recovery of a creditor's claim; providing that claims for relief are governed by specified claims law, etc. Effective Date: 07/01/2018

Reported favorably by the Committee on Banking and Insurance; reported favorably by the Committee on Judiciary; and reported favorably as a committee substitute by the Committee on Rules

SB 1398 (SO) by Senator Benacquisto—

Florida ABLE Program Trust Fund/State Board of Administration; Re-creating the Florida ABLE Program Trust Fund within the State Board of Administration without modification, etc. Effective Date: 07/01/2018

OGSR/Complaints of Violations and Referrals; Amending provisions which provides exemptions from public records and public meetings requirements for complaints alleging a violation of part III of ch. 112, F.S., and related records that are held by the Commission on Ethics or its agents and specified local government entities, for written referrals and related records that are held by the commission or its agents, the Governor, the Department of Law Enforcement, and state attorneys, and for portions of meetings at which complaints or referrals are discussed or acted upon; removing the scheduled repeal of the exemptions, etc. Effective Date: 10/01/2018

Transportation Facility Designations; Providing honorary designations of certain transportation facilities in specified counties; directing the Department of Transportation to erect suitable markers, etc. Effective Date: 07/01/2018

Reported favorably by the Committee on Transportation; recommended favorably as a committee substitute by Appropriations Subcommittee on Transportation, Tourism, and Economic Development; and reported favorably as a committee substitute by the Committee on Appropriations

CS/SB 434 (SO) by the Committee on Appropriations, Senator Passidomo and others—

Neonatal Abstinence Syndrome Pilot Project; Revising the definition of the term "prescribed pediatric extended care center" or "PPEC center" to include certain buildings that provide certain residential services to infants with neonatal abstinence syndrome; providing that a specified Agency for Health Care Administration rule include an exception for infants being treated for neonatal abstinence syndrome; requiring the agency, in consultation with the Department of Children and Families, to establish a pilot project to approve one or more facilities licensed to provide PPEC services to treat certain eligible infants, etc. Effective Date: Upon becoming a law

Reported favorably by the Committee on Health Policy; recommended favorably as a committee substitute by Appropriations Subcommittee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Appropriations

CS/SB 942 (SO) by the Committee on Criminal Justice and Senator Bracy—

Department of Juvenile Justice's Direct-support Organization; Requiring the secretary of the Department of Juvenile Justice to appoint board of directors to the department's direct-support organization according to the organization's established bylaws; abrogating the scheduled repeal of provisions governing a direct-support organization established by the department, etc. Effective Date: 07/01/2018

Reported favorably as a committee substitute by the Committee on Criminal Justice; Appropriations Subcommittee on Criminal and Civil Justice recommends the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably

CS/SB 872 (SO) by the Committee on Appropriations and Senator Grimsley—

Young Farmers and Ranchers; Creating the Florida Young Farmer and Rancher Matching Grant Program within the Department of Agriculture and Consumer Services; creating the Florida Young Farmer and Rancher Advisory Council within the department; requiring the department to establish a clearinghouse on its website for resources to assist young and beginning farmers and ranchers, etc. Effective Date: 07/01/2018

Reported favorably by the Committee on Agriculture; recommended favorably as a committee substitute by Appropriations Subcommittee on the Environment and Natural Resources; and reported favorably as a committee substitute by the Committee on Appropriations

CS/CS/SB 740 (SO) by the Committees on Appropriations, Agriculture and Senator Stargel—

Department of Agriculture and Consumer Services; Specifying the methodology for the assessment of certain structures in horticultural production; revising permitting requirements and operating standards for water vending machines; authorizing the department to temporarily suspend enforcement, for specified purposes during states of emergency, of certain provisions relating to predatory practices in the retail sale of motor fuel; requiring certain liquefied petroleum gas dealers to provide notice within a specified period before rendering a consumer's liquefied petroleum gas equipment or system inoperable or discontinuing service, etc. Effective Date: 07/01/2018

Reported favorably as a committee substitute by the Committee on Agriculture; Appropriations Subcommittee on the Environment and Natural Resources recommends the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Appropriations

Child Welfare; Providing for the name of a child's guardian ad litem or attorney ad litem to be entered on court orders in dependency proceedings; providing that time limitations governing placement of a child in a shelter do not include continuances requested by the court; requiring the court to advise the parents during an adjudicatory hearing of certain actions that are required to achieve reunification, etc. Effective Date: 07/01/2018

Vessel Safety Inspection Decals; Providing rulemaking authority to the Fish and Wildlife Conservation Commission regarding expiration and design of safety inspection decals, etc. Effective Date: 01/01/2019

Reported favorably by the Committee on Environmental Preservation and Conservation; recommended favorably as a committee substitute by Appropriations Subcommittee on the Environment and Natural Resources; and reported favorably as a committee substitute by the Committee on Appropriations

CS/SB 1526 (SO) by the Committee on Appropriations and Senator Gibson—

Historically Black Colleges and Universities Matching Endowment Scholarship Program; Establishing the Historically Black Colleges and Universities Matching Endowment Scholarship Program within the Department of Education; authorizing the Legislature to appropriate funds for the program; requiring a historically black college or university to provide a certain amount of matching funds to participate in the program, etc. Effective Date: 07/01/2018

Reported favorably by the Committee on Education; recommended favorably as a committee substitute by Appropriations Subcommittee on Higher Education; and reported favorably as a committee substitute by the Committee on Appropriations

CS/SB 1392 (SO) by the Committee on Criminal Justice, Senator Brandes and others—

Prearrest Diversion Programs; Encouraging counties, municipalities, and public or private educational institutions to implement prearrest diversion programs; requiring that in each judicial circuit the public defender, the state attorney, the clerks of the court, and representatives of participating law enforcement agencies create a prearrest diversion program and develop its policies and procedures; requiring, rather than authorizing, the Department of Law Enforcement to adopt rules for the expunction of certain nonjudicial records of the arrest of a minor upon his or her successful completion of a certain diversion program, etc. Effective Date: 10/01/2018

SB 7026 (SO) by the Committee on Rules (Benacquisto)—

Public Safety; Citing this act as the "Marjory Stoneman Douglas High School Public Safety Act"; establishing the Office of Safe Schools within the Department of Education; prohibiting a person younger than a certain age from purchasing a firearm; prohibiting the importation, transfer, distribution, transport, sale, or giving of a bump-fire stock in this state; creating the Marjory Stoneman Douglas High School Public Safety Commission within the Florida Department of Law Enforcement; requiring district school boards to formulate and prescribe policies and procedures for active shooter situations, etc. Effective Date: Upon becoming a law
