**Physician Certifications for the Medical Use of Marijuana;** Authorizes qualified physicians to perform patient examinations & evaluations through telehealth for renewals of physician certifications for the medical use of marijuana under certain circumstances; authorizes DOH to suspend registration of qualified physician in medical marijuana use registry for specified timeframe under certain circumstances. Effective Date: 07/01/2023

Read the second time and amended on May 3, 2023

CS/CS/HB 1471, 1st Eng. (3R) by the Committees on Health & Human Services Committee, Healthcare Regulation Subcommittee, Representative Busatta Cabrera and others—

**Health Care Provider Accountability;** Revises rights of licensed nursing home facility residents; creates cause of action for ex parte temporary injunction against continued unlicensed activity; authorizes ACHA to provide records to local law enforcement & state attorneys' offices; provides standard of care requirements for office surgeries; prohibits certain office surgeries; provides physician, office, & procedure requirements. Effective Date: 07/01/2023

Substituted for **CS/SB 1596(SUB)** (Garcia), read the second time, and amended on May 3, 2023

#### CS/CS/HB 121 (3R) by the Committees on Health Care Appropriations Subcommittee, Healthcare Regulation Subcommittee, Representatives Bartleman, Trabulsy and others—

Florida Kidcare Program Eligibility; Increases income eligibility threshold for coverage under Medikids program component; increases income eligibility threshold for coverage under Florida Kidcare program; requires applicant seeking coverage under program to provide certain documentation if eligibility cannot be verified using reliable data sources; requires that premiums for certain enrollees under Florida Kidcare program be based on tiered system of uniform premiums. Effective Date: Upon becoming a law

CS/HB 339 (3R) by the Committee on Local Administration, Federal Affairs & Special Districts Subcommittee, Representative Yarkosky and others—

Education of Dependents of Deceased or Disabled Servicemembers, Prisoners of War, and Persons Missing in Action; Revises eligibility requirements for educational benefits provided by state to spouse or dependent child of deceased or disabled servicemember; revises eligibility requirements for educational benefits provided by state to dependent child of prisoner of war, person missing in action, or deceased or disabled servicemember who participated in certain military operations. Effective Date: 07/01/2023

#### CS/CS/CS/HB 49 (3R) by the Committees on State Affairs Committee, Infrastructure & Tourism Appropriations Subcommittee, Constitutional Rights, Rule of Law & Government Operations Subcommittee, Representative Driskell and others—

Abandoned and Historic Cemeteries; Creates Historic Cemeteries Program within Division of Historical Resources of DOS; creates Historic Cemeteries Program Advisory Council; authorizes certain entities to acquire conservation easements to preserve cemeteries; provides appropriations & authorizes positions. Effective Date: 07/01/2023

Substituted for **CS/SB 430(SUB)** (Powell) and read the second time on May 3, 2023

#### CS/HB 965 (3R) by the Committee on Infrastructure Strategies Committee, Representatives Gottlieb, Arrington and others—

Driver License, Identification Card, and Motor Vehicle Registration Applications; Requires that motor vehicle registration form & registration renewal form & driver license or ID card application form, respectively, include option to make voluntary contribution to Best Buddies International. Effective Date: 10/01/2023

Substituted for **CS/SB 996(SUB)** (Berman) and read the second time on May 3, 2023

CS/CS/HB 7039 (3R) by the Committees on Education & Employment Committee, PreK-12 Appropriations Subcommittee, Education Quality Subcommittee, Representative Trabulsy and others—

**Student Outcomes;** Revises provisions relating to instructional materials, programs & strategies, reading interventions & programs, New Worlds Reading Scholarship Accounts, specified FEFP funding, & students with educational deficiencies. Effective Date: 07/01/2023

Substituted for **SB 1424(SUB)** (Calatayud) and read the second time on May 3, 2023

#### CS/CS/HB 1419 (3R) by the Committees on Judiciary Committee, Civil Justice Subcommittee, Representative Robinson, W. and others—

**Real Property Fraud;** Creates Title Fraud Prevention Through Identity Verification Pilot Program; authorizes clerk to require production of government-issued photographic ID card before recording deed & provides requirements therefor; provides requirements for clerk; provides clerk is not required to allow access to record or other information that is confidential & exempt; requires clerk to create, maintain, & operate opt-in recording notification service; requires clerk to ensure that registration for such service is possible through electronic registration portal; provides action may be brought to quiet title after fraudulent attempted conveyance; revises requirements for recording instruments affecting real property. Effective Date: 07/01/2023

Substituted for **CS/SB 1436(SUB)** (Bradley) and read the second time on May 3, 2023

#### CS/HB 1397, 1st Eng. (3R) by the Committee on Transportation & Modals Subcommittee and Representative McClure—

**Regional Transportation Planning**; Provides legislative findings & intent; requires DOT to conduct study of the organizational structure and operation of the Hillsborough Area Regional Transit Authority; specifies requirements of study; requires DOT to submit specified report to Governor & Legislature. Effective Date: Upon becoming a law

Substituted for **CS/SB 1532(SUB)** (Burgess) and read the second time on May 3, 2023

## HB 891 (3R) by Representative Williams and others—

Year-round School Pilot Program; Creates Year-round School Pilot Program for period of 4 school years beginning with specified school year; provides requirements for program. Effective Date: 07/01/2023

Substituted for **SB 1564(SUB)** (Stewart) and read the second time on May 3, 2023

#### CS/HB 1353, 1st Eng. (3R) by the Committee on Commerce Committee, Representative Bankson and others—

**Commercial Financing Product Brokers and Providers;** Requires providers that consummate commercial financing transactions to provide specified written disclosures; prohibits brokers from taking specified actions; provides exclusive authority of Attorney General to enforce specified provisions. Effective Date: 07/01/2023

Substituted for **CS/CS/SB 1624(SUB)** (Brodeur) and read the second time on May 3, 2023

#### CS/CS/HB 5, 1st Eng. (3R) by the Committees on Appropriations Committee, Commerce Committee, Representative Esposito and others—

**Economic Programs;** Renames DEO as Department of Commerce; revises purposes of department; provides head of department is Secretary of Commerce; repeals provisions relating to economic development programs; transfers all duties, records, pending issues, rules, & unexpended balances of appropriations, allocations, & other public funds relating to programs in Enterprise Florida, Inc., to department by type two transfer; authorizes Florida Sports Foundation to enter into an agreement with department for certain purposes & use certain funds; requires department to establish direct-support organization designated Florida International Trade, Inc., for certain purposes; provides appropriations & authorizes positions. Effective Date: 07/01/2023

Substituted for **CS/CS/CS/SB 1664(SUB)** (Hooper), read the second time, and amended on May 3, 2023

#### HB 7027 (3R) by the Committee on Water Quality, Supply & Treatment Subcommittee, Representative Overdorf and others—

Ratification of Rules of the Department of Environmental Protection; Ratifies specified rules relating to onsite sewage treatment & disposal systems & domestic wastewater facilities. Effective Date: Upon becoming a law

# HB 7007 (3R) by the Committee on Ethics, Elections & Open Government Subcommittee and Representative Jacques—

OGSR/Security and Firesafety System Plans; Removes scheduled repeal of exemption from public records requirements for certain security or firesafety system plans; repeals provisions relating to security & firesafety systems; removes scheduled repeal of exemption from public meetings requirements for portion of meeting that would reveal security or firesafety system plan or portion thereof. Effective Date: 10/01/2023

Substituted for **CS/SB 7040(SUB)** (Boyd) and read the second time on May 3, 2023

# HB 7035 (3R) by the Committee on Ethics, Elections & Open Government Subcommittee and Representative Griffitts—

OGSR/Citizens Property Insurance Corporation/Cybersecurity Data and Information; Removes exemption relating to data & information from technology systems; revises specified information that is required to be made available to certain entities; removes scheduled repeal of exemption from public record & public meeting requirements for certain data relating to cybersecurity. Effective Date: 10/01/2023

Substituted for **CS/SB 7042(SUB)** (Boyd) and read the second time on May 3, 2023

## HB 1091 (3R) by Representative Alvarez and others—

**Licensing Fee Relief;** Waives portion of initial license application fee & renewal fees for certain licenses; provides maximum waiver; provides expiration. Effective Date: 07/01/2023

Substituted for **SB 7046(SUB)** (Gruters) and read the second time on May 3, 2023

#### CS/HB 7041, 1st Eng. (3R) by the Committees on Commerce Committee, Regulatory Reform & Economic Development Subcommittee, Representatives Sirois, Duggan and others—

**Space Florida;** Requires Secretary of Economic Opportunity to serve as manager for state with respect to contracts with Space Florida; revises powers, duties, & membership of board of directors of Space Florida; prohibits Space Florida from endorsing candidate or contributing moneys to campaign; prohibits Space Florida from expending funds on certain expenses; requires Space Florida to consult with agencies & jurisdictions. Effective Date: 07/01/2023

Substituted for **CS/SB 7048(SUB)** (Wright) and read the second time on May 3, 2023

#### HB 267 (3R) by Representative Fabricio and others-

Telehealth Practice Standards; Revises definition of term "telehealth." Effective Date: 07/01/2023

Substituted for **SB 298(SUB)** (Boyd) and read the second time on May 3, 2023

#### CS/CS/HB 1573 (3R) by the Committees on Commerce Committee, Insurance & Banking Subcommittee, Representative Persons-Mulicka and others—

Continuing Care Providers; Revises conditions for release of certain escrowed funds to providers; revises information required to be contained in certain providers' financial reports in their annual reports; revises list of financial institutions in which escrow accounts for certain providers' funds must be established; revises condition under which provider may hold & not deposit resident's check for specified period: specifies requirements for notice & for certain plans to replenish withdrawn funds; revises calculation of minimum liquid reserve requirements for certain facilities; revises requirements for letters of credit which satisfy minimum liquid reserve requirements; revises circumstances under which provider may withdraw funds held in escrow without office's approval; specifies that forfeiture penalty may be deducted from certain resident refunds; provides reporting & notice requirements for continuing care facilities; provides disclosure requirement for providers to prospective residents or their legal representatives. Effective Date: 07/01/2023

**Agricultural Lands;** Prohibits counties from levying specified special assessments on lands classified as agricultural; provides exception; authorizes construction or installation of housing for agricultural employees on certain lands; provides requirements for such housing; exempts such housing from certain local government approval; prohibits county or municipality from requiring removal or relinquishment of agricultural land classification for certain lands; requires landowners to provide county or municipality with certain written notice regarding such lands. Effective Date: 07/01/2023

#### CS/CS/CS/HB 425, 1st Eng. (3R) by the Committees on Infrastructure Strategies Committee, Infrastructure & Tourism Appropriations Subcommittee, Transportation & Modals Subcommittee, Representatives Esposito, Andrade and others—

**Transportation**; Revises & provides requirements relating to disabled motor vehicles, autonomous vehicle grading standards, airport zoning regulations, Implementing Solutions from Transportation Research & Evaluating Emerging Technologies Living Lab, certification of aggregate shipments, acceptance of electronic proof of delivery, liability insurance, sharing of cost savings, contractor's certificate of qualification to bid, exemption from public records requirements, request for legislative approval of proposed turnpike projects, M.P.O.'s, allocation of funds to workforce development program. Effective Date: 07/01/2023

Substituted for **CS/CS/CS/SB 64(SUB)** (Hooper) and read the second time on May 3, 2023

#### CS/CS/HB 1259, 1st Eng. (3R) by the Committees on Appropriations Committee, Education & Employment Committee, Representative Canady and others—

**Education**; Revises charter school eligibility & ineligibility criteria to receive capital outlay funds; revises calculation methodologies for distribution of specified funds to eligible charter schools; provides school district requirements for distribution of capital outlay funds to eligible charter schools; & provides requirements for use of capital outlay funds. Effective Date: 07/01/2023

Substituted for **CS/CS/SB 1328(SUB)** (Hutson) and read the second time on May 3, 2023

# CS/HB 733 (3R) by the Committee on Education & Employment Committee, Representative Temple and others—

**Middle School and High School Start Times;** Provides requirements for middle school & high school start times; provides district school board requirements; requires charter schools to meet requirements relating to middle school & high school start times. Effective Date: 07/01/2023

Substituted for **SB 1112(SUB)** (Burgess) and read the second time on May 3, 2023

#### CS/HB 389 (SO) by the Committee on Education Quality Subcommittee, Representative Skidmore and others—

**Menstrual Hygiene Products in Public Schools;** Authorizes school districts to make menstrual hygiene products available, at no charge, in schools within district & at certain locations within such schools; provides notification requirements; & encourages school districts to partner with specified organizations for specified purposes. Effective Date: 07/01/2023

Withdrawn from the Committee on Fiscal Policy

#### CS/HB 551 (SO) by the Committee on Education Quality Subcommittee, Representatives Benjamin, Fine and others—

**Required African-American Instruction;** Requires each school district to certify & provide certain evidence to DOE regarding certain instruction; authorizes DOE to seek input from & contract with certain educational organizations for specified purposes; requires each school district to submit implementation plan to Commissioner of Education & post plan on its website; provides requirements for plan; requires commissioner or DOE to provide certain notification; provides timeframe within which school district must submit revisions to its plan; authorizes SBE to take certain actions. Effective Date: 07/01/2023

Withdrawn from the Committee on Fiscal Policy

## HB 1373 (SO) by Representative Fernandez-Barquin and others—

**County Constitutional Officers;** Prohibits county from creating office, special district, or governmental unit, or expanding powers or authority of such office, district, or unit, under certain conditions; provides county commissioner is guilty of misfeasance or malfeasance in office under certain conditions; authorizes state to withhold county funding under certain conditions; authorizes county constitutional officers & residents to bring action in circuit court. Effective Date: 07/01/2023

Withdrawn from the Committee on Rules

#### CS/CS/HB 1405 (SO) by the Committees on Infrastructure Strategies Committee, Water Quality, Supply & Treatment Subcommittee, Representative Tuck and others—

**Biosolids**; Establishes biosolids grant program within DEP; authorizes DEP to provide grants to counties, special districts, & municipalities for certain wastewater conversion projects; provides eligibility, prioritization, & funding requirements; authorizes waiver of matching fund requirement; requires DEP to develop specified reporting requirements for grants awarded to counties, special districts, & municipalities. Effective Date: 07/01/2023

Withdrawn from the Committee on Appropriations

#### CS/CS/SB 1506 (SO) by the Committees on Rules, Health Policy and Senator Rodriguez—

**Department of Health**; Prohibiting certain research in this state relating to enhanced potential pandemic pathogens; prohibiting medical marijuana treatment centers from producing marijuana products that are attractive to children or manufactured in specified manners; requiring local registrars to electronically file all live birth, death, and fetal death records in their respective jurisdictions in the department's electronic registration system; revising the types of health care practitioners who may make certain determinations of death; extending the timeframe for the confidentiality of certain birth records; requiring that hearing aids provided to persons younger than 18 years of age be prescription hearing aids and not over-the-counter hearing aids, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2023

Reported favorably as a committee substitute by the Committee on Health Policy; and reported favorably as a committee substitute by the Committee on Rules

# CS/SB 7062 (SO) by the Committees on Appropriations, and Finance and Tax (Ingoglia)—

Taxation; Requiring that a referendum to reenact an expiring tourist impact tax be held at a general election; specifying that certain permanently and totally disabled veterans or their surviving spouses are entitled to, rather than may receive, a prorated refund of ad valorem taxes paid under certain circumstances; revising requirements for applying for property tax refunds due to catastrophic events; providing a sales tax exemption for the purchase of certain equipment necessary for the storage of electrical energy; exempting from sales and use tax the retail sale of certain clothing, wallets, bags, school supplies, learning aids and jigsaw puzzles, and personal computers and personal computer-related accessories during specified timeframes; exempting from sales and use tax specified disaster preparedness supplies during a specified timeframe, etc. Effective Date: Except as otherwise provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2023

#### HB 227 (LB) by Representative Botana-

Lee Memorial Health System, Lee County; Provides quorum requirements for system board meetings; removes requirement that health system's annual audit & annual budget be filed with clerk of circuit court; revises provisions relating to purchasing real property, entering into financial agreements, & managing funds; provides process by which health system may convert to nonprofit entity; removes provisions relating to execution & enforcement of liens. Effective Date: Upon becoming a law

# HB 567 (LB) by Representatives Steele and Yarkosky—

Lake Padgett Estates Independent Special District, Pasco County; Revises terms of certain members elected to board of supervisors to provide for staggered terms. Effective Date: 07/01/2023

#### CS/HB 773 (LB) by the Committee on Local Administration, Federal Affairs & Special Districts Subcommittee, Representative Holcomb and others—

Hernando County School District, Hernando County; Repeals School Board of Hernando County resolution which provides for appointed superintendent of schools; provides for elected superintendent of schools; requires referendum. Effective Date: Upon becoming a law

#### CS/HB 815 (LB) by the Committee on State Affairs Committee and Representative Maney—

**Ocean City-Wright Fire Control District, Okaloosa County;** Provides for future annexation of certain unincorporated territory. Effective Date: Upon becoming a law

#### HB 943 (LB) by Representative Waldron-

ACME Improvement District and Pine Tree Water Control District, Palm Beach County; Transfers certain land from the Pine Tree Water Control District to the Acme Improvement District; provides purpose. Effective Date: Upon becoming a law

#### HB 945 (LB) by Representative Snyder-

Jupiter Inlet District, Palm Beach County; Codifies, amends, reenacts, & repeals special acts relating to Jupiter Inlet District, Palm Beach County; provides purpose & construction. Effective Date: Upon becoming a law

#### CS/HB 947 (LB) by the Committee on Regulatory Reform & Economic Development Subcommittee, Representative Robinson, W. and others—

**Manatee County;** Authorizes Manatee County to construct parking facility & amenities within territorial boundaries of City of Holmes Beach; requires permit for construction to be issued by county. Effective Date: Upon becoming a law

#### HB 1027 (LB) by Representative Melo and others-

Ave Maria Stewardship Community District, Collier County; Revises boundaries of Ave Maria Stewardship Community District, Collier County. Effective Date: Upon becoming a law

#### CS/HB 1049 (LB) by the Committee on Local Administration, Federal Affairs & Special Districts Subcommittee, Representative Gossett-Seidman and others—

**Boca Raton Airport Authority, Palm Beach County;** Provides boundaries; provides authority is independent special district; provides for title of land to be vested in authority; provides additional powers & duties; provides attendance fee for members; requires Board of Trustees of Internal Improvement Trust Fund to transfer title of land to authority; revises employment of airport manager; provides authority is political subdivision of state for sovereign immunity purposes. Effective Date: Upon becoming a law

# CS/HB 1083 (LB) by the Committee on Ways & Means Committee, Representative Beltran and others—

**Manatee County;** Creates East River Ranch Stewardship District; provides definitions; establishes legal boundaries; provides for jurisdiction; provides for governing board; provides for membership, election, terms of office, & meetings; provides powers & duties; provides method for transition of board from landowner control to control by resident electors of district; provides for district manager & personnel; provides general & special powers of district; provides for bonds; provides for borrowing; provides for ad valorem taxation, special assessments, certificates of indebtedness & tax liens; provides for referendum. Effective Date: 07/01/2023

#### HB 1169 (LB) by Representative Shoaf-

Hamilton County; Creates Hamilton County Development Authority; provides for appointment & terms of members of board of authority; provides powers; provides for annual budget & annual financial reporting; limits authority to incur debt; provides purpose & construction; provides for severability. Effective Date: 06/01/2023

# CS/HB 1175 (LB) by the Committee on Ways & Means Committee, Representative Buchanan and others—

Sarasota County; Creates Three Rivers Stewardship District; provides charter. Effective Date: 07/01/2023

#### HB 1225 (LB) by Representative Smith and others-

Sanford Airport Authority, Seminole County; Revises authorized term for which authority may enter into exclusive or nonexclusive contracts, leases, franchises, or other arrangements with any person. Effective Date: Upon becoming a law

## HB 1237 (LB) by Representative Robinson, W. and others—
