Amends provisions of the SAIL Program in s. 420.5087, F.S., to require the evaluation of additional components related to local government contributions, including policies that promote access to public transportation, reduce the need for on-site parking where appropriate.		AFFORDABLE HOUSING. Amends s. 420.5095, F.S., revising the Community Workforce Housing Loan Program, administered by Florida Housing. Workforce housing is defined as housing affordable to persons of families whose total annual income does not exceed 80 percent of the area median income or 120 percent of the area median income, adjusted for household size in specified areas of critical concern. Requires Florida Housing to establish a loan application process pursuant to SAIL Program provisions under s. 420.5087, F.S., and award loans at a one percent interest rate for a term not to exceed 15 years.
