- 7. <u>FY 2012-13 GAA proviso specifically associated with the project (if any)</u>: From the funds in Specific Appropriation 775, \$600,000 in recurring general revenue funds are provided for the Drug Abuse Comprehensive Coordinating Office, Inc. (DACCO) in Hillsborough County.
- 8. <u>Project Purpose/Description</u>: The purpose of this project is to fund additional residential substance abuse beds in an area that has one of the highest number of offenders on supervision and prison admission rates. It funds approximately 32 beds in a Short-Term Residential Substance Abuse Treatment Program specifically designed for the criminal justice population. The length of the program is six (6) months. Offenders must be court ordered to participate in the program.
- 9. <u>Number of years this project has received state funding</u>: Nine (9) years; FY 04-05 through FY 12-13.
- 10. Does this project align with the core missions of the agency or the program area in which it is funded? (Explain): Yes, the appropriation aligns with the mission of the Florida Department of Corrections', Office of Re-Entry which is to provide inmates and offenders with comprehensive programs and services that will assist in the successful re-entry into the community, thereby reducing recidivism while enhancing public safety, and promoting post-release success.

11. <u>Does the program meet a demonstrated need in the community that is not otherwise being met?</u> (Explain): Yes, it provides an additional thirty-two (32) Nonsecure (short-term) residential substance abuse treatment beds for offenders on community supervision in a circuit that has one of the highest number of offenders on supervision and prison admission rates.

12. What are the intended outcomes/impacts and benefits of the project? The goal of the project is to provide a substance abuse treatment program that offers services and interventions to motivate and assist offenders in their personal recovery from substance abuse and assistance in re-entry/employment services for their reintegration into the community. This model allows the offender to remain in the community, gain and maintain employment while participating in residential substance abuse treatment. This community-based model assists in maintaining family ties and through the work component; the offender is paying taxes, restitution and managing a budget while receiving substance abuse treatment. The program offers the judiciary an alternative to incarceration.

13. What performance data does the agency/entity regularly collect and report that demonstrates the value of the program to the State of Florida? \*The Performance data is collected on all funded beds for this provider/program, not just the beds funded by this specific proviso. In FY 11-12 DACCO had 77 nonsecure beds funded from other sources and 32 funded from this proviso for a total of 109 beds. This is the current number of funded beds.

- 17. How do the unit costs compare to those of comparable or alternative projects or services? (EXPLAIN AND SPECIFY): DACCO's unit cost is \$51.47 per day per occupied bed. This is the second highest rate in the state. The statewide average cost for a nonsecure bed is \$48.23. Statewide, the unit cost ranges from a low of \$45.00 to a high of \$55.80 per day per occupied bed.
- 18. Based on performance data, is this project meeting the expected outputs and having the intended outcomes? (Explain): Yes. The beds are being utilized and all funds are being drawn down. DACCO has consistently met contract performance measures.
- 19. Describe how the information upon which the answer above is based was obtained and validated: Bed utilization and spending patterns are reviewed on at least a monthly basis. Exit data is reviewed on a quarterly basis and analyzed annually based on fiscal year.

Inmates earn an 18-credit high school diploma and a credentialed career certificate in one, comprehensive online program. Inmates take online courses in supervised onsite learning labs that are available to them five (5) days per week. One academic teacher is provided by the Department of Corrections per program (2 total) to support the learning labs.

This is aligned with Smart Horizon's intent to provide web-based education services to inmates transitioning from the custody of the Florida Department of Corrections.

The Florida Department of Corrections has no existing contracts with service providers that provide an online high school diploma during incarceration.

Issuance of a standard high school diploma to every inmate who successfully completes the program in accordance with the Advanced/SACS accreditation requirements. The goal is to assist transitioning inmates by providing them with education and employability skills.

Yes; however, additional time is needed for program evaluation. The program has been operational for less than one (1) year. As of December 2012, there were 97 participants in the program. Currently, there are 19 program completers. Of these, two (2) were released. There are plans to work with the Florida Education and

Training Placement Information Program (FETPIP) to collect data on graduates of the program. Through this partnership, employment and earnings of the students will be monitored. Please note that there is a one (1) to two (2) year delay in data from FETPIP after release so additional time is needed to determine the outcomes.

Information provided is compared to data entered into the Offender Based Information System (OBIS) and reviewed to ensure services are rendered as specified in the contract.
