The requested funds will be used to provide law enforcement managers with the strategies and resources they need to establish and maintain positive relationships with diverse communities. Through this training, law enforcement professionals and community stakeholders will gain the skills and knowledge to build trust and foster mutual understanding between law enforcement and the community. The expected outcome of this training is to create a mutually beneficial and respectful relationship between law enforcement and the community.

The Community Resources Connector (CRC) is a powerful real-time resource tool designed to help law enforcement, juvenile justice, child welfare, education, traditional and non-traditional not-for-profits, and other professionals quickly connect community residents and stakeholders with targeted quality of life referral information. With CRC, you can find a range of services and support, including food pantries, domestic violence shelters, youth programs, elderly assistance, and job training programs. Furthermore, CRC offers in-depth communications capabilities between law enforcement, community stakeholders, courts and state attorney's offices, allowing for improved public safety cooperation and crime reduction. For law enforcement and community stakeholders, CRC is the premier solution for efficient resource referral.

### c. What direct services will be provided to citizens by the appropriation project?

The direct services provided to citizens through the appropriation project will be an increase in the number of trained and qualified law enforcement officers serving in the State of Florida. This will help to ensure that our communities are safer and more secure, as law enforcement officers play a crucial role in protecting citizens and maintaining order. The recruitment initiative will aim to attract top talent to join our law enforcement agencies, which will ultimately benefit citizens by providing increased protection and service. This is an opportunity for law enforcement and community stakeholders to gain insight into how to create and maintain positive relationships between law enforcement and community stakeholders.

The expected outcome of this project is to increase shared public safety accountability among Community Stakeholders, Law Enforcement, Courts, and the State Attorney, with emphasis on gun violence.
