Records preservation services to include archival stabilization, deacidification, and Mylar encapsulation. Digital imaging services to include scanning documents into an archival format that can be indexed and hosted to create a digital access point for citizens.

Citizens will have the ability to view, research, or request material electronically from anywhere and at their convenience.

Allowing and creating access to historical records has a far reaching impact on citizens. It could easily be estimated the 1-3 million people of Cuban origin within the state of Florida and outside the state could benefit from this project.

The expected benefit from this project is the preservation of and direct digital access to historical records that have been archived and shelved for the majority of their life. The outcome will be measured by the number of records available electronically after the project is finished.
