The Florida Fallen Heroes Wall Memorial honoring the men and women in uniform that made the ultimate sacrifice upon the altar of freedom is currently housed at the Air Force Armament Museum at Eglin Air Force Base. The Wall Memorial must be relocated due to a planned FDOT and Eglin AFB (taking) road and new runway expansion/reconfiguration causing the museum to close and relocate in 2023-25.

The Military Order of the Purple Heart, Eglin AFB, the Wounded Warrior Project, and FDVA agreed the Wall Memorial should be moved to the Florida Capitol Grounds, Purple Heart section, and is requesting an appropriation during fiscal year 2023 in the amount of \$150,000 for design, build, update, and installation of the Memorial. The project will be managed by DMS with direction and input by the Military Order of the Purple Heart, Tallahassee Chapter 758, Commander Rick Stafford, USM.
