e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The expected outcome is to have a Police and Emergency Response Center that meets all Federal, State, and Local Code requirements for health, safety and accessibility. The primary way of measuring performance is to have the City Building Official identify the numerous Federal, State and Local Code issues resolved with the new facility. Also, keep accurate databases of information on new jobs, economic development, regional meeting, police data, and track the information over time to see annual changes. This can be done by making these requirements as part of the funding award.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

The contracting agency shall establish a Critical Path with date specific targets for predevelopment. Once bids are received and awarded for the project the contract will have specific completion dates, if not met contractor will be subject to Liquidated Damages, assessed on a daily basis.
