Statistics demonstrate that youth who age out of foster care experience homelessness, unemployment ,dropping out of school, incarceration, and exploitation at at higher rates than their peers. Providing youth with stable housing, therapeutic supportive services, and independent living skills can help to ensure they have a brighter future and the chance they deserve to be successful. SAYS has been providing therapeutic residential services for youth with mental health diagnosis since 1989. Our mission is to shape the future of Florida's at-risk youth by providing coaching, counseling and care. 14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Funding to expand services to young people aging out of the foster care system to prevent homelessness, human trafficking, and dependency on more intensive and expensive social support systems. The St. Augustine Youth Services (SAYS) is expanding its services to provide support and housing for youth aging out of foster care with the goal of providing them the opportunity to live a healthful and productively independent life. The total project will cost approximately \$2,000,000. SAYS has already secured the property and raised \$900,000 toward the project for a total value of 1,100,000. An additional \$1,019,300 is needed in state funds to complete the project.

b. What activities and services will be provided to meet the intended purpose of these funds?

Once the apartments are completed, the youth will receive housing, on-site residential staff, mental health services and life-skills training in an open, non-restrictive, supportive family-like model.

• Long-term placement: Providing youth with a stable living environment is the most important support we can offer. This provides youth with safe and consistent guidance and support and helps to ensure their long-term success.
Independent living skills: Providing youth with the necessary skills to live independently, such as budgeting, cooking,

and basic life skills, can help to ensure their success once they leave the foster care system.

 Mental health services and mentorship: Providing youth with mental health services mentors can help to provide them with support and guidance as they transition into adulthood.

c. What direct services will be provided to citizens by the appropriation project?

The Independent Living Village and all associated services named above would provide services directly to some of the most at risk, under-served citizens in our state, our youth aging out of foster care.

d. Who is the target population served by this project? How many individuals are expected to be served?

Young people aging out of the foster care system that are not ready for full independence and needing additional support to be successful. Approximately 14- 20 full time residents will be served annually.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Children in foster care have experienced trauma. Mental illness and trauma history have a large impact on a person's ability to lead a successful and fulfilling life. Outcome: Youth living in SAYS IL Village will participate in therapeutic services to assist with their mental health treatment.

Only 58% of youth aging out of foster care in Florida have completed high school or obtain a GED. Outcome: Eligible youth living in SAYS IL Village shall attend /complete an educational program

According to Children's Rights, it was found that up to 47 percent of children who were in foster care are currently unemployed. Outcome: SAYS will provide youth living at the IL Village independent living skills and job training to improve residence with economic self sufficiency.

According to CHLSS. It is believed that one out of two kids who age out of foster care will develop a substance use dependence. Outcome: SAYS will provide substance abuse education for youth

Outcome: Reduce homeles

The project will build new residential facilities to address the needs of the young people aging out of the child protection system. Penalties could include repayment of funds should the project not be completed.
