Rehabilitation of the foster facility on Forever Florida Lands. Hurricane Ian destroyed parts of our facility and our two aging campuses also need improvements. Our facilities serve boys ages 12-17 years old who, on average, have been placed in 14 homes prior to arriving at our facility. As a result, trauma-informed care and therapies along with an enriched learning environment are necessary. All of these things require a stable, safe, and working infrastructure.

b. What activities and services will be provided to meet the intended purpose of these funds?

Currently there is no indoor space for recreation at our new campus. The new building will have a dual purpose of giving us an indoor space for our Christmas and monthly birthday parties.

c. What direct services will be provided to citizens by the appropriation project?

Continued quality care of a marginalized population: teen foster boys.

d. Who is the target population served by this project? How many individuals are expected to be served?

A total of 48 teen foster boys will be served.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

An indoor recreational facility will promote physical activity and a sense of community which improves mental health. It will also provide a safe and secure environment for the boys to study and learn. 20% of foster boys are incarcerated by the age of 22. Improvements to our facilities allow us to take on more kids and provide them with skills to be successful in life and avoid a life of crime. Currently, we have a less than 2% of our graduates in the criminal system.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Repayment of the appropriations funding.
