**Special Master on Claim Bills**

**CS/HB 6513 — Relief/Eric Scott Tenner/Miami-Dade County Board of County Commissioners**

by Civil Justice Subcommittee and Representative Perez (CS/SB 24 by Committee on Judiciary and Senators Simmons and Benacquisto)

The bill provides \$1,450,000 for the relief of the estate of Eric S. Tenner. Mr. Tenner died after being hit by a county bus while riding his bicycle.

If approved by the Governor, or allowed to become law without the Governor's signature, these provisions take effect upon becoming law.

**CS/HB 6515 — Relief/Estate of Herminio Padilla, Jr./the City of West Palm Beach, Palm Beach County, the City of Lake Worth, the City of Riviera Beach, and the Town of Palm Beach**

by Civil Justice Subcommittee and Representative Fernandez-Barquin (CS/sCS/SB 200 by Committees on Governmental Oversight and Accountability and Judiciary and Senator Cruz)

The bill provides \$100,000 for the relief of the estate of Herminio Padilla, Jr. As he was walking on a catwalk above a sewage basin, the grate on which Mr. Padilla, Jr., was walking fell out of the catwalk causing him to fall into the basin and drown.

If approved by the Governor, or allowed to become law without the Governor's signature, these provisions take effect upon becoming law.

**CS/HB 6517 — Relief/Robert Allan Smith/Orange County**

by Judiciary and Representative McClure (CS/CS/SB 34 by Committees on Governmental Oversight and Accountability and Judiciary and Senator Torres)

The bill provides \$750,000 for the relief of Mr. Robert A. Smith. Mr. Smith suffered injuries, including an above-the-knee amputation, after being hit on his motorcycle by a county van.

If approved by the Governor, or allowed to become law without the Governor's signature, these provisions take effect upon becoming law.

**CS/HB 6523 — Relief/Jane Doe/School Board of Miami-Dade County**

by Civil Justice Subcommittee and Representative A. M. Rodriguez (CS/SB 38 by Committee on Judiciary and Senator Thurston)

The bill provides \$1,300,000 for the relief of Jane Doe. A student, with behavioral concerns unknown to Ms. Doe, raped and attempted to murder Ms. Doe in her classroom.

If approved by the Governor, or allowed to become law without the Governor's signature, these provisions take effect upon becoming law.

**CS/HB 6525 — Relief/Dominguez Family/Hillsborough County**

by Civil Justice Subcommittee and Representative Fernandez (CS/SB 42 by Committee on Judiciary and Senator Taddeo)

The bill provides \$400,000 for relief of the Dominguez family. Darcia Dominguez died after crashing into a county tractor-trailer truck that was broken down in the left travel lane of Veterans Express Highway.

If approved by the Governor, or allowed to become law without the Governor's signature, these provisions take effect upon becoming law.
