

Florida State Attorney's



Florida Constitution Article 5

SECTION 17. State attorneys.—In each judicial circuit a state attorney shall be elected for a term of four years. Except as otherwise provided in this constitution, the state attorney shall be the prosecuting officer of all trial courts in that circuit and shall perform other duties prescribed by general law; provided, however, when authorized by general law, the violations of all municipal ordinances may be prosecuted by municipal prosecutors. A state attorney shall be an elector of the state and reside in the territorial jurisdiction of the circuit; shall be and have been a member of the bar of Florida for the preceding five years; shall devote full time to the duties of the office; and shall not engage in the private practice of law. State attorneys shall appoint such assistant state attorneys as may be authorized by law.

Living in a postpandemic world

The backlog has come to fruition.

Statewide caseloads show an average increase of 50% more criminal cases than pre-pandemic levels.





Criminal cases have increased in both number and severity.

- Felony cases went from 51,273-76,215
- 49% increase
- Misdemeanor cases went from 203,194-312,898
- 54% increase



More work with less staffing!!!

- Over 450 support staff positions need to be filled!
- Over 270 Assistant State Attorneys need to be hired!

Compression is our biggest problem

- The \$50,000 starting salary has been a wonderful boon to our new attorneys.
- The increase in minimum wage has been a just and needed relief for our lowest paid team members.
- However, this has consumed our funding and we are not able to retain our folks who are excelling!

- (5) The appropriations for the offices of state attorneys shall be determined by a funding formula based on population and such other factors as may be deemed appropriate in a manner to be determined by this section and the General Appropriations Act.


We suggest a formula generated by independent variables. Population and Cost of living

Appropriation= Base budget x [Population Annual Factor x Cost of Living Annual Factor x Cumulative Annual Factor] This year, that would result in:

3.34% budget increase

JUSTIFICATION FOR BUDGET REQUEST

- ► Civil case backlog = Law firms poaching state offices
- ► PDO Salaries are not competitive
- ► TURNOVER CRISIS. Turnover average is 26% statewide, SOME CIRCUITS HIGHER THAN 50% TURNOVER
- ► Higher pending caseloads due to INCREASED TURNOVER, BACKLOG, and SUSPENSION OF SPEEDY TRIAL
- ▶ Drop in attorney applications
- Across the board increase should match other state agencies
 A.G. asked for minimum \$10,000 per attorney
- ▶ \$2,080 per FTE compression due to minimum wage increase





#1, Close Regional Counsel Salary Cap


- PD's, SA's and RC's have salary cap set in law.
- PD's and SA's make the same.
- Regional Counsels have historically been approximately 30% less than JRO counterparts. A wide but somewhat workable gap.

Last year a 10% raise to the salary caps of the PD's and SA's further widened the gap to 38%. Closing to gap back to 30% is needed to keep up with historical disparity without worsening the problem yearly.



LEGISLATIVE PRIORITIES 2022-2023

Office of Criminal Conflict and Civil Regional Counsel Second District Court of Appeal

Ita M. Neymotin, Esq., LL.M., M.P.A., LSS Black Belt Regional Counsel, Second District Court of Appeal

Regional Counsels provide legal representation for indigent people with substantial cost savings. The Justice Administrative Commission has estimated that to date, the Regional Counsels have saved the State of Florida close to \$349,000,000 compared to private registry counsel.

- 1- COVID-19 backlog workload \$1,234,408
- 2- A Cross Jurisdictional Death Penalty Program Budget Proposal providing death penalty litigation across the State of Florida at reduced costs, as compared with private registry counsel \$1,397,041
- 3- Secure swipe card access \$30,000
- 1- Regional Counsel 2 is requesting 5 criminal attorney positions, 5 dependency attorney positions, and 3 forensic social worker positions to clear the caseload backlog of more than 1000 cases which have accumulated since March 2020; and continue to accumulate. The courts were slowed due to the pandemic response, with hearings and cases being delayed. This request is for funds to hire staff to process and handle to completion these cases.
- 2- Regional Counsel 2 is proposing a Cross Jurisdictional Death Penalty Program to take cases in central (Ocala/Orlando) and north (Tallahassee) Florida Judicial Circuits 2, 5, and 9 to show how it will provide death penalty litigation at reduced costs, when compared with private registry counsel; while still ensuring client representation is adequate and is not diminished in effectiveness.
- 3- Regional Counsel 2 has an obligation to keep employees and clients safe, to secure our premises and to safeguard information. All of our buildings are privately leased and do not have county provided security as the Public Defender and State Attorney offices do in county provided buildings. Swipe card access is superior to standard metallic key access for ease of use and access control. This is a request for the swipe card access upgrade.



Ita M. Neymotin, Regional Counsel Second District CROSS JURISDICTIONAL DEATH PENALTY PROGRAM (CJDPP) FACTS SHEET

- * **PURPOSE**: Regional Counsel, Second District is proposing a Cross Jurisdictional Death Penalty Program to take cases in central (Ocala/Orlando) and north (Tallahassee) Florida Judicial Circuits 2, 5, and 9 to demonstrate how RC2 can provide death penalty litigation at reduced costs and save tax payer's dollars when compared with private registry counsel; while still ensuring client representation is adequate and is not diminished in effectiveness for indigent clients.
- ❖ PRIVATE REGISTRY EXCEEDS FUNDS APPROPRIATED: The Private Attorney Registry has exceeded legislative appropriations for the last several years with annual budgetary over spending between 15 and 17 million dollars.
- * RETURN ON INVESTMENT/TAXPAYERS SAVINGS The Return on Investment (ROI) in comparing Private Registry cases against Regional Counsel Second District cases has shown a savings ratio ranging from 3:1 to 10:1, according to the Death Penalty Cost Analysis created by Regional Counsel. Indigent Representation under The proposed Cross Jurisdictional Death Penalty Program will cost to taxpayers between 3 to 10 times less than the amount of taxpayer money spent by Registry Attorney's in death penalty cases.
- * CITED SOLUTION BY THE OFFICE OF PROGRAM POLICY ANALYSIS AND GOVERNMENT ACCOUNTABILITY (OPPAGA): OPPAGA completed a study on due process expenditures for the state of Florida dated December 2019 and cited Regional Counsel Second District's Cross Jurisdictional Death Penalty Program as a possible solution to the rising expenses of death penalty private registry attorney's due process costs (page 16).
- ❖ **DIVERSITY**: Through community partnerships, Regional Counsel, Second District's Cross Jurisdictional Death Penalty Program will provide educational opportunities for attorneys, paralegals, mitigation specialists, and investigators of diverse ethnic and national origins to become death penalty certified attorneys and staff, which will increase diversity in the legal representation of death penalty cases. As the first person to be admitted into The Florida Bar from the Country of Kazakhstan, I can honestly say that diversity is crucial to an organization as well as to our communities in general.
- **SUPPORT OF PROGRAM**: Law schools, as well as colleges have pledged their support for the Cross Jurisdictional Death Penalty Program. The Henry Latimer Center for Professionalism has agreed to help put together a professionalism curriculum for the new attorneys involved in this program.
- * WORLDWIDE JOURNAL PUBLICATION: The Cross Jurisdictional Death Penalty Program was published worldwide in *The Empirical Economics Letters* journal article "Minimizing the 'Price' of the Death Penalty in Florida" written by Ms. Ita M. Neymotin, Regional Counsel, Second District and Dr. Florence Neymotin, Huizenga College of Business, Nova Southeastern University, USA.
- * THE FLORIDA BAR PUBLICATIONS: The Florida Bar conducted an interview with Regional Counsel Second District and then published two articles regarding the benefits of the Cross Jurisdictional Death Penalty Program: "Pilot Program Suggested For Death Penalty Conflict Cases" and "Professionalism: Helping To Overcome Unjust Sentencing And Discrimination In Death Penalty Litigation".
- ❖ AWARDS: In 2021, Ms. Ita M. Neymotin, Regional Counsel, Second District was awarded the most prestigious award from Florida Gulf Cost University, the Alumni of Distinction Award, partly for the research and proposed creation of the Cross Jurisdictional Death Penalty Program. Ms. Neymotin holds a Juris Doctorate and an LL.M. in Business from Capital University and a Master in Public Administration from Florida Gulf Coast University. Further, she also holds a Lean Six Sigma Black Belt Certification and won "Best Use of Data" at the 29th Annual Florida Sterling Conference Team Showcase in June 2021.
- * TV SHOW FEATURE: The TV Show "Law & Sarasota" hosted by Senior Chief Judge Lee E. Haworth aired a 30 minute segment on the Cross Jurisdictional Death Penalty Program with Ms. Ita M. Neymotin, Regional Counsel, Second District and Mark Brewer, Circuit Chief of Sarasota.

CAPITAL COLLATERAL REGIONAL COUNSELS 2022-2023 LEGISLATIVE BUDGET REQUEST

Florida Statute 27.702 requires the Capital Collateral Regional Counsels (CCRCs) to represent death sentenced inmates in the state and federal courts, including the United States Supreme Court, until relief is granted or the sentence of execution is carried out.

There are three offices, North, Middle and South and cases are assigned by the Florida Supreme Court after the direct appeal and are based on the jurisdictions of the Federal District Courts. All CCRC attorneys must have expertise in the highly complex area of Federal Habeas Corpus and are required by Rule 3.112(k) Florida Rules of Criminal Procedure to have extensive experience in capital case litigation before becoming a lead attorney.

The total General Revenue budget request for all three CCRC offices combined for the 2022-2023 fiscal year is \$254,398 broken down by agency as follows:

CCRC-North

- \$34,000 Competitive Pay Adjustment
- \$12,700 Information Technology

CCRC- Middle

- \$72,000 Competitive Pay Adjustment
- \$52,554 Information Technology

CCRC-South

- \$73,000 Competitive Pay Adjustment
- \$10,144 Information Technology

Over the past two fiscal years, the CCRCs have experienced a **40% turnover rate**. Nine (9) lead lawyers, with a combined 118 years of experience and fourteen (14) second chair lawyers, with a combined 59 years of experience, have moved to other government agencies, gone into private practice, or retired. The loss of staff at this critical juncture when the CCRCs expect a substantial increase in caseload is particularly devastating.

In order to recruit and retain staff for the expected increase in caseload, compete with similarly situated government agencies and continue to meet legislative performance measures, the CCRCs are requesting a \$5,000 competitive pay adjustment for every attorney with less than three (3) years' experience and \$3,000 for every attorney with more than three (3) years' experience.

For the 2022-2023 fiscal year, the total competitive pay adjustment requested is **\$179,000** for all three agencies combined, with the amount requested by each agency delineated above. The pay adjustment is requested in order to recruit and retain experienced attorneys who must comply with the skill requirements set by the Florida Supreme Court.

REPRESENTING FLORIDA'S CHILDREN ADVOCATING FOR BEST INTERESTS

Under federal law states are required to ensure appointment of a guardian ad litem who will represent and protect the rights and best interests of the child. (45 C.F.R. § 1340.14(g) (2004)



In Florida - § 39.822(1), F.S.:

A guardian ad litem shall be appointed by the court at the earliest possible time to represent the child in any child abuse, abandonment, or neglect judicial proceeding, whether civil or criminal.

ISSUE 1: TRUST FUND AUTHORITY







- The Guardian ad Litem Program can <u>represent every child</u> using federal Title IV-E funding without general revenue.
- The Guardian ad Litem Program is requesting Grants and Donations Trust Fund spending authority of \$4,397,042 and 67.50 FTEs.



ISSUE 2: ENHANCE VOLUNTEER RETENTION



- The Guardian ad Litem Program is seeking \$60,000 in the expense category for the purpose of enhancing volunteer retention through Certified Public Manager ("CPM") training.
- Invest in retention as well as recruiting.
- Give each circuit Guardian ad Litem
 Program at least one person with CPM training.

INTRODUCTION

The Florida Legislature created the Florida Clerks of Court Operations Corporation (CCOC) in 2003.

CCOC performs the statutory responsibility of approving the court-related budgets for all 67 Clerks of Court – s. 28.35, F.S.


CLERK OPERATIONS

In State Fiscal Year 2020-21, Clerks collected \$765.6 million in statutorily mandated fines and fees, of which they only retained \$421.9 million to provide services to the Floridians who depend on the timely resolution of their cases ELSEWHERE



PANDEMIC-RELATED BUDGET REDUCTION

CFY 2019-20 CCOC approved budget: \$458.5 million

- Reduced to \$404 million (\$54 million; over 12 percent)
 - Taken in 4th quarter; <u>50% reduction</u> to 4th quarter expenditures
 - Operations impacted: Furloughs, layoffs, closures, delays

CFY 2020-21 CCOC approved budget: \$421.7 million

 Reduced over \$36 million (approximately 8 percent) from CFY 2019-20 approved budget



PANDEMIC RECOVERY PLAN

2021 Legislative Session

- Clerks' Pandemic Recovery Plan
 - Used the Courts' Pandemic Recovery Plan as a guide
 - Chair Perry sponsored LFIR 1993
 - \$6.25 million NR General Revenue approved

2022 Legislative Session Request

- Pandemic Recovery Plan Phase II
 - \$6.25 million NR General Revenue
 - CCOC will continue working with the Courts to direct the resources



JUROR MANAGEMENT

2021 Legislative Session

- Juror Management \$11.7 million recurring GR
 - Reverted \$2.4 million due to the suspension of jury trials
 - Appropriated for the same purpose in SFY 2021-22

2022 Legislative Session Request

- Request the same language for SFY 2022-23
 - Amount TBD



REIMBURSEMENT - PROTECTIVE INJUNCTIONS

Current law allows for the reimbursement for protective injunctions

- Protective injunctions include, Domestic Violence, Dating Violence, Sexual Violence, Repeat Violence, and Stalking
- Many clerks have staff on-call 24/7 to process these cases
 - \$40 reimbursement per petition, subject to appropriation

2022 Legislative Session Request

 Request \$3.2 million appropriated to OSCA to reimburse clerks for these cases
