JAC Legislative Budget Request 2026 Legislative Session

Justice Administrative Commission

The Justice Administrative Commission (JAC), a state agency created in 1965, provides administrative services to 49 Judicial-Related Offices (JROs) and performs compliance and financial review of billings for services provided by private court-appointed attorneys representing indigent persons and associated due process vendors (court reporters, private investigators, and experts).

In the last fiscal year, JAC processed 327,000+ accounting transactions, including 54,000+ court-appointed attorney and due process vendor invoices, 64,000+ payroll and human resources-related transactions, 10,900+ budgetary transactions, and 558 public records requests. With respect to the state's provision of indigent criminal and civil representation, JAC also contracted with 1,483 registry and indigent for cost attorneys and 646 due process vendors; attended 934 evidentiary hearings for state payment of attorney fees and due process costs; and responded to 13,231 motions for payment of state-funded indigent defense costs. This workload was performed by 93 staff members and a budget of \$12.1 million through its partnership with the Legislature, systemic cross-training of staff, and continuous development and refinement of processes to enhance efficiency, accountability, and customer convenience. It is important to note that JAC exceeds meeting its statutory duties with a budget that represents 0.91 percent of the total appropriations it administers. However, additional resources are needed to continue meeting the agency's statutory requirements to serve our customers, who, in turn, serve the judiciary and the taxpayers of Florida.

JAC's Legislative Budget Request for FY 2026-27 for Executive Leadership aligns with JAC's Vision: To be the model of exemplary state government.

Under the direction of Tara S. Green, Clay County Clerk of Court and Comptroller and Chair of the CCOC Executive Council, we are committed to transparency, efficiency, and excellence in supporting Florida's court operations.

How We Serve

- Educational programs and professional training to enhance court operations and procedural knowledge

LBR Request

For FY 2026-27, the 67 Florida Clerks of Court request \$5.5 million reimbursement for filed Injunctions for Protection, Baker Act, Marchman Act, and Sexually Violent Predator Act cases.

In the most recently completed fiscal year, clerks processed:

- Over 50,000 Baker Act cases
- Almost 9,000 Marchman Act cases
- 59 Sexually Violent Predator cases
- And nearly 80,000 injunctions for protection.
- Injunctions range from Domestic Violence to Dating and Sexual Violence situations.

These cases are not optional; they are statutorily required and time sensitive.

The \$5.5 million reimbursement will help sustain the services provided to some of our most vulnerable populations and help ensure their future protection.

Our thanks goes out to the Legislature for everything that was done last year to support our staff. The Competitive Pay Adjustments, Competitive Area Differential, and Special Pay Adjustments were crucial in reducing turnover and increasing staff retention.

Legislative Budget Priorities

Underfunded Circuits - \$35.5 million

An underfunded circuit is a circuit whose actual percentage of general revenue funding is below its general revenue allocation based on the funding formula.





- The FPAA funding formula is comprised of the following factors:
 - population
 - arrests
 - DUI citations
 - and prison admissions for homicide and robbery

How did we get here:

- No prior instances of "truing up."
- Inconsistent population growth
- Funding outside of the formula



Staffing for Added Judges



Staffing for Added Judges - \$8.7 million

- In FY24/25, the legislature provided 14 additional "criminal" judgeships.
- For the anticipated 14 Criminal Judgeships, the State Attorney Offices needs a total of 76 staff at a cost of \$8.7 million.
- There is a direct workload correlation between the number of judgeships allocation and the number of Assistant State Attorneys and legal staff required to represent the citizens of Florida.



Staffing Needs – 76 Staff for 14 Judges

- Approximately 3 Assistant State Attorney Per Judge
- Approximately 2 Attorney support
- Numbers were determined by a survey of all circuits





VOCA FUNDING

Victims Of Crime Act (VOCA)- \$8 million

This federal funding continues to dimmish and can no longer be a reliable source of funding for our Victim Services programs.

\$8 million is required within general revenue to allow us to become fully funded off state resources.





DUE PROCESS DEFICIT

Due Process


This issue is within the Justice Administrative Commission budget and the FPAA is in full support of this critical item. Due Process funding covers the expenses that are incurred for case prosecution and investigation. It is projected that funding will be \$2.5 million short for fy26/27 (this appropriation was lasted adjusted in 2017).



Combined Priorities For Fiscal Year 2026-2027










RATE FOR MINIMUM PAY OF \$63,000 FOR ATTORNEYS

- The State Attorneys and Public Defenders hire at competitive pay that we can not match with our minimum pay rate.
- \$44,125 is the current minimum for RC attorneys which no attorney can be hired at that rate.
- This will mostly be a rate change. We currently have very few attorneys below the \$63,000 pay rate. There will be minimal compression issues.

Capital Collateral Regional Counsels

Legislative Budget Request 2026-2027

Capital Collateral Regional Counsels

- Florida Statute 27.702 requires the Capital Collateral Regional Counsels (CCRCs) to represent death sentenced inmates in the state and federal courts, including the United States Supreme Court, until relief is granted or the sentence of execution is carried out.
- There are three offices, North, Middle and South and cases are assigned by the Florida Supreme Court after the direct appeal and are based on the jurisdictions of the Federal District Courts.
- CCRC offices employ a team concept of assigning a first and second chair attorney and investigator to each case as it proceeds through the postconviction process.

The Total General Revenue budget request for all CCRC offices combined for the 2025-2026 fiscal year is \$1,283,764.92.

 While each CCRC office face similar problems, each region has its own unique issues as it relates to the budget. Significantly, both the Capital Collateral Regional Counsels for the Northern and Middle Regions have experienced an increase in caseload, while the CCRC-South has experienced challenges due to a continued rise in cost of living.

CCRC-North

- \$405,873 (recurring) Additional Workload (Salary and Benefits)
- \$180,000 (recurring) Additional General Revenue (Case Related Costs)
- \$15,121.92 (recurring) Rental Increase

CCRC-North has experienced a 50% increase in caseload since FY 2020-21. CCRC-North is requesting 3 additional positions to handle the 50% increase in caseload since the beginning of FY20-21, as well as the new capital postconviction cases that CCRC-North is anticipating this current fiscal year. The three positions are lead attorney, second-chair attorney, and investigator. The total amount of salary and benefits requested is \$405,873. Additionally, CCRC-North anticipates \$180,000 would be needed in additional Case Related funding in General Revenue to properly and adequately review and represent the additional CCRC-North cases.

CCRC-Middle

- \$281,780 (recurring) Additional Workload (Salary and Benefits)
- \$32,920 (recurring) Rental Increase
- \$75,000 (recurring) Additional General Revenue (Case Related Costs)
- \$81,166 (recurring) Competitive Area Differential

CCRC-Middle has seen an increase in case assignments, new cases having more than doubled. Due to the increased workload associated with these significant increases CCRC-M requests an additional \$281,780.00 in salary and benefits in order to reclassify two existing vacant positions and hire two additional attorneys. To further address the increase in workload, CCRC-Middle is requesting \$75,000 in case related costs.

CCRC-South

• \$211,904 (recurring) Competitive Area Differential

Last year, the legislature recognized the high cost of living in South Florida, providing for a Competitive Area Differential (CAD) with substantial increases in salary and benefits for State Attorney Offices in the 6th, 11th, 13th, 15th, 16th, 17th, 18th and 20th circuits. Every state attorney circuit within the jurisdictional boundaries of CCRC-South received the CAD. CCRC-South competes with other similarly situated state agencies, including the state attorney offices within CCRC-South's jurisdiction, for legal, investigative and support staff talent. Appropriating a competitive area differential to every state attorney office in the South Florida area, while not funding a similar increase to CCRC-South, creates an unequal playing field further hindering CCRC-South's ability to recruit, and retain, critical staff.

- Turnover is rising among child advocate managers: 19.8% to 25.3% in 2 years



THE CHALLENGE

CLOSING THE PAY GAP TO ATTRACT AND RETAIN SKILLED PROFESSIONALS

The Statewide Guardian ad Litem Office aims to stay competitive with peer agencies by reducing and/or moderating salary disparities. Rising vacancies and turnover are putting added strain on existing staff and limiting recruitment in key roles.



ATTORNEYS: On average earn \$3,500 less and nearly 50% of vacancies are attorney positions.

CHILD ADVOCATE
MANAGERS: Certified CAMs
earn \$8,500 less and turnover rose
from 19.8% to 25.3% in two years.

RECRUITMENT: Lower pay limits qualified applicants in smaller labor pools.

RETENTION: Staff leave for higher pay at sister agencies, CBCs or private practice.

Residential Commitment

Capacity

Broward Detention Center Replacement

Uniforms for Staff and Youth

- Covers Class A uniforms for 1,363 staff members and three sets of uniforms for 1,000 youth in detention centers.

FLORIDA PROSECUTING ATTORNEYS ASSOCIATION LEGISLATIVE SUMMARY

As a recap of our September 12th, 2025, board meeting, the following budgetary items were discussed and will be priorities the association will support and lobby for. The order of the issues listed do not indicate the importance of the issue.

FPAA Underfunded Circuits (Issue code 30000080) \$35.6 M

An underfunded circuit is defined as a circuit whose actual percentage of general revenue funding is below its general revenue allocation based on the funding formula. The funding formula is the agreed upon formula that is comprised of population, arrests, DUI citations, and prison admissions for homicide and robbery to determine the allocation of funding. Currently there are 12 circuits that meet the definition of being underfunded. Resolving this underfunding problem cannot be remedied by simply reallocating or redistributing current funding allocations, which would negatively impact and endanger public safety in the circuits that have not been identified as underfunded.

Judgeships:

There is a direct correlation between the number of judges allocated within a circuit and the number of Assistant State Attorneys required to represent the citizens of Florida. When a new judgeship is created, the effect on the State Attorney's Office is not just one of Assistant State Attorney staffing, but a "prosecution team" that is necessary to meet the workload demands.

Victim of Crime Act (VOCA):

As federal funding continues to dimmish, and this can no longer be a reliable source of funding for our Victim Services programs. \$8 million is required within general revenue to allow us to become fully funded off state resources.

Items of Support and Further Review:

Special Risk Class:

Florida Statue 121.0515 established a "Special Risk Class" within the Florida Retirement System. This class is designated for employees in specific job classifications such as: law enforcement, who face physical and mental challenges that could impact their ability to continue performing their duties. Members of this class receive additional retirement credit per years of service, thus, compensating them for the unique demands of their jobs. Assistant State Attorneys (ASAs) are not included in this class designation. As Assistant State Attorneys are working directly with many of these classes, we strongly believe it is only appropriate that they receive the same retirement compensation, thereby increasing their retirement benefit to 3%.

Due Process:

Within the Justice Administrative Commission budget, an LBR issue has been submitted to increase the State Attorney Offices Due Process funding by \$2.5 million. FY25/26 funding is \$10,266,646, spending trends indicate total expenditures for FY26/27 will be approximately \$12,766,646, leaving a shortfall of funding of \$2,500.000.
