Judicial Certification Issues

Funding for FY 2020-21 Judgeships - \$3,567,094 (\$51,788 NR); 22 FTE

Provides funds and FTE necessary for the circuit and county court judges and associated support staff that were statutorily authorized during the 2020 Legislative Session. The judges include:

- Four circuit court judges – two in the Ninth Judicial and one each in the First and Fourteenth Judicial Circuits; and
- Six county court judges – four in Hillsborough County and one each in Orange and Lee Counties.

FY 2021-22 Certification of Need for Additional Judges - \$1,018,433 (\$14,124 NR); 6 FTE

Provides funds and FTE for the judges and associated support staff that were certified by the Florida Supreme Court on December 3, 2020 (Opinion No. SC20-1668, *In re: Certification of Need for Additional Judges*). The judges include:

- One circuit court judge in the Fourteenth Judicial Circuit; and
- Two county court judges in Hillsborough County.

The issue will be submitted through the legislative budget request amendment process.

FY 2021-22 Schedule VIII-B

Impact of 10% Target Reductions (\$57.2 Million)

Approximately 86% of the branch budget is dedicated to salaries. Roughly half of the salary budget funds constitutional positions (e.g., judges, appellate clerks, appellate marshals) and federally funded positions, which are not included in the proposed reduction. As a result, reductions to the salary budget have a disproportionate impact on the non-constitutional and non-federally funded positions.

One-time base budget reductions were included in the exercise and will impact mission critical functions and support to those functions.

Potential impacts to court system users include:

- Delays in managing and processing cases;
- Increases in disposition times and case backlogs; and
- Losses in efficient and effective deployment of resources.

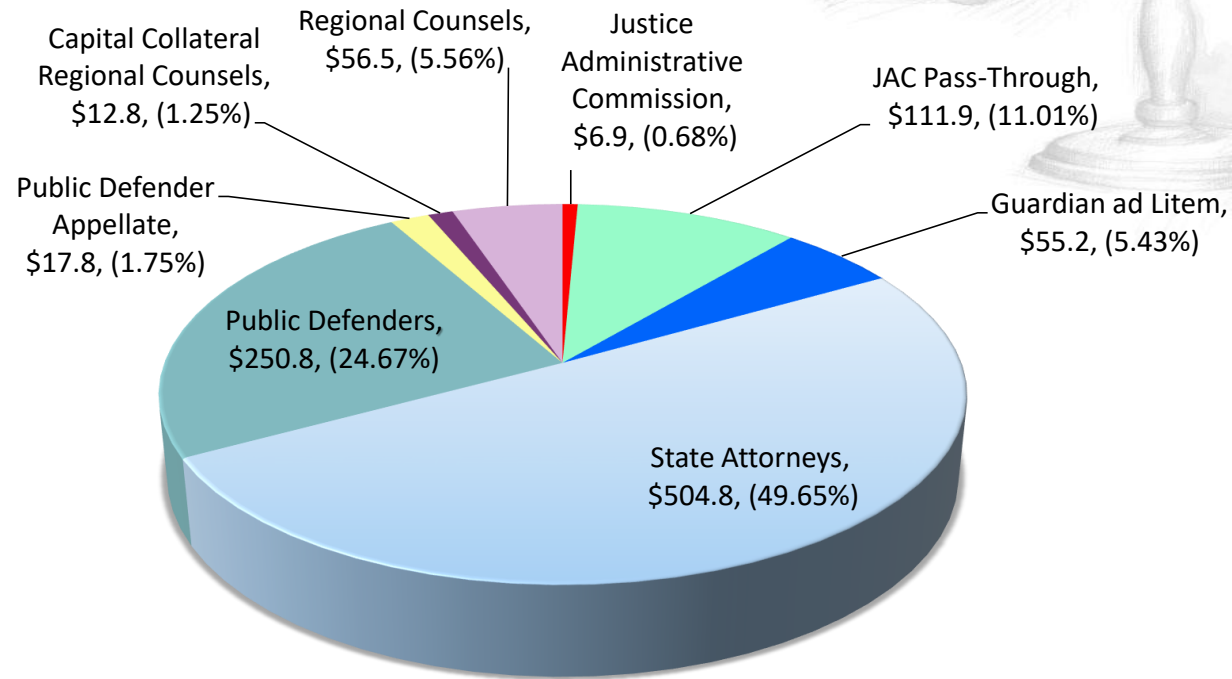

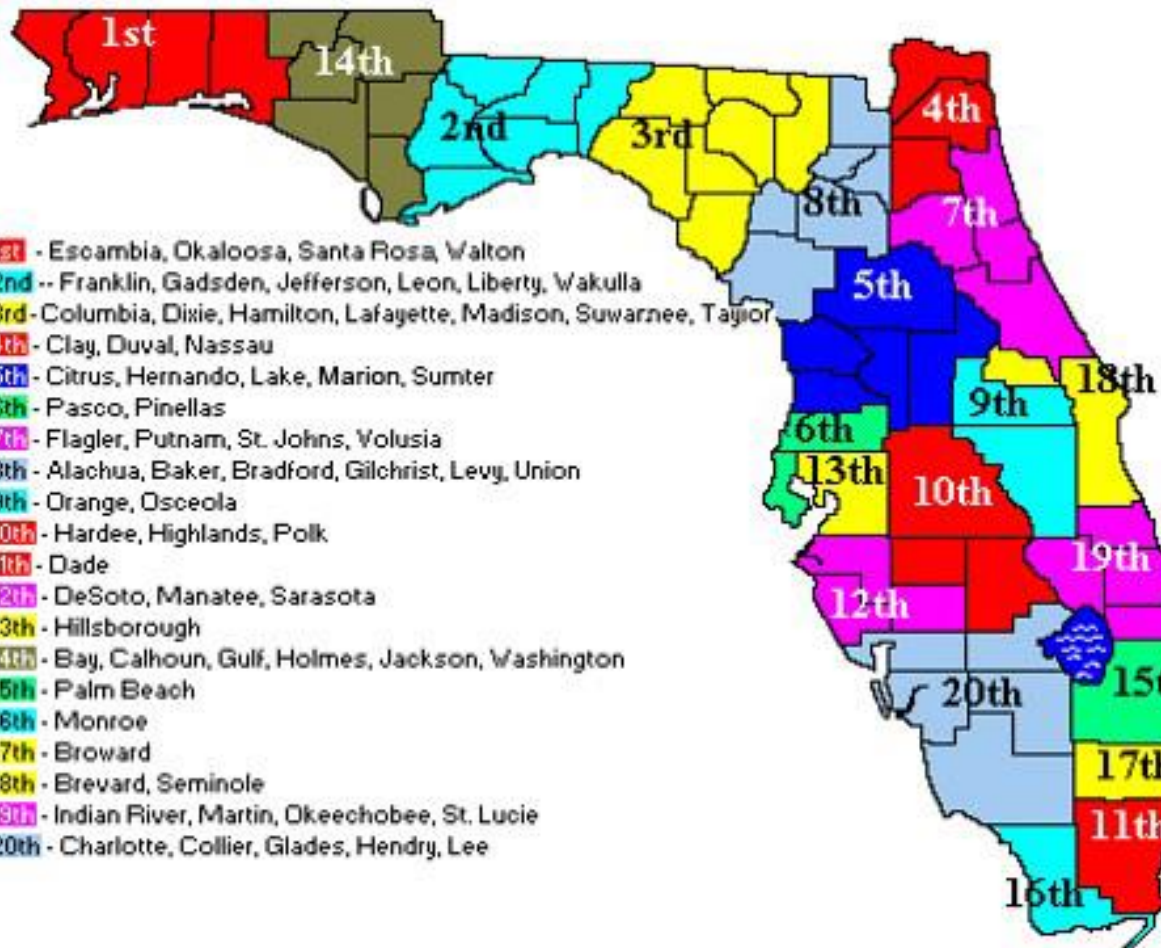

Offices of State Attorney

Florida Constitution Article 5

- ▶ SECTION 17. State attorneys.—In each judicial circuit a state attorney shall be elected for a term of four years. Except as otherwise provided in this constitution, **the state attorney shall be the prosecuting officer of all trial courts in that circuit** and shall perform other duties prescribed by general law; provided, however, when authorized by general law, the violations of all municipal ordinances may be prosecuted by municipal prosecutors. A state attorney shall be an elector of the state and reside in the territorial jurisdiction of the circuit; shall be and have been a member of the bar of Florida for the preceding five years; shall devote full time to the duties of the office; and shall not engage in the private practice of law. State attorneys shall appoint such assistant state attorneys as may be authorized by law.

COVID IMPACTS

- ▶ STATEWIDE SHUTDOWN OF COURTS HAS RESULTED IN BACKLOG OF CASES
- ▶ INCREASING PD CASELOADS STATEWIDE DESPITE DECREASE IN ARRESTS
 - ▶ CASES ARE STILL COMING IN BUT CANNOT BE RESOLVED
 - ▶ INCREASE IN PENDING CASES SINCE MARCH OF 2020:
 - ▶ PD 11 (MIAMI-LARGE CIRCUIT SIZE) HAS EXPERIENCED A 52% INCREASE
 - ▶ PD 5 (OCALA AREA-MEDIUM CIRCUIT SIZE) HAS EXPERIENCED A 59% INCREASE
 - ▶ PD 8 (GAINESVILLE AREA-SMALLER CIRCUIT SIZE) HAS EXPERIENCED A 30% INCREASE

CONTINUED COVID IMPACTS EXPECTED

- ▶ **BACKLOG OF CASES WILL CONTINUE EVEN AFTER COURTS FULLY REOPEN**
 - ▶ ANY FUTURE COURT SHUTDOWNS WILL STALL MOVEMENT OF CASES
- ▶ **BACKLOG OF CASES GREATLY INCREASES COSTS FOR COUNTIES**
 - ▶ INCREASES IN DAILY INMATE POPULATION OF COUNTY JAILS
 - ▶ COSTS PER INMATE CAN BE AS HIGH AS \$233 PER DAY
- ▶ **SPEEDY TRIAL RULE HAS BEEN SUSPENDED**
 - ▶ UNTIL IT IS RESTORED, TRIAL CASES WILL CONTINUE TO BACKLOG
- ▶ **STATE ATTORNEYS ARE NOW GOING FORWARD WITH CASES THAT WERE PREVIOUSLY HELD BACK DUE TO COVID SHUTDOWN**
- ▶ **ICDTF REVENUE COLLECTIONS ARE EXPECTED TO CONTINUALLY DECLINE UNTIL THE ECONOMY RECOVERS. THE DECREASE IN COLLECTIONS WILL SUBSTANTIALLY HINDER THE USE OF TRUST FUND AUTHORITY BY CIRCUITS**

FY 2021-22 BUDGET PRIORITIES

- ▶ **MAINTAIN CURRENT FUNDING LEVELS**
 - ▶ **RELEASE 6% HOLDBACK**
 - ▶ **ANY FINAL REDUCTION TO FY 2020-21 FUNDING BE NON-RECURRING**
 - ▶ **NO GR REDUCTION IN FY 2021-22**
 - ▶ **MUST BE ABLE TO DEAL WITH BACKLOG OF CASES**
- ▶ **INCREASE IN NON-RECURRING FUNDING TO DEAL WITH BACKLOG**

BUDGET REDUCTION EXERCISE

- ▶ OUR BUDGET IS DEVOTED TO SALARIES AND BENEFITS (94%)
- ▶ DO NOT HAVE 'PROGRAMS' OR 'FACILITIES' TO CUT
- ▶ ANY % REDUCTION = REDUCTION IN STAFF
 - ▶ 10% REDUCTION (\$27 MILLION) = APPROXIMATELY 16% OF STATEWIDE FTE
 - ▶ 8% REDUCTION (\$24 MILLION) = APPROXIMATELY 12% OF STATEWIDE FTE
 - ▶ REDUCTION IN PUBLIC DEFENDER STAFFING RESULTS IN DELAYS AND FURTHER BACKLOG

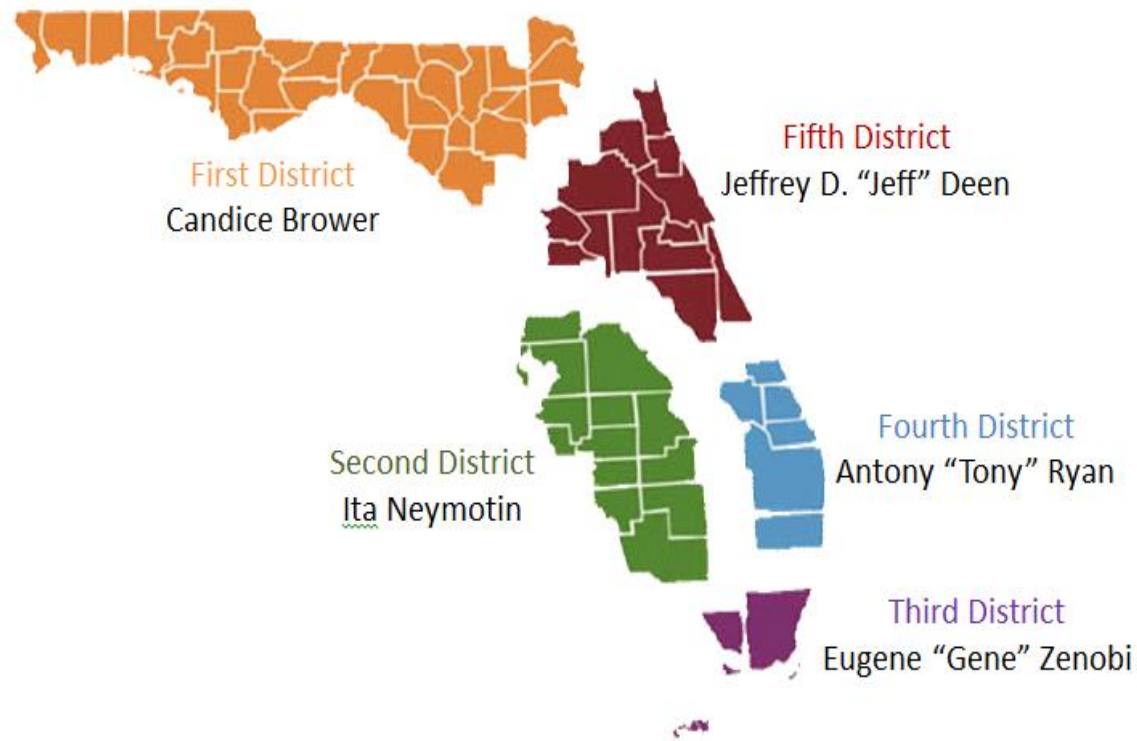

RCs - Who, What & When

- The Regional Counsels were established in 2007 to save and control funding allocations by the state for constitutionally or statutorily mandated indigent legal representation.
- Civil and Criminal:
 - The RCs represent court-appointed indigent clients in *criminal* cases when the Public Defenders have a legal conflict of interest (co-defendants is the most common example); the RCs have secondary responsibility to the PDs in criminal cases.
 - The RCs have primary responsibility in most *civil* cases in Florida in which indigent clients are entitled to court-appointed counsel; the vast majority of civil clients are parents in Dependency and Termination of Parental Rights cases (child neglect cases initiated by DCF); the RCs also act as court-appointed counsel in Guardianship, Marchman, and Adult Protective Services cases.
 - Savings
- Since inception, Regional Counsels have saved the state **\$368 million** and counting

Offices of Criminal Conflict & Civil Regional Counsels (RCs)



RCs – FY 2021-22 Collective Priorities (RCs 1, 3, 4, & 5)

1. Maintain current appropriations. Dependency & TPR proceedings have continued uninterrupted by the pandemic; the costs of criminal cases have not abated and criminal caseloads have increased with jury trial backlog.
2. Rent increases of \$144,500 for privately rented professional office space:
 - Unlike other JRO's who are funded by the counties, the RCs must rent commercial office space that are mostly multi-year leases with annual increases. Failure to fund these increases would result in a deficit.
3. Strategically target any reductions by category and avoid across the board cuts.

RCs – FY 2021-22 RC 2 Priorities

- Six (6) FTE dependency attorneys and two (2) Forensic Social Workers - \$598,605 (Salary & Benefits)
- A Cross Jurisdictional Death Penalty Program Budget Proposal - providing death penalty litigation across the State of Florida at reduced costs, when compared with private registry counsel - \$4,317,198
- CLE education, including *ets Lean Six Sigma*, in-house with substantial savings for taxpayers - \$75,000

RCs – Schedule VIII-B2

- Reduction of \$5.5 million.
- Reduction of approximately 75 FTE among the RCs.
 - This would result in inability to handle cases or result in closing offices. For example, RC1 would have to eliminate 19 positions and would be unable to handle approximately 4,200 cases.
- **Any** budget cuts to the RC's will affect operations and will translate to the Regional Counsels not being able to handle as many cases. The State's obligation to pay for lawyers will continue however, so more cases would have to return to the private registry. Cutting the Regional Counsel's budgets will ultimately result in costing the State *more* for the court-appointed private attorneys.

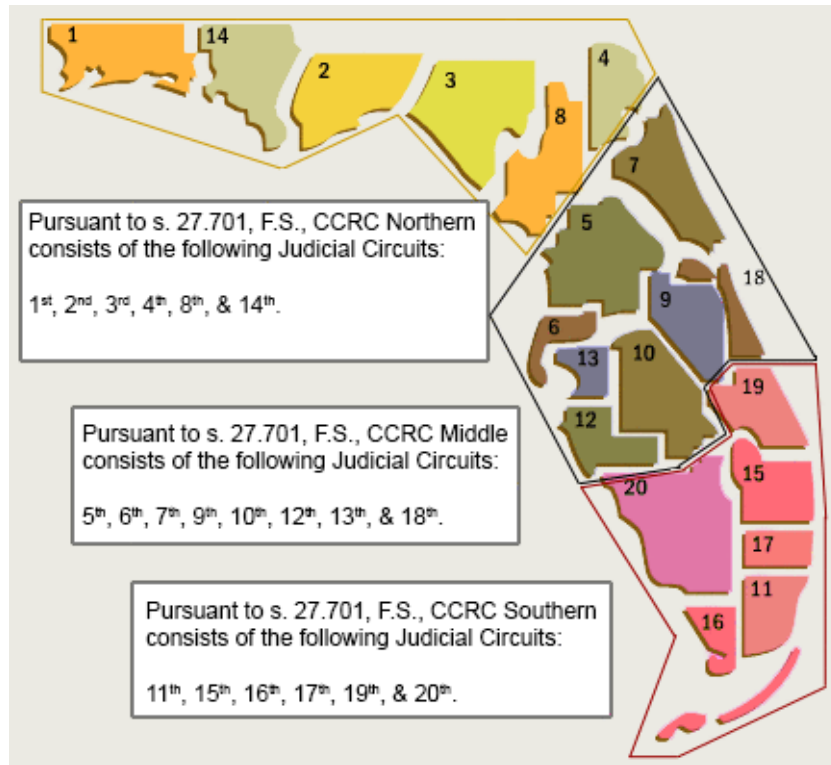

Capital Collateral Regional Councils (CCRCs) – Who We Are

- Section 27.702, F.S., requires the CCRCs to represent death sentenced inmates in the state and federal courts, including the United States Supreme Court, until relief is granted or the sentence of execution is carried out.
- There are three offices (Northern, Middle, and Southern), and cases are assigned by the Florida Supreme Court after the direct appeal and are based on the jurisdictions of the federal district courts.
- All CCRC attorneys must have expertise in the highly complex area of Federal Habeas Corpus, and are required by Rule 3.112(k) Florida Rules of Criminal Procedure to have extensive experience in capital case litigation.

CCRCs – FY 2021-22 Collective Priority

The total budget request for all three CCRC offices combined for the FY 2021-22 is \$51,126 broken down as follows:

- **CCRC – Northern Region – \$14,113 (Rental Increase)**
- **CCRC – Middle Region – \$18,413 (Rental Increase)**
- **CCRC – Southern Region – \$18,600 (Rental Increase)**

CCRCs – Schedule VIII-B2

Reduce Staff: Seven FTEs:	\$466,629
Reduce Case Related Costs:	420,316
Reduce Operating Expenditures:	179,379
Reduce OPS:	45,500
Reduce Trust Fund	12,480
Total:	<u>\$ 1,142,304</u>

- The 10% reduction to CCRC budgets would greatly affect their ability to timely process cases, meet time standards set by the state and federal courts, as well as hamper their ability to meet legislatively created performance measures. If the CCRCs cannot handle cases due to a 10% reduction, the cases would be assigned to private attorneys on the capital case registry, which represents a cost shift, **not a cost savings**, since registry attorneys are paid out of state funds.
- If a reduction becomes necessary, the CCRCs are requesting they be allowed to target the reductions between categories, rather than be subjected to across the board cuts.

Guardians ad Litem represent abused, abandoned and neglected children through a multi-disciplinary, best-interest model in Florida's dependency court system. Florida has more than 10,000 volunteers statewide who advocate for the best interests of children.

- JAC is looking to work with the Legislature on the required reductions to minimize the impact on our operations.

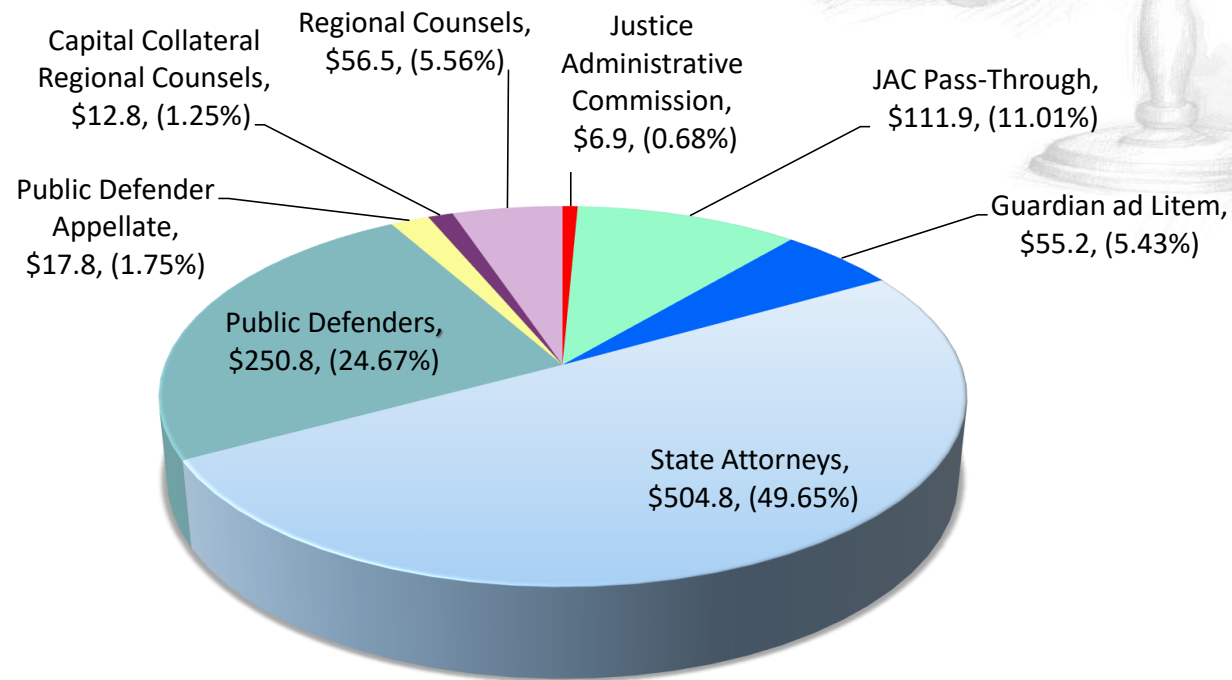




Schedule VIII-B2 for Agencies of Justice Administration

FY 2020-21 Base Budget by Entity Group - \$1.01 Billion

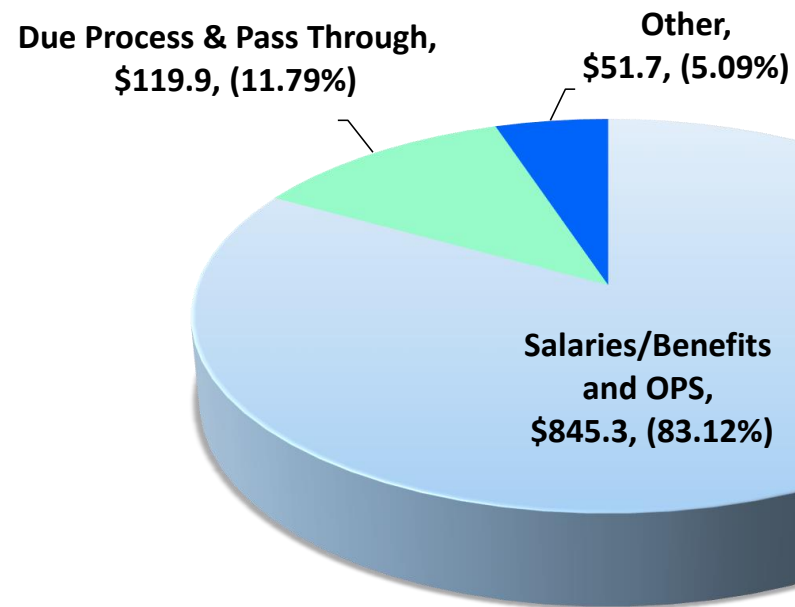

Schedule VIII-B2s

- Across the agencies, reductions of \$85.3 million in General Revenue and \$11.7 million in Trust Funds were proposed to hit the 10% target.
- As the agencies are primarily made up of Salaries/Benefits and OPS, the proposed reductions are primarily in those areas, which, if implemented, would severely impact their ability to prosecute crime, represent indigent clients and death row inmates, represent children in foster care, and administer these constitutional and statutory responsibilities.
- As mentioned, given the significant backlog of criminal cases that is building up due to the pandemic, our staff, due process, and other expenditures will be critical to meet the needs of these offices.
