Fiscal Year 2022-2023

- DEO was appropriated \$50 million for the Governor's Job Growth Grant Fund (JGGF).

Under Governor DeSantis:

- **\$134,601,832 has been awarded to 41 projects.**

In September of 2022, \$6.7 Million was granted to four state colleges to increase capacity of Commercial Driver's License training programs to more than 3,500 students per year.

- **\$488.4 million** allocated to State of Florida by US Treasury
- In September 2022, Legislative Budget Commission approved **\$142.3 million** for tranche 1

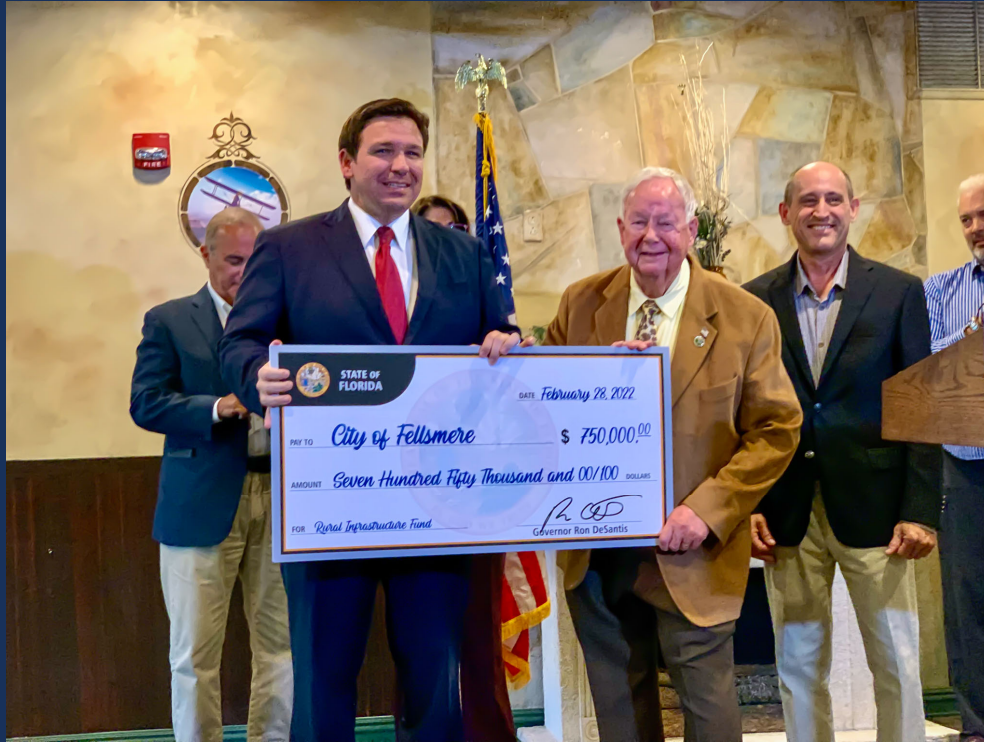

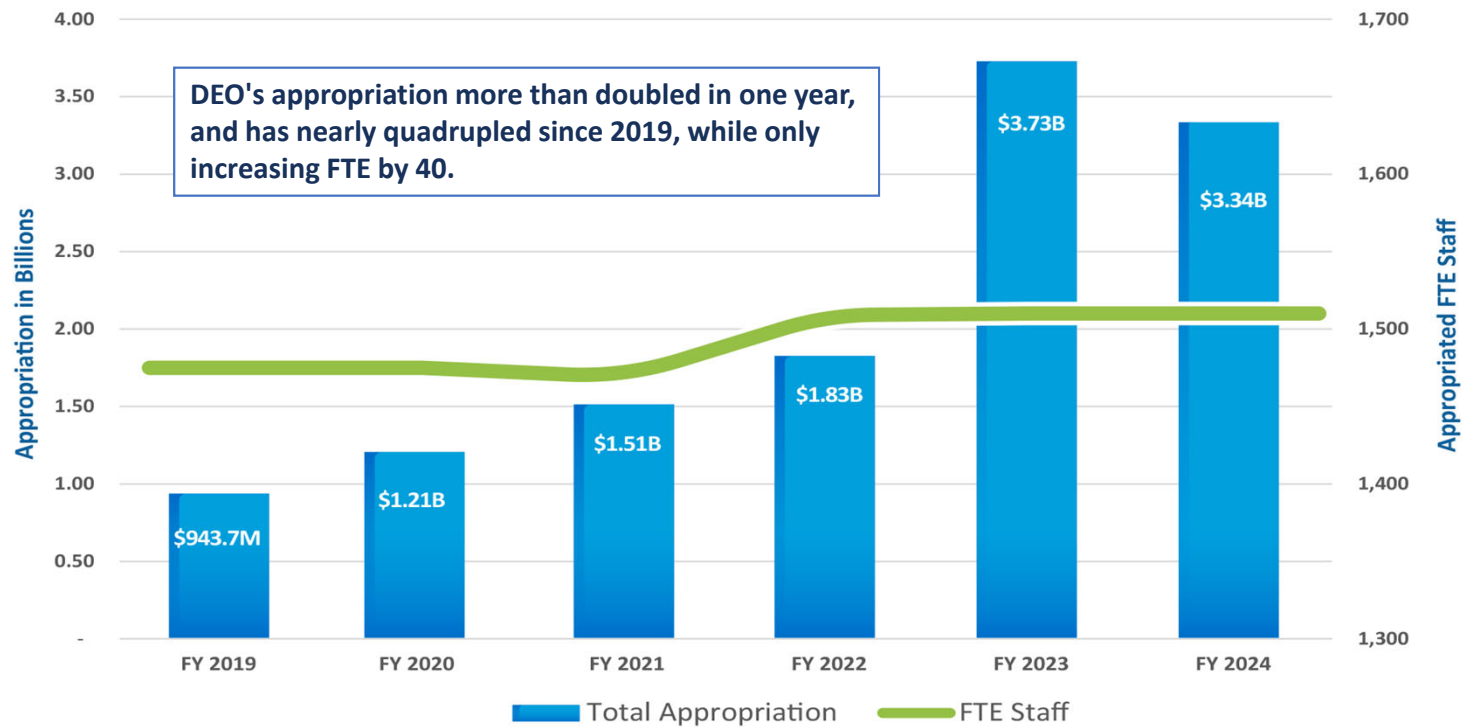

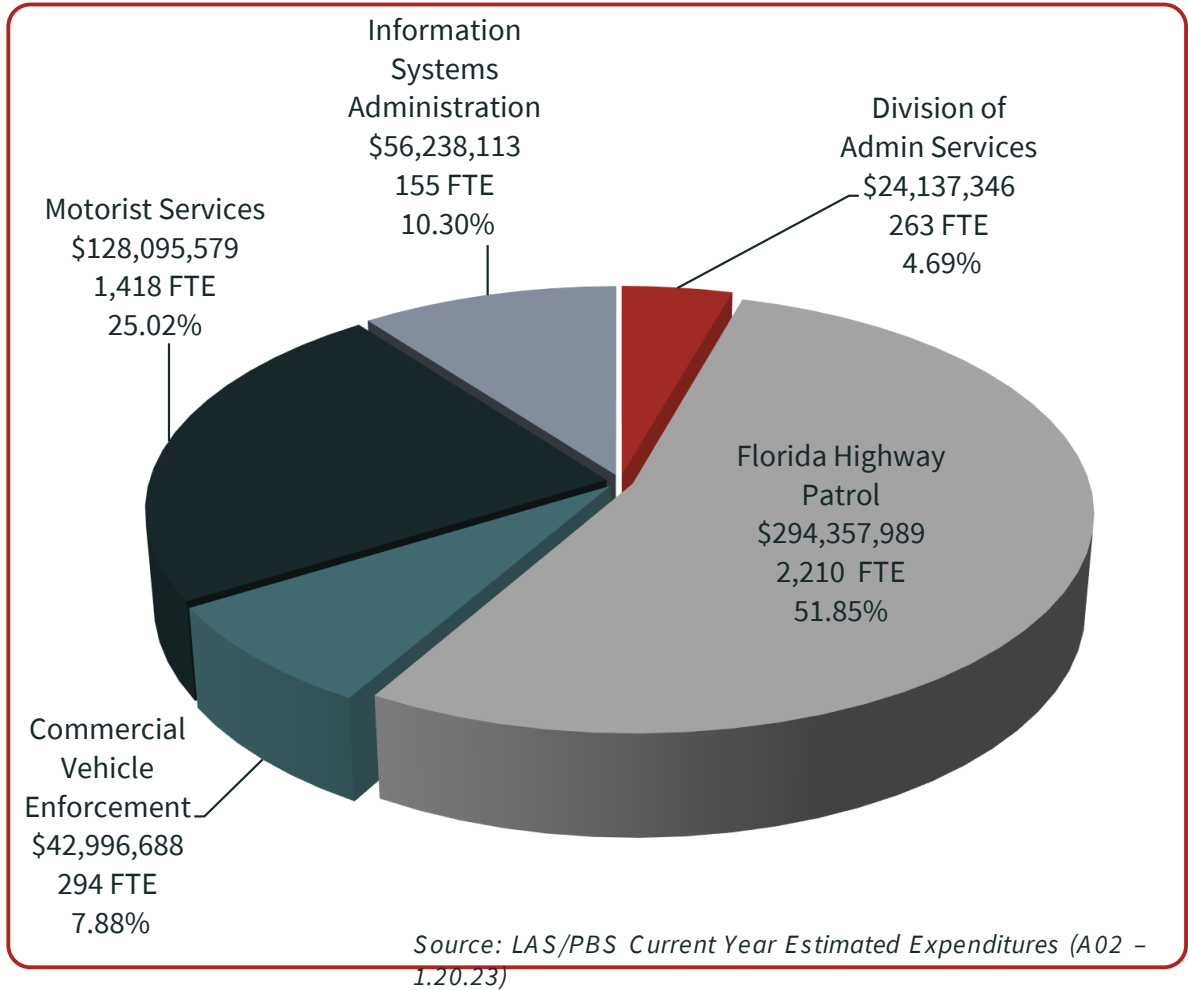

Florida Highway Patrol

Salary & Benefits: \$13.5M

Budget is requested to continue to fill positions due to higher than anticipated interest in joining the Florida Highway Patrol.

- Due to the historic pay increases and unprecedented interest in the Florida Highway Patrol, FHP must hold positions vacant to ensure the current budget authority is not exceeded;
- This budget request would allow FHP to continue to fill Trooper positions that protect Florida's roadways;
- This budget will also help retain highly valued and qualified employees, which reduce costs associated with recruitment, training, risk management, and civil litigation; and enable FHP to recruit more highly qualified new members.

Motorist Modernization

Phase II - \$10M

- Phase II of Motorist Modernization is the second step in the modernization effort and represents the re-engineering and re-development effort of the systems and processes supporting motor vehicle systems, which include:
 - Titles, Registrations, International Fuel Tax Agreement (IFTA), International Registration Plan (IRP), vehicle inspections, parking permits and database re-design;
 - Enterprise Content Management Study (ECM); and
 - Mobile Driver License (mDL) or Florida Smart ID; including electronic motor vehicle registration and insurance information
- Phase II will achieve the goal of creating one comprehensive system that handles driver and motor vehicle issuance for the State of Florida.

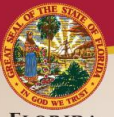

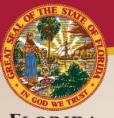
Division of Elections

- Voter Education Campaign for 2024 election cycle
 - \$500,000 nonrecurring General Revenue in the Expenses category
 - Statewide Voter Education
 - 25% of the materials will be in Spanish.
 - 75% of the materials will be in English.
 - Statutorily required program to train poll workers about voters with disabilities.
- Elections Signature Verification
 - \$100,000 nonrecurring General Revenue in the Contracted Services category
 - Statutorily required signature verification training program for duties relating to processing voter registration applications and counting or rejecting vote-by-mail ballots, provisional ballots, candidate petitions, and initiative petitions. It is also used to identify fraudulent activities.
 - Online program for signature verification training.
 - Testing and certification



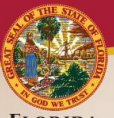

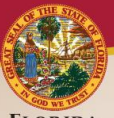

Overview of FDEM Core Programs

Preparedness

- Administers Florida's All-Hazards planning programs to ensure the State Emergency Response Team (SERT) is prepared.
- Facilitates prompt and efficient response and recovery.
- Protects lives and property impacted by disasters.
- Coordinates training courses for counties and first responders.

Response

- Monitors incidents that may require State response.
- Manages 24/7 State Watch Office.
- Oversees Logistics vendor management and resource deployment.
- Supports State Emergency Response Commission through Tech Hazards Unit– *Nuclear Power Plants*.

Recovery

- Works to maximize federal disaster assistance to eligible public-sector partners and residents.
- Administers recovery funding such as Public Assistance, Individual Assistance, CARES Act and American Recovery Plan Act.
- Paid out over \$7 billion in recovery funding to local governments.

Mitigation

- State Coordinating Agency of the National Flood Insurance Program.
- Administers FEMA's Hazard Mitigation Grant Program.
- Administers FEMA's Building Resilient Infrastructure and Communities Program.
- Provides technical assistance to counties developing and implementing local mitigation strategies.

Finance

- Provides all financial support, from procurement to payment, of all programmatic areas of the Division, with our approved legislative budget and declarations of approximately \$3.7 billion.

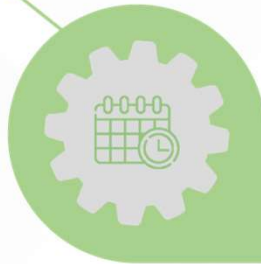

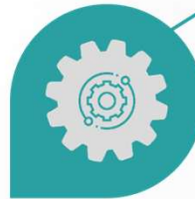

2023-2024 Legislative Budget Request

FTE Salary Rate Parity: Increase the salaries for 197 FTEs to be more competitive with local, state, federal, and private counterparts performing similar functions. This will assist in the retention of employees as DEM has an extremely high turnover rate of 61%.

- **Request: \$4,999,746**

OPS to FTE Conversion: Conversion of 35 Other Personal Services (OPS) temporary positions to FTE permanent positions that are performing permanent functions.

- **Request: \$1,778,257**

Enterprise Business Solution: Funding for Year One implementation to modernize grant management, business processes, systems issues, and digitization projects.

- **Total: \$6,811,050**

Information Technology Sustainment: Funding for all information technology operating costs related to responding and maintaining the operational readiness of the State Emergency Operations Center, addressing annual increases in costs due to market drivers.

- **Request: \$5,580,258**



2023-2024 Legislative Budget Request

Recovery Compliance Positions: Funding to provide staffing for 15 FTEs and operating costs to address compliance, monitoring, standardization and risk abatement regarding federal funding.

- **Request: 15 FTEs, \$2,728,410**

Expansion of Regional Coordination Team: Funding to expand the regional coordination team from seven regions to ten regions and add six FTE to meet the increasing local response and technical assistance demands placed on the Division.

- **Request: \$1,212,242**

Fund Shift from Operating Trust Fund to General Revenue: Fund shift from the Operating Trust Fund to General Revenue of salaries and benefits, other personal services, and expense dollars to support existing requirements. The cost of this issue is \$600,000 in General Revenue on a recurring basis until there is adequate revenue from fees to operate the Technological Hazard's program.

- **Request: \$600,000**

Mitigation Risk Reduction Initiatives: Funding for five mitigation projects to improve the resiliency of communities, avoid future flooding losses, and reduce the need for federal disaster funding.

- **Request: \$15,638,498**
