Here is a response to the legislative questions. Please let me know if you have any questions or concerns.

In the past five years, our research has not shown any disciplinary cases that were overturned by an appeals court. There are also no cases that have been overturned by an administrative law judge (ALJ). However, since ALJs do not "overturn" disciplinary decisions, this question is not clear. There have been cases where probable cause was found and an administrative complaint filed, and the ALJ subsequently recommended that the case be dismissed. In the past 5 years, 3 such cases have been dismissed.

To the additional questions about finding probable cause:

The Board's probable cause panel, which is made up of experts in the field and a consumer member, evaluate the cases, including consideration of the prosecutor's recommendation, and if an Administrative Complaint is to be filed, typically a report from an expert witness. The panel then independently evaluates the cases and makes a decision. The recommendation from the Department is only one of many factors which are considered in determining whether or not probable cause is found by the panel. The Board is charged with the interpretation of its own rules, and in fact, on matters specific to its particular rules, is given deference in the interpretation of them, by both Administrative Law Judges and Appellate Courts. (see generally Bd. Of Podiatric Medicine v. Fla. Medical Association, 779 So. 2d 658, 660 (Fla. 1st DCA 2001) (Noting that the administrative law judge should not have rejected the Board's definition of "human leg.")

Also, the statistics for finding probable cause for this profession are similar to other professions regulated by the Department. There are several reasons that probable cause is not found in cases. Many concerns raised in a complaint are not within the jurisdiction of the Department to resolve. Another reason is that some claims are not properly documented with sufficient evidence to move forward to the filing of an administrative complaint.

On the reason why the Probable Cause Panel (PCP) only finds probable cause (PC) in 12% of the cases. I would attach the three pages with the statistics for all the Boards. Interestingly, the fiscal year report for 2009-2010, shows that out of 36 cases that were found to be legally sufficient, 25 had probable cause found – which is 69.44%, not 12%. Fiscal year 2008-2009 had 27% of the cases where PCP was found. For Fiscal Year 2010-2011, of the 48 cases that were legally sufficient, probable cause was found in 34, which results in 70.8%.

## I. Summary:

Senate Memorial 672 urges Congress to propose to the states an amendment to the U.S. Constitution limiting the number of consecutive terms that a U.S. Senator or U.S. House Representative may serve.

A memorial has no force of law; it is a mechanism for formally petitioning the U.S. Congress for action on a specific subject.

### II. Present Situation:

In 1992, Florida voters adopted the so-called "eight-is-enough" amendment to the State Constitution, prohibiting federal senators and representatives from Florida from having their name appear on the ballot if they served 8 consecutive years in office. Similar limits were adopted on federal office holders in numerous other state constitutions as part of a nationwide initiative. In 1995, however, the U.S. Supreme Court invalidated these state attempts to impose term limits on federal office holders, finding that they violated the qualifications clauses of the *federal* Constitution.<sup>2</sup>
