# Culture War Session

It was Tuesday, March 7th in Florida's Capital City. The day had started beautifully - the skies blue, with just enough shade to keep residents and visitors on the ground feeling good. Lawmakers and legislative staff started to arrive at the Florida Capitol Building, an appearance that was more frequent than usual with back-to-back special sessions under their belt. But despite the day outside, a storm was brewing inside the Capitol building.

In the last few days before the legislation filing deadline, a salvo of bills were published, representing an attack on minorities and the vulnerable. And in the last few minutes before the opening day ceremony began, an abortion ban appeared that would set Florida back 50 years in women's reproductive rights.

Over the course of the past few years, the political atmosphere across the nation has turned particularly negative. Florida's leadership has embraced the targeted

rhetoric with dangerous policies that attack constitutional rights, freedom of speech, academic freedom, the LGBTQ community, immigrants, and local governments, to name a few. **Florida's Senate Democrats** - a small but mighty group of 12 in the 40-member Senate - took on the challenge to stand up for *everyone's* right to live a free, prosperous and safe life.

# 04 Permitless Carry

HB 543, sponsored by Senator Jay Collins in the Senate, goes against both common sense and public safety. It encourages untrained people to carry guns. While some supporters refer to it as "constitutional carry", Florida has been following the Constitution. Those who want to carry a concealed firearm can do so now, as long as they're trained and legally able to. This new law encourages recklessness – with people's lives as the ultimate price.

Here are three amendments offered by Democrats that were ultimately rejected:

- Make sure concealed carry holders are trained on gun safety
- Create a community violence task force to review crime and violence in urban communities
- Expose hypocrisy of this law - ask
   Republicans if they would allow people to carry a concealed weapon for any meeting of the Legislature

6 weeks. That's the maximum amount of time Florida leadership believes women need to make the personal decision to terminate their pregnancy. Reality check: 75% of Floridians disagree with this extreme policy.

Last year, with no scientific explanation, lawmakers shortened the abortion window to 15 weeks. And while the Supreme Court considers whether that law violates Florida's constitutional right to privacy, lawmakers rushed to shorten the abortion window again - to 6 weeks with SB 300, sponsored by Senator Erin Grall.

If the 15-week ban prevails in the Florida Supreme Court, Florida's 6-week ban will take effect.

SB 300 is essentially an all-out abortion ban

#### More than a dozen amendments were offered, including:

**Democratic Leader Lauren Book's amendment** would have renamed "The Heartbeat Protection Act" to something more scientifically accurate: "The Electrical Activity that can be Manipulated to Sound like a Heartbeat through Ultrasound **Protection at the Expense of Pregnant** People's Health and Wellbeing Act".



**Senator Geraldine** Thompson's amendment Senator Tina Polsky's would have allowed an exemption for women under threat of domestic violence.

amendment would have allowed for a religious exemption.



**Senator Lori Berman's** amendment would have added regulations for fake abortion clinics. requiring them to at a minimum have a licensed ultrasound tech.



An amendment by **Senator Tracie Davis** would have diverted money from fake abortion clinics for family planning & minority maternal mortality programs.



Governor DeSantis signed SB 300 quickly, late at night and in the privacy of his office, with anti-abortion supporters clapping on.

# Higher Education

SB 266: Higher Education

Sponsored by Senator Erin Grall (R), Fort Pierce

This bill limits academic freedom and impacts hiring practices at Florida's public universities and colleges.

- Bans funding on programs and initiatives that are based on diversity, equity and inclusion
- Reviews academic programs and bans general education courses that are "based on theories that systemic racism, sexism, oppression, and privilege are inherent in the institutions of the U.S. and were created to maintain social, political and economic inequities"
- Revises hiring authorities, preempting tenure review processes to the state instead of each school
- Allows political appointees to govern everyday university hiring decisions

## Universal Private School Vouchers

#### **HB 1:** Private School Voucher Expansion

Sponsored in the Senate by Senator Corey Simon (R), Tallahassee

#### What They'll Tell You:

Expands the state's private school voucher program to all K-12 students.

#### What They Won't Tell You:

#### No Accountability or Transparency for Private Schools

#### Impact on Traditional Public Schools

Bottom line: this bill impacts public education funds. It is an experiment that we've seen fail in other states, with families and students on the line.

## Access to Courts

HB 837, sponsored by Senator Travis Hutson in the Senate, was the first bill signed during the 2023 legislative session. This bill will drastically impact the court system - potentially limiting access to the courts in cases against property, health and car insurers. Some of the changes:



- Reducing the statute of limitations for negligence from 4 to 2 years
- Raises the bar to pursue bad faith insurance claims litigation
- Limits recoverable damages for medical treatment or service expenses
- Only allows people to recover damages in personal injury or wrongful death claim if they were less than 50% at fault for the harm

# Bottom line: this legislation prioritized big corporations over everyday people.



#### SB 254: Gender Affirming Care

Sponsored in the Senate by Senator Clay Yarborough (R), Jacksonville

Anti-LGBTQ Bills

This bill is about government intrusion in Floridians' personal medical decisions. It goes against freedom and parental rights, restricting trans children from seeking trans treatment, medicine and care.

And it doesn't stop at young people - it restricts where trans adults can get treatments.

Despite the many testimonies from trans people and allies against the bill, it still passed.

# Anti-LGBTQ bills

#### HB 1069: Bathroom Bill Sponsored in the Senate by Senator Erin Grall (R), Fort Pierce

This bill targets the trans community - making it a second-degree misdemeanor crime for trans people to simply use the bathroom.

This bill is bound to encourage discrimination and cause confusion based on how people look.



"I saw a trans man testify who has a full beard in every way, shape and form...Is he supposed to go into the women's restroom?"



"The law as written in the bill would require a person to use a facility of their sex at birth or use a unisex facility."



"So the security guard is supposed to say 'Get out, you're in the wrong bathroom" and the trans man says no - is that the way the scenario will go?"

# DeSantis vs. Disney

# Anti-Immigration Bill

<u>SB 1718</u>, sponsored by Senator Blaise Ingoglia, is an anti-immigrant bill pushed by the Governor in his quest to use vulnerable people as pawns in his political game.

#### Some of the changes:

- Creates stricter penalties for private businesses that hire undocumented workers
- Invalidates out-of-state licenses given to undocumented immigrants
- Requires hospitals to collect data about undocumented patients
- Adds another \$12 million for the misguided migrant flight program

### 16 Medical Discrimination

#### SB 1580: Protections of Medical Conscience

Sponsored by Senator Jay Trumbull (R), Panama City

This bill allows doctors, nurses, residents, and groups that provide health coverage to opt out of providing or paying for a health care service on the basis of a conscience-based objection based on a sincerely held religious, moral, or ethical belief.

It also prohibits medical boards from disciplining doctors based on their speech.



#### **Three Amendments:**

#### **Protect Patients From Discrimination**

This amendment would have added "pregnancy, age, disability, marital status, sexual orientation or gender identity" to section outlining what doctors couldn't discriminate against

# Elections Bill

**Another year, another complicated & unnecessary bill to change Florida's elections system. Here's what <u>SB 7050</u>, sponsored by
Senator Travis Huston, <b>does:** 

- Targets voter engagement groups
- Adds more unfunded & burdensome requirements for local Supervisors of Elections
- Paves the way for the Governor to run for President without resigning to run

#### Four common sense amendments offered by Democrats:



Parity on resign to run - allow any Florida elected official to run for federal public office without having to resign



Make vote-by-mail more accessible to voters with disabilities



Only send voter ID cards to eligible voters



Delete unfunded mandate for local supervisors to identify registered voters with felony convictions whose rights haven't yet been restored a job better left to the state

# Secret Governor Flights

SB 1616, sponsored by Senator Jonathan Martin, is a public records exemption that will essentially shield all information related to "security and transportation services" for the Governor.

Senator Jason Pizzo questioned the bill sponsor about potential impropriety:



"Doesn't the public have the right to know if he (the Governor) hitched a ride on a billionaire's jet who has business before the Legislature?" "If it's for political purposes or for personal purposes - then it's exempt. If it's for official purposes, then we get to know who is involved - as long as it doesn't relate to something...that could be used for nefarious purposes."

"Tell me...we're not protecting and covering up the free flights, the favors of donors to the Governor with this bill."

"That's not the reason for this bill."

"The biggest challenge was the slate of dangerous, divisive laws. This was a particularly bad session. Civil liberties and constitutional rights were eroded. Reason gave way to rightwing extremism. A near total abortion ban, permitless carry, attacks on queer children and Floridians, universal private school vouchers, and union-busting legislation all passed. But Democrats did what we could with the tools we had - we used our voice to awaken reason and lead others to act."

That has a profound impact on how we go about our work in Tallahassee."



"A major challenge this session was watching SB 1718, the immigration bill, move through the process. Seeing families pleading for their loved ones, and knowing the damage it will cause to families, businesses, and even consumers in Florida. That was one of the most challenging moments of my legislative career."

# Democrats Working For You Relief for Your Pocketbooks

 Senators passed several tax exemptions to provide Floridians relief at the cash register - including a Permanent Tax
 Exemption for Diapers and Incontinence Products, a proposal sponsored by Leader Book to give families a break from basic necessities for babies and adults.



- There are several tax break holidays this fiscal year - from back-to-school supplies and disaster preparedness to Florida fun, including cultural, creative and outdoor entertainment!
- The tax bill also included a tax break for Firearm Safety Devices - which includes safes, lockboxes, trigger lock and cable locks - important gun safety incentives to help reduce accidental shootings.

# Public Health

KidCare Expansion - Both chambers
 unanimously approved a measure to <u>raise the</u>
 <u>income eligibility requirements for KidCare</u>,
 effectively expanding the subsidized health
 coverage for kids.



- To better help those with sickle cell disease, <u>SB 1352</u>, sponsored by Senator Rouson, will help to better track data and improve outcomes for those diagnosed with the disease. It requires the Agency for Health Care Administration to determine whether current covered medications, treatments, and services for sickle cell disease are adequate to meet the needs of Medicaid recipients.
- HB 829, sponsored in the Senate by Senator Davis, modernizes and makes the Baker Act manual more accessible for those helping others with mental health issues.
- In the fight against the fentanyl crisis, <u>SB 164</u> sponsored by Senator Polsky legalizes fentanyl test strips in Florida.



For years, Democrats have tried in various ways to expand Medicaid for Floridians. This year was no different - Senator Berman had a bill that was an incremental approach to explore expanding Medicaid to young Floridians.

Unfortunately, the bill did not get heard.

## Justice + Courts

 HB 233, brought by Senator Jones in the Senate, requires law enforcement investigating the murder of a young person to provide family with status updates, contact information and a list of items found with the deceased loved one. Named Curtis's Law in honor of Curtis Williamson, whose homicide death in 1997 was originally thought by police to be an accidental drowning.



- SB 508, sponsored by Senator Rouson, makes changes to problem solving courts, including expanding eligibility requirements to allow admission into a misdemeanor pretrial treatment-based drug court program.
- SB 144, filed by Senator Berman, is a compassionate alternative for working, breastfeeding mothers by requiring, in most cases, that county courthouses provide a lactation space.

### Veterans



• <u>HB 139</u>, sponsored by Senator Torres in the Senate, focuses on helping veterans pursue their dream careers in medicine by **creating the Office of Veteran Licensure Services** in the Department of Health.

# History

- Two bills sponsored in the Senate by Senator Powell focus on the history of African-Americans in Florida.
  - HB 1441 creates a task force to make recommendations for the planning and construction of a Florida Museum of Black History.
  - HB 49 creates the Historic Cemeteries
     Program within the Department of State, it creates an advisory council and it provides funding for research. In recent years, abandoned African-American cemeteries have been rediscovered, prompting a task force that recommended these policies to address the issue.




