PRIDE FLAG

Senators got the chance to hear from Floridians testifying against SB 1120 - a bill that bans flags like Pride flags from being displayed in most public buildings. It also allows veterans to use "reasonable force" to prevent anyone from destroying the U.S. flag.

SB 1492: EMPLOYMENT REGULATIONS

 PROHIBITS LOCAL GOVERNMENTS FROM MANDATING HEAT EXPOSURE REQUIREMENTS FOR EMPLOYERS OR CONTRACTORS

SB 742: PUBLIC WORKS PROJECTS

 BANS LOCAL GOVERNMENTS FROM REQUIRING LIVING WAGES ON PUBLIC PROJECTS IF USING LOCAL FUNDS, WITH EXCEPTIONS

HB 433: EMPLOYMENT REGULATIONS

- BANS LOCAL GOVERNMENT FROM SETTING THEIR OWN MINIMUM WAGE, BENEFITS, TERM AND CONDITIONS, PREEMPTING THESE PROVISIONS TO THE STATE
- ALSO PROHIBITS LOCAL GOVERNMENTS FROM MANDATING HEAT EXPOSURE REQUIREMENTS FOR EMPLOYERS OR CONTRACTORS

SB 1596: CHILD LABOR



HB 49: CHILD LABOR

Uses children as cheap labor at the expense of their education

- LOOSENS CHILD LABOR LAWS EVEN ON A SCHOOL WEEK, REMOVES BREAK REQUIREMENTS FOR 16 AND 17-YEAR-OLDS, LENGTHENS THE HOURS KIDS CAN BE SCHEDULED TO WORK - FROM AS EARLY AS 5:30 AM TO 12:00 AM, AND INCREASES THE NUMBER OF CONSECUTIVE DAYS KIDS CAN WORK
- LOOSENS CHILD LABOR LAWS EVEN ON A SCHOOL WEEK, REMOVES BREAK REQUIREMENTS FOR 16 AND 17-YEAR-OLDS, ALLOWS KIDS TO WORK AS EARLY AS 6 AM INSTEAD OF 6:30 AM, WORK MORE THAN 8 HOURS A DAY, AND WORK MORE THAN 30 HOURS A WEEK

SB 1260: UNEMPLOYMENT BENEFITS



HB 1289: UNEMPLOYMENT BENEFITS

Targets the unemployment system making skills tests mandatory again

- CREATES MORE HURDLES FOR FLORIDIANS TO REMAIN ELIGIBLE FOR UNEMPLOYMENT BENEFITS BY CREATING MORE WAYS TO BE DISQUALIFIED
- CREATES MORE HURDLES FOR FLORIDIANS TO REMAIN ELIGIBLE FOR UNEMPLOYMENT BENEFITS BY CREATING MORE WAYS TO BE DISQUALIFIED

ABORTION

FETAL PERSONHOOD

SB 476 IS DANGEROUS FOR REPRODUCTIVE RIGHTS - IT COULD SPELL OUT FETAL PERSONHOOD, IMPACTING THE FUTURE OF ABORTION RIGHTS IN FLORIDA.

DEMOCRATIC BILLS ON THE MOVE

BILLS SPONSORED BY DEMOCRATS ARE MOVING THROUGH THE PROCESS - HERE'S THIS WEEK'S FEATURED BILL:

DOZIER SCHOOL FOR BOYS & OKEECHOBEE SCHOOL COMPENSATION PROGRAM



FROM THE 1950S TO THE 1960S, MORE THAN 300 BOYS WERE SENT TO A REFORM SCHOOL WEST OF TALLAHASSEE. THE OKEECHOBEE SCHOOL SOON OPENED DUE TO OVERCROWDING AT DOZIER. THESE YOUNG BOYS SUFFERED YEARS OF MENTAL, PHYSICAL, AND SEXUAL ABUSE BY THE HANDS OF THE SCHOOLS OFFICIALS.

SENATOR ROUSON'S BILL (SB

24) WILL ALLOW THE LIVING VICTIMS OF THE DOZIER SCHOOL FOR BOYS AND THE OKEECHOBEE SCHOOL TO APPLY FOR COMPENSATION AS A WAY TO MAKE UP FOR THE ABUSE THEY WENT THROUGH.

VOTE * VOTING RIGHTS RALLY



THE HARRY T. AND HARIETTE V. MOORE VOTING RIGHTS ACT (SB 1522) HONORS TWO OF FLORIDA'S FIRST AFRICAN AMERICAN VOTING RIGHTS ACTIVISTS, ENSURING THE REGISTRATION AND VOTING PROCESS FOR FLORIDIANS BEFORE, DURING AND AFTER THE VOTE IS ACCESSIBLE AND STRAIGHTFORWARD, ESPECIALLY FOR MINORITY FLORIDIANS.

JONATHAN CLARKSON GIBBS

Gibbs was among the most powerful black elected officials in Florida during Reconstruction, serving as Secretary of State and State Superintendent of Public Instruction.



SENATOR BERMAN'S PICK



SIDNEY POITIER

Incomparable Bahamian and American actor from the Golden Age of Hollywood cinema. In 1963, he became the first Black actor to win an Academy Award for Best Actor for his portrayal in Lillies of the Field.



SENATOR THOMPSON'S PICK



BARBARA JORDAN

Lawyer, educator and politician who made history several times - as the first African American elected to the Texas Senate after Reconstruction, the first southern African American woman elected to Congress and one of the first two African Americans elected to the U.S. House from the former Confederacy since 1901.
