BILL UPDATES

We are glad to officially announce our first "Brodeur Blog"! So far this week in Tallahassee, Sen. Brodeur has presented his bills SB 998, and SB 1634. Both passed with unanimous support. From the district office in Lake Mary, we have been continuing to work with constituents to help resolve their unemployment claims.

SB 864: Telehealth

TALLAHASSEE, FL – Senator Brodeur's bill SB 864, relating to Telehealth, is now in the Appropriations Subcommittee on Health and Human Services. The bill passed unanimously out of the Health Policy Committee with ten "Yeas" and zero "Nays" on March 17th. We're incredibly proud of the momentum this bill is gaining! The bill expands the definition of telehealth in Florida to include audio-only consultations with a healthcare provider, allowing those without the level of equipment and connectivity required for video streaming to use this exciting new service under Florida law.

SB 852: Medicaid Modernization

TALLAHASSEE, FL – Senate bill 852 by Senator Brodeur has also passed out of the Health Policy committee with unanimous support! This bill would authorize the Agency for Health Care Administration to reimburse for telehealth services using a "store-and-forward" technology and remote patient monitoring services under the Florida Medicaid program. This means physicians could more easily use data collected from wearable devices in the diagnosis and treatment of diseases.
