Daylight Savings Time

Today marks the end of Daylight Savings Time, please remember to update your clocks to "Fall Back" one hour.

In 2018, the Florida Legislature overwhelmingly passed the Sunshine Protection Act. The Act supported adopting daylight saving time as the year-round standard time of the entire state. However, in order for this act to take effect, the United States Congress must pass legislation to allow Florida to remain on Daylight Savings Time year-round. US Senators Marco Rubio and Rick Scott have filed legislation to skip the change to standard time across the country. However, the bill has yet to be voted on by the US House of Representatives or the US Senate.

FL Dept of Health to Conduct Review of COVID Fatalities

Florida's Surgeon General, Dr. Scott A. Rivkees, recently announced the Department of Health will be conducting a more thorough review of all COVID-19 fatalities reported to the state.

Fatality data reported to the state has consistently created confusion and warrants a more rigorous review. Of the 95 fatalities reported to the state on October 21st, 16 had more than a two-month separation between the time the individuals tested positive and passed away, and 11 of the deaths occurred more than a month prior to being reported.

"During a pandemic, the public must be able to rely on accurate public health data to make informed decisions," said Florida Surgeon General Scott Rivkees. "To ensure the accuracy of COVID-19

related deaths, the Department will be performing additional reviews of all deaths. Timely and accurate data remains a top priority of the Department of Health."

Of the 95 fatalities reported to the Florida Department of Health on October 21, 2020: 11 were over 30 days old; 16 had at least two months between the time the individuals tested positive and passed away; and 5 had at least three months between the time the individuals tested positive and passed away.

FL Dept of Health Opens Free Adult Flu Clinics in Brevard

The Florida Department of Health in Brevard County (DOH-Brevard) is strongly encouraging all unvaccinated residents to get their flu shot as soon as possible. Flu vaccination is the best way to prevent the flu and its potentially serious complications. To better serve Brevard County residents, DOH-Brevard is offering free adult flu clinics during the month of November.

The DOH-Brevard continues to offer free flu vaccines for children ages 6 months through 18 years of age, Monday – Friday from 8:00AM to 4:00PM on a walk-in basis at each of our clinic locations in Melbourne, Viera, and Titusville as well.

Getting the flu shot each year is important but reducing illness and hospitalization from flu is even more critical this year to protect frontline health care workers and hospital systems who will continue to care for people with COVID-19 and other illnesses. Also, having the flu and COVID-19 at the same time could lead to a negative outcome.

The flu and COVID-19 are respiratory illnesses, but until there is a steady vaccine supply against COVID-19, the way to help prevent these two viruses from circulating at the same time is to get your flu vaccine now.
