| 15 | | | | Senate New | <p>Amends section 373.1501, F.S. adding the process for acquiring land for water storage.</p> <p>(4) The Legislature declares that acquiring land for water storage north of Lake Okeechobee is in the public interest, for a public purpose, and necessary for the public health and welfare. The governing board of the district is authorized to acquire land, if necessary, to implement a reservoir project north of Lake Okeechobee with the goal of providing at least 200,000 acre-feet of water storage. Any acquisition of real property for the purpose of a reservoir project constitutes a public purpose for which it is in the public interest to expend public funds. Any land necessary for implementing the projects in this subsection may only be acquired in accordance with s. 373.139(2), and chapters 73 and 74. The district and the state are not authorized to request the United States Army Corps of Engineers to acquire the lands for such reservoir project, and may not include any provision for such request in the project partnership agreement for such reservoir project.</p> | |
